Dear Ms. Estabrook:

The staff of the Maine Commission on Governmental Ethics and Election Practices ("the Commission") has completed its review of your request for certification as a Maine Clean Election Act (MCEA) candidate. We determined you submitted 52 valid qualifying contributions (QCs), which is less than the 60 QCs required to receive MCEA funding. You have an opportunity to appeal this staff determination to the members of the Commission, as discussed in Section III.

I. Legal Requirements for MCEA Funding

Duty to Collect 60 QCs

Candidates for the Maine House of Representatives must obtain QCs during the qualifying period from at least 60 verified registered voters from the candidate's House district. 21-A M.R.S. § 1125(3)(D)(3). A QC is defined as a donation:

A. Of \$5 or more in the form of cash, a check or a money order payable to the fund and signed by the contributor in support of a candidate or made over the Internet in support of a candidate according to the procedure established by the commission;B. Made by a registered voter within the electoral division for the office a candidate is seeking and whose voter registration has been verified according to procedures established by the commission;

C. Made during the designated qualifying period; and

D. That the contributor acknowledges was made with the contributor's personal funds and in support of the candidate and was not given in exchange for anything of value

> and that the candidate acknowledges was obtained with the candidate's knowledge and approval and that nothing of value was given in exchange for the contribution, on forms provided by the commission.

21-A M.R.S. §§ 1122(7)(A)-(D).

Required Documentation

In order for a QC made by check, cash, or money order to be valid, the contributor must sign a Receipt & Acknowledgement form to affirm they made the contribution with personal funds. 21-A M.R.S. §§ 1122(7)(D) & 1125(3-B). For QCs given by cash, the MCEA requires contributors to "sign a form prepared by the commission affirming that the contributor made the contribution with personal funds." 21-A M.R.S § 1125(3)(F).

Proof of Contributors' Voter Registration

Under the Commission's rules, a candidate's request for MCEA funding must include proof of the contributors' voter registration. 94-270 C.M.R. ch. 3, § 3(1)(A). The proof of registration must be received by the Commission within the qualifying period. The candidate must verify that each contributor is registered to vote in the candidate's legislative district through the Commission's online QC service or through written verification from the clerk in the contributor's municipality. 94-270 C.M.R. ch. 3, § 2(4)(F).

Deadline to Submit QCs, Voter Registration Verifications, and Receipt & Acknowledgement Forms by 5:00 p.m. on April 20, 2022

The candidate "must submit qualifying contributions, receipt and acknowledgement forms, proof of verification of voter registration ... during the qualifying period according to procedures developed by the commission" 21-A M.R.S. § 1125(4). For candidates for the State House of Representatives, the qualifying period ends at 5:00 p.m. on April 20th of the election year. 21-A M.R.S § 1122(8)(B). Under the Commission Rules, the Commission and its staff may not grant extensions for a candidate to submit the QCs and verifications of voter registration. 94-270 C.M.R. ch. 3, § 3(1)(F). II. Determination by Commission Staff

When your MCEA qualifying materials were submitted to the Commission on Wednesday, April 20, the Commission's online QC service indicated you were submitting 76 QCs. The Commission staff has determined 24 of the QCs from this submission were invalid, and that you submitted 52 valid QCs.

Duplicate QCs for Three Contributors

The materials submitted on April 20 include duplicate QCs for three contributors. The Commission staff is counting only one QC for each of these contributors.

- Joseph McConnell signed two different Receipt and Acknowledgment Forms, on March 10 and April 11. The March 10 QC is invalid.
- Amy Ward signed two different Receipt and Acknowledgment Forms, on March 10 and April 11. The March 10 QC is invalid.
- William C Crandall signed a Receipt and Acknowledgment Form on March 10 and gave a QC on the Commission's online QC service on March 16. The March 10 QC is invalid.

Ten Missing Cash Qualifying Contribution Affirmation Forms

If a contributor makes a QC in cash, the contributor is required to sign a Cash Qualifying Contribution Affirmation form ("Cash QC form"), as required by 21-A M.R.S. § 1125(3)(F), that all QC contributors who donate via cash must sign. Your April 20 submission of qualifying materials was missing ten Cash QC forms. Those ten QCs are not valid.

Eleven Unverified Contributors

There were fourteen contributors for whom the Commission's online QC service was unable to verify the voter registration status. You did not submit additional confirmation from the municipal registrar that any of these voters were registered voters in your district and their QCs are invalid:

Because 24 of your QCs do not meet the legal requirements to be counted toward certification, the Commission staff has determined that your campaign submitted 52 valid QCs.

III. Your Right to Appeal

You have a right to appeal the staff determination to the members of the Commission, pursuant to 21-A M.R.S. § 1125(14). If you wish to do so, please submit the appeal, in writing, *within seven days*, addressed to:

You may file the appeal through U.S. Mail or other delivery service, by hand, or by email addressed to <u>Jonathan.Wayne@maine.gov</u>. The Commission is required to hold a hearing to consider the appeal within five calendar days of receiving the appeal. The hearing would be held in accordance with the State Administrative Procedure Act (5 M.R.S. §§ 8001-11008). You would have the burden of proving that the Commission

Estabrook Hearing Statement

As discussed with Mr Wayne last week, I would like to make some points with regards to what I believe to be a lack of communication and a flaw within the qualification process.

As a first time candidate I would like to start with discussing my frustrations with a lack of information/ training/ overview of the Clean Election Act and the process of becoming certified. If it wasn't for a now Representative I wouldn't have a copy of the rule book. I understand and accept that we are in the day of the internet. What Id like to make the Commission aware of is that entire State of Maine doesn't have access to internet. Currently the Town of Chesterville where I live internet is not available to the entire Town. Meaning not that people can't afford it. Consolidated communications doesn't service the entire Town with service. The service that most have in Chesterville is spotty as best.I can provide more technical information, if needed. I can only assume that the Commission recognizes email as less than perfect method of communication seeing as I was mailed a hard copy of the Commissions findings (postmarked May 2nd).

My assumption is based on the fact that I don't believe our government would unnecessarily make more work for itself and it's employees nor use tax payers dollars for postage without good reason.

I collected 76 \$5 contributions. Out of those 76 I recognize that 8 where going to be disqualified based on not having the proper cash "second slip" filled out. My volunteers and myself didn't realize this was necessary until I myself gave \$5 cash to a senate candidate and was asked to fill out the "second cash slip". I take full responsibility for those 8 being disqualified.

The issue more pressing in my opinion is the number of contributions disqualified by being entered into the online system as requested and the system having no recognition or acknowledgment that these are indeed registered voters. One example that stands out is voter Stephan Bunker, previous candidate for the House from Farmington, endorsed and funded by this commission. I can list the names individually if needed, for the purpose of this letter know that out of 12 that were considered disqualified 2 should have been disqualified as they recently moved to Farmington and haven't registered in the Town yet. An algorithm change is needed, so that when a person fills out the contribution sheet and puts Steve, the commission in my opinion should recognize Stephan or Stephen or Steve as acceptable names of registered voter living at that address. example : Stephan Bunker 404 Bailey Hill Rd Farmington Maine 04938

I am to understand that names not verified online and have verified by Town Clerks. As of the writing of this letter 5:46pm Sunday, May 8th 2022, (please see attached) the status of all 76 contributions is stated online as pending. How is a candidate to know which voters needs verification from Town Clerk if when the website is checked the status is still pending. When reading the instructions I read that any unverified contributions needed to be verified with the Town Clerk. In my case, none listed as valid or invalid all are pending.

The online voter entry needs to be dissolved and have candidates take collected signatures papers to Town Clerk for verification as is required of candidates when collecting signatures to be on the ballot. I believe creating this consistency in protocol would be a Benefit to all.

The other suggestion would be to continue to have candidates enter online, yet have someone within your commission verify and update website regularly.

NOTICE OF HEARING

Hearing Scheduled for May 11, 2022

On April 29, 2022, the staff of the Maine Ethics Commission completed its review of a request for Maine Clean Election Act funding by Ms. Tiffany Estabrook, a candidate for the Maine House of Representative, District 75. The Commission staff found that Ms. Estabrook did not submit 60 valid qualifying contributions during the qualifying period. Specifically, the Commission found a total of 11 qualifying contributions were invalid because the candidate did not submit confirmation that the contributors are registered to vote in the candidate's house district, three contributors made two contributions; and the submission did not include ten Cash Qualifying Contribution (QC) Affirmation forms. For these reasons, the Commission staff determined Ms. Estabrook did not meet the requirements to receive Maine Clean Election Act funding under 21-A M.R.S. § 1125(5).

Ms. Estabrook has appealed the staff determination. Pursuant to 21-A M.R.S. § 1125(14), the Commission will hold a hearing on her appeal, with the agreement of the appellant, on **Wednesday, May 11, 2022 at 10:00 a.m.** The hearing will be held at the Commission office at **45 Memorial Circle, in Augusta.** The hearing will be streamed to YouTube for the public to access.

The May 11, 2022 hearing will be conducted in accordance with Chapter 2 of the Commission's rules (available at www.maine.gov/ethics) and the Maine Administrative Procedure Act, 5 M.R.S. §§ 8001 et seq.

Issue to be Addressed at the Hearing

At the hearing, Ms. Estabrook will have the burden of proving that the determination by the Commission staff was in error as a matter of law or was based on factual error. The members of the Commission are expected to reach a decision in the matter as part of the hearing.

Opportunity to Present Evidence and Legal Argument

The appellant, the Commission staff, and any intervenors may present evidence and legal argument at the May 11, 2022 hearing.

Subpoenas

Any requests to the Commission for issuance of subpoenas under 5 M.R.S. § 9060 should be made as soon as possible. Requests should be addressed to the William Schneider, Commission Chair, and emailed to Jonathan.Wayne@maine.gov.
