Re: Maine Republican Party – Waiver Requests

During the last 13 days before an election, registered state party committees must file special campaign finance reports (within 24 hours) of large transactions that would not otherwise be publicly disclosed until after the election. The Maine Republican Party is seeking waivers for two late 24-Hour Reports. On June 3, 2024, the Maine Republican Party received a \$7,808 contribution and was required to file a 24-Hour Report by June 4 but did not do so until July 22. On June 4 the state party received a \$38,839.80 contribution and was required to file a 24-Hour Report by June 5 but did not do so until June 10.

# LEGAL REQUIREMENTS

<u>24-Hour Reports</u>. During the 13 days before an election state party committees are required to report any single contribution of \$5,000 or more received or single expenditure of \$1,000 or more made within 24 hours. 21-A M.R.S. § 1017-A (4-A) (E). If the party is late in filing the 24-hour report, the statutory amount of the preliminary penalty is determined by the amount of the transaction, the number of prior violations within a two-year period, and the number of days late. 21-A M.R.S. § 1020-A (4-A). The Commission may grant a full or partial waiver if it determines that the report was late due to mitigating circumstances defined in statute or is disproportionately high relative to certain factors. 21-A M.R.S. § 1020-A (2).

### DISCUSSION AND STAFF RECOMMENDATION

The statutory formula for calculating late-filing penalties for the late 24-Hour Reports are outlined below:

State Party Treasurer, Tiffany Gilda-Gaspar, seeks a waiver on behalf of the party because she is an inexperienced treasurer who started the position in March 2024. While her time as treasurer is limited, the Maine Republican Party is an experienced political committee that has extensive experience in filing campaign finance reports with the Commission and should already have measures in place to ensure timely compliance. This party committee moves millions of dollars every election cycle and should be held to a higher standard than a newly formed political action committee with novice filers.

As treasurer, she has received correspondence from Commission staff including a May 28, 2024, email sent to all PACs and state party committees outlining the 24-hour and independent expenditure reporting obligations for the June 2024 primary election.

Commission staff do not think the Maine Republican Party had any intent to deceive the public and believe this error was likely an administrative oversight; however, even oversight errors may result in penalties. Violations of the 24-hour reporting requirements can be serious matters, as these reports play an important role in informing the electorate about how money is changing hands in the critical days just before an election. The law does not differentiate between what reporting errors constitute a mitigating circumstance, and instead leaves those decisions to the Commissioners.

It is rare that one of the two major state parties' files a campaign finance report late. The last time a state party committee requested a waiver for late 24-Hour Reports was in 2015 when the Maine Republican Party had five late reports. At that time, the Commission reduced the preliminary penalties from \$37,400 to \$5,000. Given the circumstances outlined in this memo, Commission staff recommend that this penalty be reduced to \$1,500 per report, for a total penalty of \$3,000.

The June Primary is right around the corner and that means that you have two additional reporting responsibilities with the Maine Ethics Commission.

#### From tomorrow May 29 through June 10 please keep in mind the following reporting requirements:

24 Hour Reporting Period:

- ANY contribution or loan of \$5,000 or more
- ANY expenditure or debt of \$1,000 or more
- MUST be reported with in 24 hours of the transaction occurring

#### <u>1-Day Independent Expenditure Reporting Period:</u>

- ANY single expenditure of more than \$250 per candidate
- MUST be reported on an Independent Expenditure Report within ONE DAY of the expenditure occurring.

To file these reports you must:

- (1) add the triggering transactions into the eFiling system; then the system will
- (2) generate the report; that you
- (3) need to file.

Remember, you must add the transaction **and** file the report for your filing responsibilities to be met.

Bonus – independent expenditures no longer require a signed affidavit to be submitted to the Commission due to a 2023 change in the law.

## Memo to Commissioners re: Maine Republican Party Committee Waiver Request – Text of Legal Authority Cited in Memo in order Referenced

### 21-A M.R.S. § 1017-A (4-A) (E)

Chapter 13: <u>Campaign Finance Reports</u>

§ 1017-A. <u>Reports of contributions and expenditures by party committees</u> 4-A. <u>Filing schedule</u>. A state party committee shall file its reports according to the following schedule. All reports required under paragraphs A, B and C must be filed by 11:59 p.m. on the day of the filing deadline.

E. If a state party committee is required to file a report 11 days before an election pursuant to paragraph B or C, the committee shall report any single contribution of \$5,000 or more received or any single expenditure of \$1,000 or more made after the 14th day before the election and more than 24 hours before 5:00 p.m. on the day of the election within 24 hours of that contribution or expenditure. The committee is not required to include in this report expenditures for overhead expenses or compensation paid to an employee or other member of the campaign staff who has received payments at regular intervals that have been disclosed in previously filed campaign finance reports. As used in this paragraph, "overhead expenses" includes, but is not limited to, rent, utility payments, taxes, insurance premiums or similar administrative expenses.

### 21-A M.R.S. § 1020-A (4-A)

Chapter 13: Campaign Finance Reports

§ 1020-A. Failure to file on time

4-A. <u>Basis for penalties</u>. The penalty for late filing of a report required under this subchapter is a percentage of the total contributions or expenditures for the filing period, whichever is greater, multiplied by the number of calendar days late, as follows:

- A. For the first violation, 2%;
- B. For the 2nd violation, 4%; and
- C. For the 3rd and subsequent violations, 6%.

Any penalty of less than \$25 is waived.

Violations accumulate on reports with filing deadlines in a 2-year period that begins on January 1st of each even-numbered year. Waiver of a penalty does not nullify the finding of a violation.

A report required to be filed under this subchapter that is sent by certified or registered United States mail and postmarked at least 2 days before the deadline is not subject to penalty.

#### 21-A M.R.S. § 1020-A (2)

Chapter 13: <u>Campaign Finance Reports</u> § 1020-A. <u>Failure to file on time</u> 2. <u>Campaign finance reports</u>. A campaign finance report is not timely filed unless a properly signed or electronically submitted copy of the report, substantially conforming to the disclosure requirements of this subchapter, is received by the commission by 11:59 p.m. on the date it is due. Except as provided in subsection 7, the commission shall determine whether a report satisfies the requirements for timely filing. The commission may waive a penalty in whole or in part if the commission determines that the penalty is disproportionate to the size of the candidate's campaign, the level of experience of the candidate, treasurer or campaign staff or the harm suffered by the public from the late disclosure. The commission may waive the penalty in whole or in part if the commission determines the failure to file a timely report was due to mitigating circumstances. For purposes of this section, "mitigating circumstances" means:

A. A valid emergency determined by the commission, in the interest of the sound administration of justice, to warrant the waiver of the penalty in whole or in part; B. An error by the commission staff;

C. Failure to receive notice of the filing deadline; or

D. Other circumstances determined by the commission that warrant mitigation of the penalty, based upon relevant evidence presented that a bona fide effort was made to file the report in accordance with the statutory requirements, including, but not limited to, unexplained delays in postal service or interruptions in Internet service.
