Additional Memorandum on the House Democratic Campaign Committee's Balance

Discrepancy

On Friday July 14<sup>th</sup>, Sean Smith provided additional information regarding the House Democratic

Campaign Committee's (HDCC) balance discrepancy. In an email, he stated himself, HDCC

treasurer Steve Von Vogt, and finance and marketing director Amy Bouchard had undertaken a

review of the PAC's finances and had found a reason for most of the discrepancy. The PAC's 2016

42-Day Post-Primary Report included 17 contributions previously reported on the 2016 11-Day

Pre-Primary Report, thus duplicating \$54,712 in donations.

Although a large amount of reporting inaccuracies have been resolved, HDCC's discrepancy is

now approximately \$14,000, which Mr. Smith refers to as "relatively small and not unexpected"

considering the millions of dollars of HDCC has raised and spent.

**Staff Recommendations** 

The Commission staff appreciate the work of the committee in solving its balance issue and

recommend a balance adjustment be approved for the remaining discrepancy of approximately

\$14,000. The Commission staff will assist HDCC in filing amendments to remove the duplicated

contributions in 2016. However, the Commission staff would like to express the following

concerns:

The lack of awareness to such a substantially inaccurate cash balance when filing the 2016

42-Day Post-Primary Report;

The quick response of Mr. Von Vogt to Ms. Burke, communicating HDCC's balance was

accurate when it was more than \$60,000 off; and

HDCC's balance inaccuracy as identified was due to their own misreporting, and not the

eFiling system that they initially identified as the culprit.

After hearing remarks from the HDCC at the July 24<sup>th</sup> meeting, the Commission may wish to consider whether the 2016 42-Day Post-Primary Report was substantially nonconforming, and therefore late, considering all but around \$2,000 in contributions were misreported, and the ending cash balance was off by more than 50%. If so, Commission staff suggests considering this issue at the Commission's August 23<sup>rd</sup> meeting. Based on presently available information, it appears the preliminary penalty would the statutory maximum of \$54,712. 21-A M.R.S § 1062-A(4).

Dear Jonathan, Martha and Emma,

We are writing to you re: the House Democratic Campaign Committee's balance discrepancy.

I'm copying our treasurer, Steve Von Vogt, and our director of finance and marketing, Amy Bouchard. Both Steve and Amy have access to our bank accounts, all of our records, and have been involved in the internal audit that we have been conducting over the last several weeks. Amy was not involved in Ethics filings prior to 2023, so having fresh eyes on all of our work was particularly helpful.

In order to investigate this discrepancy, we developed a process and conducted an internal audit of our bank records and Ethics finance reports going back to 2016. We looked closely for any errors we could find between our bank account and the finance reports. Because the Ethics website is reporting that the HDCC has more money than is actually in the bank account, we especially looked for under-reported expenditures and over-reported revenue.

Taking Jonathan's advice, we began looking at our records beginning in July of 2018, around the time the most recent Ethics software and reporting platform took effect. But we immediately noticed that the discrepancy between our bank account and the finance reports already existed in July of 2018 and was very close to the discrepancy that is now being reported. So, although it was clear to us that the discrepancy occurred sometime prior to July 2018 and involved one of the old reporting systems, we decided to continue with our audit process and look at all of our records from 2018 through the end of 2022. Unsurprisingly, we did not find anything significant.

So we started looking at our records prior to July 2018, and immediately found a major discrepancy on the 2016 42-Day Post Primary report for the period of June 1, 2016 through July 19, 2016. We have no idea how this happened, but nearly all contributions reported on that report (17 out of 19) were already reported on the two previous reports (the April Quarterly report for the period of January 1, 2016 to March 31, 2016 and the 11-Day Pre-Primary Report for the period of April 1, 2016 to May 31, 2016). In total, the duplicate contributions amounted to \$54,712.00, providing an explanation for the vast majority (nearly 80%) of the current discrepancy.

Just to restate, these 17 contributions were reported accurately on either the 2016 April Quarterly report or the 2016 11-Day Pre-Primary report, and then accidentally re-reported on the 2016 42-Day Post-Primary report.

Here is a list of those duplicate contributions (please see attached spreadsheet for more details):

Again, we have no idea how this happened – this error occurred seven years ago. Our internal records match the bank records exactly. Somehow, these 17 contributions just made it on to an extra report. If the new system allows us to go back and amend the 2016 reports, we are happy to do that. We will gladly take your advice on how to handle that.

We are sorry that we did not report this balance discrepancy sooner. We should have, and we apologize for not doing that. It was something we should have paid more attention to during the hustle and bustle of the campaign, and it was just something that we fell short on. Honestly, our PAC balance has been off for a very long time and we admitted that to many different Ethics staff over the years going back to Paul Lavin and even back to Ben Dyer seven to eight years ago. It was kind of a running joke that between all the new reporting systems that there could easily be errors that were not our fault, and that many of the PAC balances across the state were off during all of those years. We have always been incredibly diligent about reporting exactly what comes in and out of our bank account, and we used the bank record as the ultimate north star.

Due to the increased attention recently on cash on hand totals and matching bank balances, we have tweaked our internal process of how we file reports and we will make sure that our reports (and subsequently reported COH) exactly match our bank account going forward, and will self-report any discovered discrepancies.


Also, we think it is very important to note that we are left with a relatively small and not unexpected discrepancy considering the volume and amount of transactions that we have had since we last reset our balance with Ethics. The last time we reset our balance was in 2013 with the implementation of that year's new reporting system. Since that time through 2022, we have had \$11.4M of transactions (half reported as revenue and half reported as expenditures). The remaining \$14,121.13 discrepancy over those 10 years is .12% of the \$11.4M that we have entered by hand into three different Ethics reporting systems over 10 years. That is 1/10 of one percent. To put that in context, if a PAC with \$1M dollars of transactions was granted a \$1,000 adjustment, the \$1,000 discrepancy out of \$1M of transactions would equal the same incredibly small 1/10 of one percent. Our reporting over the years has been very, very accurate and attentive.

Thanks for your advice on helping us handle this situation. We are glad we found the discrepancy on the 2016 report, but it took a lot of effort. After a grueling few weeks of working on this, we are going back to doing our normal day jobs and working on the campaign!
