Dear Ms. Kidder:

The staff of the Maine Commission on Governmental Ethics and Election Practices ("the Commission") has completed its review of your request for Maine Clean Election Act (MCEA) funding as a candidate for State Representative. We determined you submitted 64 valid qualifying contributions (QCs). Nevertheless, because you did not submit the Request for Certification form, which is required under the Commission's procedures and rules, we cannot certify that you meet the legal requirements to qualify for MCEA funding. You may appeal this staff determination to the members of the Commission who would hold a hearing to consider your appeal, as discussed in Section III.

I. Legal Requirements for MCEA Funding

Duty to Collect 60 QCs

Candidates for the Maine House of Representatives must obtain QCs during the qualifying period from at least 60 verified registered voters from the candidate's House district. 21-A M.R.S. § 1125(3)(D)(3). A QC is defined as a donation:

A. Of \$5 or more in the form of cash, a check or a money order payable to the fund and signed by the contributor in support of a candidate or made over the Internet in support of a candidate according to the procedure established by the commission;

- B. Made by a registered voter within the electoral division for the office a candidate is seeking and whose voter registration has been verified according to procedures established by the commission;
- C. Made during the designated qualifying period; and
- D. That the contributor acknowledges was made with the contributor's personal funds and in support of the candidate and was not given in exchange for anything of value and that the candidate acknowledges was obtained with the candidate's knowledge and approval and that nothing of value was given in exchange for the contribution, on forms provided by the commission.

21-A M.R.S. §§ 1122(7)(A)-(D).

Required Documentation of QCs

In order for a QC made by check, cash, or money order to be valid, the contributor must sign a Receipt & Acknowledgement form to affirm they made the contribution with personal funds. 21-A M.R.S. §§ 1122(7)(D) & 1125(3-B). For QCs given by cash, the MCEA requires contributors to "sign a form prepared by the commission affirming that the contributor made the contribution with personal funds." 21-A M.R.S § 1125(3)(F).

Deadline to Submit QCs, Voter Registration Verifications, and Receipt & Acknowledgement Forms by 5:00 p.m. on April 20, 2022

The MCEA directs candidates to submit the required qualifying materials to the Commission during the qualifying period:

A participating candidate must submit qualifying contributions, receipt and acknowledgement forms, proof of verification of voter registration and a seed money report to the commission during the qualifying period according to procedures developed by the commission"

21-A M.R.S. § 1125(4) (italics added). For candidates for the State House of Representatives, the qualifying period ends at 5:00 p.m. on April 20th of the election year. 21-A M.R.S § 1122(8)(B). Under the Commission Rules, the Commission and its staff

may not grant extensions for a candidate to submit the QCs and verifications of voter registration. 94-270 C.M.R. ch. 3, § 3(1)(F).

Due to the COVID pandemic, during 2022 the Commission authorized candidates to submit qualifying materials by mail provided they were postmarked by the deadline of April 20, 2022. On April 1, 2022, Candidate Registrar Erin Gordon sent to all MCEA candidates instructions on how to submit the materials by mail and a checklist of materials to include.

Request for Certification Form

The Commission's rules contain a provision setting out the procedures for how a candidate requests MCEA funding. 94-270 C.M.R. ch. 3, § 3(1). Paragraphs 1(A) through 1(E) list the required qualifying materials that candidates must submit.

Paragraph 1(E) states that the application must include the Request for Certification form:

The request will be deemed complete and considered for certification only when the candidate has submitted to the Commission: ...

E. a signed request for certification on a form provided by the Commission which contains an affirmation by the candidate that he or she has complied with all seed money and qualifying contribution requirements, has established a separate federally-insured bank account for campaign purposes and, if applicable, that any person who circulated receipt and acknowledgement forms and collected qualifying contributions acted with the candidate's knowledge and consent, and any other information relevant to the certification process.

94-270 C.M.R. ch. 3, § 3(1)(E). The rule specifically states that "[t]he Commission and the Commission staff may not grant an extension of time" to submit the request for certification form. 94-270 C.M.R. ch. 3, § 3(1)(F).

II. Determination by Commission Staff

You mailed your MCEA qualifying materials to us on the deadline of April 20, 2022. We received and date-stamped them Friday, April 22, and began reviewing them for compliance on Monday, April 25. You submitted 65 QCs. Candidate Registrar Emma Burke determined that 64 of the QCs met the legal requirements for certification as an MCEA candidate. One QC was found to be invalid, because no Cash Qualifying Contribution Affirmation form was submitted for the contribution from Theresa Parsons.

The Commission staff is unable to view your application as complete, however, because it did not contain a signed Request for Certification form that is required by 94-270 C.M.R. ch. 3, § 3(1)(E). The rule, which is binding on the Commission staff, explicitly states that the application "will be deemed complete ... only when the candidate has submitted" the Request for Certification form. The rule also directs the Commission not to grant extensions to submit the Request for Certification form.

The Request for Certification form serves a few different functions in the Commission's procedures for MCEA candidates. The form:

- lists the qualifying materials that a candidate needs to submit,
- contains affirmations by the candidate that they have complied with program procedures that promote the integrity of the program, and
- facilitates a request by the candidate for additional time to file a seed money report, as allowed by the Commission's rules.

In this year's elections, the Commission staff has attempted to educate candidates to file the Request for Certification form through different methods. Page 14 of the 2022 MCEA Candidate Guidebook instructs candidates to submit the form no later than 5:00 pm on April 20, 2022. (attached) On April 1, 2022, Candidate Registrar Erin Gordon emailed the request to certification from and a checklist of materials as a single PDF to all candidates seeking MCEA funding, along with mailing instructions. (attached) The

form was posted on the Forms and Guides page for MCEA candidates on the Commission's website. Leading up to the certification deadline, the staff set out the form in a prominent place in our lobby.

Because Chapter 3, section 3(1) of the Commission's rules requires candidates to submit the Request for Certification form as part of their application for MCEA funding and you did not submit the form, the Commission staff is denying your request for MCEA funding.

III. Your Right to Appeal

You have a right to appeal the staff determination to the members of the Commission, pursuant to 21-A M.R.S. § 1125(14). If you wish to do so, please submit the appeal, in writing, *within seven days*, addressed to:

You may file the appeal through U.S. Mail or other delivery service, by hand, or by email addressed to Jonathan. Wayne@maine.gov. The Commission is required to hold a hearing to consider the appeal within five calendar days of receiving the appeal. The hearing would be held in accordance with the State Administrative Procedure Act (5 M.R.S. §§ 8001-11008). You would have the burden of proving that the Commission staff's decision was in error as a matter of law or was based on factual error. The

CHAPTER 4

Requesting MCEA Certification & Initial Payment of Public Campaign Funds

REQUESTING CERTIFICATION AS AN MCEA CANDIDATE

Certification Request & Deadline. After a candidate has collected the required number of valid QCs, the next step is to request certification by submitting the QCs along with the R&A Forms and the other required documents (see chart on the next page) to the Commission. The Commission staff carefully reviews all requests and determines if all requirements have been met. A request for certification must be submitted to the Commission no later than 5:00 p.m. on April 20, 2022.

To qualify for MCEA funding, the treasurer must file a Seed Money Report, and the campaign must submit the list of QC contributors and a Request for Certification Form. The Commission's Rules permit Commission staff to grant a one week extension for submitting the Seed Money Report; the extension request is at the bottom of the Request for Certification Form. The Commission has no authority to grant an extension to submit R&A Forms and QCs. Late submissions will not be accepted for review.

Submit Checks/Money Orders & R&A Forms. No later than 5:00 p.m. on April 20, 2022, a candidate must submit at least the minimum number of valid QCs, the original R&A Forms, and system-generated R&A Forms signed by municipal clerks. Checks, Cash QC Affirmation slips, and both bulk and individual money orders must be paper-clipped to their corresponding R&A Forms. Commission staff recommends submitting at least 10% more than the required number of QCs in the event some are invalid.

Submit List of Contributors. A candidate must submit to the Commission, via the Commission's online QC service, a list of individuals who gave QCs to the campaign. The list must include all of the QC contributors the candidate wishes to submit for certification. Lists must be submitted by using the online QC service. The service uses the information on the R&A Form (name, address, and municipality) to determine voter registration status, and adds all valid QCs to a master submission list with any online QCs received in that period of time. The generated list can be downloaded and printed, but Commission staff will also be able to access the list through their own administrative portal. The list must be submitted to the Commission via the online QC service by 5:00 p.m. on April 20th for the QCs to be counted as valid.

File Seed Money Report. The Seed Money Report discloses all seed money contributions received and expenditures made by a campaign. Candidates and treasurers should carefully review seed money

Request for Certification Form. This form is a candidate's signed agreement to comply with the requirements of the MCEA and the Commission's Rules. It is also a checklist for the materials they must submit for certification. A candidate may also use this form to request an extension of time to file the Seed Money Report.

Notice to Unenrolled Candidates:

MCEA participants must be qualified for the ballot in order to be certified and receive funding. Unenrolled candidates are required to file ballot petitions and be qualified with the Secretary of State's office no later than April 27, 2022 if they wish to participate in the MCEA program.

When you are ready to submit your qualifying contribution (QC) packets this year you may hand-deliver it to the Ethics office or mail it. If you choose to mail your QC packet, please follow the instructions in this memo exactly to make sure your QC package is sent on time and in the proper format:

- All packages must be postmarked by April 20, 2022 for them to be considered as submitted on time, regardless of when the package arrives.
- You can mail your QC packages using the United States Postal Service or FedEx.
 We recommend using one of the following shipping options: USPS Priority Mail
 Flat Rate Envelope or USPS Priority Mail Medium Flat Rate Box. Please be sure
 to request tracking for your package, retain the tracking number, and email your
 Candidate Registrar your tracking number before 5:00 p.m. on April 20, 2022.
- Address your package to the following address:

 You may pay for the cost of shipping and tracking the package with seed money or with personal funds. Using personal funds does not constitute an in-kind contribution to your campaign.

Dear Mr. Lee:

I am writing you to appeal the staff's determination of my request for MCEA funding as a candidate for State Representative to the members of the Commission. Please know that I truly thought I had done everything required to be eligible for Maine Clean Elections Act Funding. I was surprised and very upset with myself that I had made an error that disqualified me after all my hard work. I thought my Declaration of Intent was the Request for Certification, so I didn't even realize I was missing anything.

When I received the April 1st E-Mail, I read it over quickly and then I forwarded it to my volunteer campaign manager. She has worked on referendum campaigns, but mine is her first with a candidate and MCEA funding. She is a single working mom while attending college to get her degree and her finals week coincided with the time leading up to the filing deadline. We decided that she needed time off from working on my campaign because her finals counted as a third of her grade. I felt her education was more important and I believed I knew what I was doing.

When I realized I was going to need the 1 week extension to file my Seed Money Report and couldn't remember how to request one, I sent an E-Mail to the staff. Because it was the morning of the 20th, they put it through for me instead of telling me to initial the box on the Request for Certification form. I was grateful for the extension and that I could get back to getting the packet ready to mail.

I baby sit my 18-month-old grandson on Tuesdays and Wednesdays while my daughter works so I was unable to bring my packet to Augusta where the missing form would have been discovered and I would have completed it immediately.

I had major health issues early this year that put me 2 months behind and I worked hard to do all the requirements to get my name on the ballot. I have signed and filed my Declaration of

Intent to participate in the MCEA and qualified as a candidate by petition. I have complied with seed money restrictions and otherwise met the requirements for participation in the MCEA. I read the Commission's guidelines on permissible campaign expenditures. I have established a separate checking account at Northeast Credit Union for my campaign and have submitted my Vendor and EFT/Direct Deposit forms.

When my plan to get my QCs wasn't working and I only had 28 the week before the deadline, I changed my strategy and I knocked on as many doors as I could as fast as I could, and I managed to submit 64 QCs with the appropriate MCEA Cash QC Affirmation Forms and Receipt & Acknowledgement Forms before the deadline. I verified them all online and submitted the printout of the list online. I did everything I was supposed to do to participate in MCEA funding that I could remember that I needed to do before the deadline. I just didn't remember that there was one more form that I needed to sign that stated I did everything and put it in my envelope.

I made the decision to run for the Maine House of Representatives because I knew that MCEA funding was available for legislative campaigns. I don't like the idea of Traditional Campaign Financing because large donors think they can control you. I am running to represent all the people in my district, and I don't want to have to solicit funds from donors from other areas.

I have attached my completed and signed 2022 Request For Certification As a Maine Clean Elections Candidate for the Legislature to my E-Mail and enclosed the original with this Appeal in the Regular Mail. Please accept my Appeal and grant my request for MCEA funding for my 2022 HD 141 Campaign. Thank you for your time.

NOTICE OF HEARING

Hearings Scheduled for May 6, 2022

On April 28, 2022, the staff of the Maine Ethics Commission completed its review of a request for Maine Clean Election Act funding by Ms. Patricia Kidder, a candidate for the Maine House of Representatives, District 141. The Commission staff found that Ms. Kidder did not submit the Request for Certification form within the qualifying period, as required by the Commission rules. For these reasons, the Commission staff determined that Ms. Kidder did not meet the requirements to receive Maine Clean Election Act funding under 21-A M.R.S. § 1125(5).

Ms. Kidder has appealed the staff determination. Pursuant to 21-A M.R.S. § 1125(14), the Commission will hold a hearing on her appeal, with the agreement of the appellant, on Friday, May 6, 2022 at 10:00 a.m. The hearing will be held at the Commission office at 45 Memorial Circle, in Augusta. The hearing will be streamed to YouTube for the public to access.

The May 6, 2022 hearing will be conducted in accordance with Chapter 2 of the Commission's rules (available at www.maine.gov/ethics) and the Maine Administrative Procedure Act, 5 M.R.S. §§ 8001 et seq.

Issue to be Addressed at the Hearing

At the hearing, Ms. Kidder has the burden of proving that the determination by the Commission staff was in error as a matter of law or was based on factual error. The members of the Commission are expected to reach a decision in the matter as part of the hearing.

The appellant, the Commission staff, and any intervenors may present evidence and legal argument at the May 6, 2022 hearing.
