Re: anonymous mailer sent to St. George voters re May 13, 2024 ballot referendum

Commission members,

I urge you to open a formal investigation into the complaint submitted by Rep. Ann Matlack, a St. George resident, who received the anonymous mailer sent to many town residents immediately preceding our annual Town Meeting in May 2024.

While I did not receive one of the postcards, as a member of the St. George Select Board I received a number of calls and emails from residents who had received it and were angry that the sender failed to identify him or herself and included inflammatory and inaccurate information in the mailer, sent only a few days before the election on a ballot question.

Although it may be difficult, or even impossible, to identify the person who circulated this mailing, the Commission should investigate and make a formal declaration as to whether this anonymous mailing violated State election law. Irrespective of the ability to hold this individual accountable, deterring future attempts to illegally influence local elections is an important function of this Commission.

Dear Members of the Commission,

I am writing to express my strong support and encouragement for the Maine State Commission on Governmental Ethics and Elections Practices to thoroughly investigate the complaint regarding the anonymous mailer sent to St. George voters in May 2024. This mailer, which contained inaccurate information, has raised significant concerns within our community about the integrity and transparency of our electoral processes.

Representative Ann Matlack, a respected resident of St. George, has rightly filed a complaint alleging a violation of the Maine Campaign Finance Law. As stipulated in 30-A M.R.S.A. 1055-A(1), any person or organization spending over \$500 on communications advocating for or against a ballot question must disclose the source of funding. The failure to do so undermines public trust and transparency, essential pillars of our democratic process.

The agenda item for your meeting on July 24, 2024, at 9 a.m. specifically addresses this issue under "Request for Investigation – May 2024 Referendum in St. George, Maine." I urge the Commission to take decisive action in this matter to uphold the principles of fairness and accountability in our elections. Investigating and addressing this complaint will reinforce the importance of adherence to campaign finance laws and deter future violations.

Re: Request for investigation of mailer sent to some St. George voters concerning May 13th ballot referendum

I was among an unknown number of Town of St George residents who received the post card in question as well as other supportive material for this proposition presumably from the CDC prior to May 13th.

Earlier, on March 25th I attended a public hearing at the town office at which time this proposal was presented. I asked several questions of Mr. Robert Kelley from the CDC, to which he failed to provide me with adequate answers. I heard several other statements from residents in attendance expressing opposition to this proposal for a variety of reasons. I do not recall hearing supportive statements and claims from anyone other than Mr. Kelley himself.

To say the very least, this ballot referendum has proven to be highly controversial among St. George residents and would provoke additional controversy the more widely it might become known should it be presented again.
