Re: Late Filing of Ballot Question Committee Registration and Recommended Penalty –

Protect ME – No Red Flag

If a "person", which is defined as an individual or organization, raises or spends more than \$5,000 (the "registration threshold") to influence a ballot question campaign, that person must register with the Commission on Governmental Ethics and Election Practices (the "Commission") as a ballot question committee within 7 days of exceeding the registration threshold. Protect ME – No Red Flag (the "BQC") is a ballot question committee formed by the Sportsman's Alliance of Maine ("SAM") to oppose the red flag citizen initiative on the November 2025 ballot. According to the BQC's initial campaign finance report, it exceeded the registration threshold on May 29, 2025. Although the registration was due on or before 11:59 pm on June 5, 2025, the BQC did not submit its registration until July 1, 2025, which was 26 calendar days after the deadline for submission.

LEGAL REQUIREMENTS

Late-filed Registration. The process for determining whether a fine should be assessed for the late filing of a committee registration differs from the process for calculating a preliminary penalty for the late filing of a committee campaign finance report. As stated above, a person is required to register within 7 days of receiving contributions or making expenditures in excess of \$5,000. 21-A M.R.S. §1052-A(1)(A-1). If a ballot question committee does not timely file its registration, the Commission *may* assess a fine of no more than \$2,500. When determining whether to assess a fine and the amount of a fine, the Commission must consider factors such as:

• whether the violation was intentional:

- the amount of campaign and financial activity that occurred before the committee registered;
- whether the committee intended to conceal its campaign or financial activity; and
- the level of experience of the committee's volunteers and staff.

21-A M.R.S. § 1062-A(1).

DISCUSSION AND STAFF RECOMMENDATION

On May 29, 2025, the BQC received a contribution of \$50 that when combined with a previous contribution of \$5,000 (a transfer from SAM's general treasury to the BQC) on May 18, 2025, caused the BQC to exceed the registration threshold. At the end of June, Commission staff received a call from Kim Moulton at SAM. Ms. Moulton is the Authorized Agent for the BQC. Ms. Moulton informed us that since she had not seen any reminders about the upcoming filing deadline for the new BQC, she checked on the BQC registration and discovered that although the registration documents had been filled out, the registration had not been submitted to the Commission. Ms. Moulton believed that David Trahan, the Executive Director of SAM and the BQC's Principal Officer, had timely hand-delivered the completed registration to the Commission's offices prior to the deadline.

As soon as she realized that was not the case, Ms. Moulton promptly contacted the Commission staff and submitted the registration materials.

Commission staff considered the following when determining its recommendation to the Commission:

- The violation was not intentional. The committee intended to register and took significant steps to complete the registration process, but there was a misunderstanding as to who was delivering the paperwork to the Commission.
- There was no intent to conceal the campaign or financial activity. As soon as it was
 discovered the BQC registration had not been timely filed, Ms. Moulton contacted
 Commission staff to acknowledge the error and she promptly submitted the completed
 registration documents.
- A significant portion of the contributions was the initial \$5,000 general treasury transfer.
- SAM is an experienced organization which has been involved in multiple ballot question campaigns.

- Since 2018, the Commission staff has recommended penalties of at least \$750 when a campaign finance *report* is filed late for routine, good faith reasons, sometimes with further reductions for good cause.
- In May 2024, the Commission assessed a \$250 penalty against a municipal ballot question committee in Boothbay Harbor for not *registering* on time, Citizens for a Bright Future. However, that matter is distinguishable from the current matter. In the 2024 matter, the people who funded the committee were caught off guard because the law had recently changed to apply to municipal referenda. This was one of the factors in the assessment of a lower penalty. This is the only penalty assessed by the Commission for a late-filed committee registration since 2018.

After considering the factors that led to the late filing and factoring in the good faith efforts to timely file the BQC registration, as well as the level of experience SAM personnel has with campaign finance filing requirements, Commission staff recommends the following:

- A finding that the committee violated 21-A M.R.S. § 1052-A(1)(A-1) by not registering with the Commission within 7 days of receiving contributions or making expenditures totaling more than \$5,000; and
- Assessment of a \$500 penalty pursuant to 21-A M.R.S. § 1062-A(1) for this violation. In recommending a penalty of \$500, the staff is putting weight on the significant steps taken by Ms. Moulton to register the BQC on time. We acknowledge that SAM has been involved in multiple ballot questions and should be held to a high standard. If the Commission believes the recommended penalty of \$500 is insufficient as a precedent or deterrent, the Commission has the discretion to assess a higher penalty.

Commission staff would like to note that we offered SAM the opportunity to submit comments for you to consider. Because they felt the staff recommendation of \$500 was fair and reasonable, they did not submit comments.

Re: Notice of Late Filing of Ballot Question Committee Registration and Recommended

Penalty

Dear Lisa Keim:

The Commission on Governmental Ethics and Election Practices (the "Commission") staff has preliminarily found that the Protect ME – No Red Flag ballot question committee (the "committee") was late in filing its registration. Although the registration was due by 11:59 p.m. on June 5, 2025, it was not filed until July 1, 2025.

Per 21-A M.R.S. § 1062-A(1), the Commission may assess a penalty of no more than \$2,500 for failure to timely file a ballot question committee registration. When assessing a penalty, the Commission must consider factors such as whether the violation was intentional, the amount of financial activity that occurred prior to the committee registering, whether the committee intended to conceal its financial activity, and the level of experience of the committee's personnel with campaign finance filings.

After discussing with committee personnel the factors that led to the late filing and factoring in the good faith efforts made by personnel to timely file, as well as the level of experience the Sportsman's Alliance of Maine personnel has with campaign finance filing requirements, the Commission staff will recommend the following to the Commission at its September 24, 2025, meeting:

- A finding that the committee violated 21-A M.R.S. § 1052-A(1)(A-1) by not registering with the Commission within 7 days of receiving contributions or making expenditures totaling more than \$5,000; and
- Assessment of a \$500 penalty pursuant to 21-A M.R.S. § 1062-A(1) for this violation.

The final decision on the amount of any penalty will be made by the members of the Commission. Please let me know if you have any questions.

Late Filing of Ballot Question Committee Registration – Protect ME – No Red Flag Applicable Law (pre-September 24, 2025 version)

Title 21-A

§1001. Definitions

3. Person. "Person" means an individual, committee, firm, partnership, corporation, association or organization.

§1052. Definitions

- **1. Campaign**. "Campaign" means any course of activities to influence the nomination or election of a candidate or to initiate or influence any of the following ballot measures:
 - A. A people's veto referendum under the Constitution of Maine, Article IV, Part Third, Section 17;
 - B. A direct initiative of legislation under the Constitution of Maine, Article IV, Part Third, Section 18;
 - C. An amendment to the Constitution of Maine under Article X, Section 4;
 - D. A referendum vote on a measure enacted by the Legislature and expressly conditioned upon ratification by a referendum vote under the Constitution of Maine, Article IV, Part Third, Section 19;
 - E. The ratification of the issue of bonds by the State or any agency thereof; and
 - F. Any county or municipal referendum.
- **2-A. Ballot question committee.** "Ballot question committee" means a person that receives contributions or makes expenditures aggregating in excess of \$5,000 for the purpose of initiating or influencing a campaign, other than a campaign for the nomination or election of a candidate. The term "ballot question committee" does not include a political action committee or an exempt donor.
 - **4-A.** Influence. "Influence" means to promote, support, oppose or defeat.

§1052-A. Registration

A committee shall register with the commission and amend its registration as required by this section. A registration is not timely filed unless it contains all the information required in this section.

- **1. Deadlines to file and amend registrations**. A committee shall register and file amendments with the commission according to the following schedule.
 - A-1. A ballot question committee shall register with the commission within 7 days of receiving contributions or making expenditures in the aggregate in excess of \$5,000.

§1062-A. Failure to file on time

1. Registration. A political action committee required to register under section 1052-A, 1053-A or 1053-B or a ballot question committee required to register under section 1053-A that fails to do so or that fails to provide the information required by the commission for

registration may be assessed a fine of no more than \$2,500. In assessing a fine, the commission shall consider, among other things, whether the violation was intentional, the amount of campaign and financial activity that occurred before the committee registered, whether the committee intended to conceal its campaign or financial activity and the level of experience of the committee's volunteers and staff.
