Re: Complaint about Websites Promoting Candidates

#### Introduction

William Clardy filed the attached complaint (the "Clardy complaint") about websites promoting roughly 130 candidates for the Maine Legislature in 2024. He searched the campaign finance reporting of the associated campaigns and found that some of them reported making expenditures for services that were obviously or potentially related to the websites (*e.g.*, graphics services, hosting, or registering a domain name). Mr. Clardy determined, however, that the campaigns of 54 candidates did not report paying for any website services or receiving such services as in-kind contributions from others. The roughly 130 websites can be grouped into two categories:

- 1) Around seventy-nine (79) of the websites are based on a common design template and have similar URLs that incorporate the last name of the candidate, such as <a href="https://stover.mainecandidate.com">https://gere.mainecandidate.com</a>. We recommend viewing one these websites online. These mainecandidate.com websites have been maintained by the Maine Democratic Party in consultation with the Senate Democratic Campaign Committee (SDCC) and the House Democratic Campaign Committee. The SDCC and the HDCC are the political action committees (PACs) of the Democratic caucuses of the Maine Legislature (referred to below as the "caucus PACs"). The websites contain the same disclaimer at the bottom of the home page: "Paid for and authorized by the candidate." Most sections of this memo focus on the mainecandidate.com websites.
- 2) Around fifty-one (51) of the websites have a different URL and apparently were organized by the candidates themselves. Our preliminary investigation focused on 12

of these websites. The look and content of these websites vary. Most of the 12 websites we examined contained disclaimers indicating they had been paid for by the candidates. The compliance of these websites is discussed in the last  $2\frac{1}{2}$  pages of this memo.

Among other things, Mr. Clardy is concerned that some of the websites contain the disclaimer "Paid for and authorized by the candidate" even though the candidates reported no payments for website services. Complaint, at 3. He also asks the Commission to consider whether persons other than the candidates paid for the websites which resulted in in-kind contributions that candidates did not report and could violate the restrictions on Maine Clean Election Act candidates. Complaint, at 2.

#### **Relevant Law**

Disclaimer requirements for websites that are authorized by a candidate

If a person makes an expenditure for a communication to voters that is authorized by a candidate and that expressly advocates for the candidate's election, the website must clearly and conspicuously state the name and address of the person who made or financed the expenditure and state that the website was authorized by the candidate. 21-A M.R.S. § 1014(1). If the candidate or the candidate's committee paid for the communication, the address may be omitted. *Id.* Many paid communications use the phrase "paid for by" to identify the communication's sponsor, but that language is not required by law.

#### Statutory definition of contribution to a candidate

With respect to candidates, the term "contribution" is defined to mean, in part: "[a] gift, subscription, loan, advance or deposit of money or anything of value made for the purpose of influencing [a candidate nomination or election]." 21-A M.R.S. § 1012(2)(A). The definition lists 15 types of costs and activities that are excluded. § 1012(2)(B). In their response to the complaint, the caucus PACs rely on an exclusion for "[c]ompensation paid by a state party committee to its employees" to provide up to 40 hours of assistance to a candidate.

§ 1012(2)(B)(7)(a). They also rely on an exclusion for "[t]he use of offices, telephones, computers and similar equipment when that use does not result in additional cost to the provider ...." § 1012(2)(B)(9). The Commission has further defined an in-kind contribution in its rules. 94-270 C.M.R. ch. 1, § 6(4)&(5).

#### Contributions arising from coordinated expenditures

If a person makes an expenditure in cooperation or consultation with a candidate to promote that candidate, the candidate has received a contribution:

Any expenditure made by any person in cooperation, consultation or concert with, or at the request or suggestion of, a candidate, a candidate's political committee or their agents is considered to be a contribution to that candidate.

21-A M.R.S. § 1015(5). This subsection appears within the statute that sets contribution limits for state and municipal candidates. The Commission has historically interpreted this section to apply to MCEA candidates even though they may not accept contributions after qualifying for MCEA funding.

#### Definitions of expenditures for PACs and party committees

Maine campaign finance law defines "expenditure" for PACs and ballot question committees, in part, as:

A purchase, payment, distribution, loan, advance, deposit or gift of money or anything of value, made for the purpose of initiating or influencing a campaign ...

21-A M.R.S. § 1052(4)(A)(1). The PAC/BQC expenditure definition lists seven types of costs and activities that are excluded. § 1052(4)(B). The caucus PACs rely on an exclusion for "[a]ny communication by a committee that is not made for the purpose of influencing the nomination or election of any person to state or county office ...." § 1052(4)(B)(6). The expenditure definition that applies to state party committees is in a different section of statute but is similar. 21-A M.R.S. § 1012(3). That definition also contains an exclusion for compensation paid by a state party committee to staff to provide up to 40 hours of assistance to a candidate. § 1012(3)(B)(10)(a).

Restrictions on contributions to legislative candidates

Candidates who join the Maine Clean Election Act (MCEA) program agree not to accept any cash or in-kind contributions. 21-A M.R.S. § 1125(6). The maximum amount that a source may give to a traditionally financed candidate for the Legislature is \$475 per election, except for the candidate and their spouse or domestic partner. 21-A M.R.S. § 1015(1) & (2-B). The limit applies to monetary and in-kind contributions (goods or services).

#### Complaint by Mr. Clardy

Enclosed with Mr. Clardy's complaint are three lists of candidates:

- 1) His first enclosure lists 54 candidates who (he says) did not report any expenditures in 2024 related to website design or maintenance and did not report receiving any inkind contributions of such services. This first enclosure is labeled "No-Pay Candidate-Authorized Websites."
- 2) In the second enclosure to his complaint, Mr. Clardy lists websites for around 130 candidates in the 2024 elections that he describes as "Candidate-Authorized Websites." It includes websites from the first enclosure and also the websites of other candidates who purchased services that seem obviously website-related (e.g., "website design") or were potentially related to their campaign websites (e.g., "digital communications").
- 3) The third disclosure includes the specific transactions disclosed by 162 candidates that were are obviously or potentially related to website services.

The fourth enclosure is domain registration information for mainecandidate.com. The last enclosure consists of 152 pages of screenshots of websites. Because of the length of this enclosure, it is moved to the very end of the materials for this agenda item.

Mr. Clardy asks the Commission to consider five questions. Complaint 2-3. In summary, he asks the Commission to consider whether the disclaimers stating that the candidates paid for the websites are accurate and compliant, and whether the candidates received in-kind contributions that were unreported and potentially a violation of MCEA program requirements. He also asks the Commission to examine spending by the SDCC.

#### **Telephone Interviews of Candidates about mainecandidate.com Websites**

After receiving the complaint, I briefly interviewed four incumbent legislators to gain their perspective on the mainecandidate.com websites that had been set up for them. All four ran for re-election in 2024. They said Democratic staff members had set up the websites for purposes of the 2022 elections. Three of the four legislators remembered providing photos or text to the Democratic staffers in 2022 to be included on the website. One point that I found relevant and contrary to my expectations was that, for purposes of their 2024 re-election campaigns, the candidates seemed to place *no* value on the mainecandidate.com websites:

- One State Senator said that they did not like the mainecandidate.com website and did
  not refer to the website in their 2022 or 2024 campaigns. They did not even know the
  website was operating in 2024 until a supporter called because a donate button on the
  site was not functioning.
- Another State Senator said they were not a fan of campaign websites in general and could not remember providing any information to Democratic staffers to create the mainecandiate.com website established in the Senator's name. The Senator viewed the website as akin to an independent expenditure communication by the SDCC. The Senator believed their campaign did not refer to the website in 2024 campaign materials.
- I interviewed two State Representatives. They both told me they were not aware the mainecandiate.com websites continued beyond the 2022 elections. One volunteered they had not put the website down on any of their 2024 campaign materials.

I interviewed only four candidates and don't know whether their responses are representative of other candidates' views. Other candidates may have viewed the mainecandidate.com websites as more helpful.

One State Representative said in 2022 they were asked by a Democratic staff member to pay \$12 to Google for domain registration, which they did. The other candidates did not mention paying anything for the websites.

#### Response by SDCC and HDCC re: mainecandidate.com

The Commission received a letter-response from the attorneys for the SDCC and the HDCC dated January 10, 2025 ("PAC letter") in which they offer a detailed explanation of the origin and costs of the mainecandidate.com "platform." According to the caucus PACs, the mainecandidate.com platform was created for the Maine Democratic Party by a volunteer technology consultant. PAC letter, at 2. The platform was "built as ongoing infrastructure that would allow for the development of future websites for the caucuses themselves and for future candidates." PAC letter, at 4. The party ended its relationship with the consultant in 2022. PAC letter, at 2. For the 2024 elections, the platform was "exclusively managed and updated by employees of the Maine Democratic Party using no more than two hours of staff time per candidate." *Id.* 

The HDCC and SDCC point out that the costs of mainecandidate.com per candidate are "quite small." PAC letter, at 2. They concede that these costs should have been "better identified," but they argue the small amounts spent per candidate did minimal, if any harm, to the public. *Id.* Their counsel state that "[m]oving forward, with Commission and staff input, our clients are open to revising the structure of and reporting for mainecandidate.com so that all costs are reimbursed and reported." *Id.* 

The caucus PACs identify three costs associated with mainecandidate.com:

- (1) In 2022, the HDCC and SDCC each paid \$750 to the volunteer technology consultant to develop and/or maintain the mainecandidate.com website. PAC letter, at 3-4.
- (2) Since March 2022, the SDCC has paid a monthly fee of \$14.50 to a hosting provider, Linode, to host mainecandidate.com. The SDCC essentially forgot about the purpose of the ongoing charge. PAC letter, at 4-5. These monthly charges "were not noticed or flagged as potential contributions to candidates." PAC letter, at 1. (Commission staff notes the monthly fee is the equivalent of \$174.00 per year.) The caucus PACs calculate the monthly fee amounts to \$0.35 per month for each candidate mentioned in Mr. Clardy's complaint, which the PACs describe as *de minimis* and having very little informational value for the public. PAC letter, at 4-5.
- (3) Paid employees of the Maine Democratic Party maintained the mainecandidate.com platform during 2024, including creating and updating individual candidate websites.

The amount of staff time dedicated per candidate was less than two hours. PAC letter, at 3.

The HDCC and SDCC rely on provisions in the statutory definitions of "expenditure" and "contribution" to contend that they and the Maine Democratic Party made no expenditures that needed to be disclosed in the "paid for by" disclaimer on the mainecandidate.com websites and made no contributions to the candidates they promoted. They argue that: compensation paid by a state party committee to its employees to provide less than two hours of IT assistance to a candidate is not a contribution because it is within the statutory exception for 40 hours of paid staff time that state parties may give to a candidate (§§ 1012(2)(B)(7)(a) & 1012(3)(B)(10)(a)) (PAC letter, at 5-6); a hosting expense of \$0.35 per month per candidate has de minimis value to the candidate and therefore is not "anything of value," which is an element of the contribution and expenditure definitions (§§ 1012(2)(A)(1) & 1052(4)(A)(1) (PAC letter, at 5-6); the hosting fee is covered by an exception for "the use of offices, telephones, computers, and similar equipment when that use does not result in additional cost to the provider" (§ 1012(2)(B)(9)) (PAC letter, at 6); the \$750 fees paid by the HDCC and SDCC to the volunteer technology consultant in 2022 to develop or maintain mainecandidate.com qualifies as "[a] communication by a committee that is not made for the purpose of influencing the nomination or election of any person to state or county office ...." § 1052(4)(B)(6). PAC letter, at 4.

#### Analysis by Commission Staff – mainecandidate.com website

Commission staff recognizes that reasonable minds may differ on how best to apply the statutory provisions raised by Mr. Clardy and the caucus PACs. We offer the analysis in the subsections below as our recommended way to apply specific provisions to advance the disclosure objectives of Maine campaign finance law in future elections without unduly penalizing candidates.

Commission staff's overall view on the mainecandidate.com platform is that in Maine, the political parties and legislative caucuses naturally are going to look for cost-effective ways to promote their nominees. The mainecandidate.com websites are within that tradition. The disclaimer on the mainecandidate.com websites ("Paid for and authorized by the candidate") probably had a rationale in 2022 when the platform was designed but should have been re-

evaluated for the 2024 elections. It is misleading for websites to state they were paid for by candidates, when they were not.

The caucus PACs acknowledge that their 2024 costs should have been better identified and are "open to revising the structure of the platform so that all costs, even de minimis ones, are reimbursed and reports." PAC letter, at 2. Commission staff recommends focusing on corrective action for the 2026 elections. We are neutral on whether the Commission should find there was a violation, even though there could be grounds for finding a disclaimer violation by the SDCC in connection with its monthly expenditures for hosting. Regarding compliance by the candidates, even if it is arguable that candidates received a contribution, Commission staff suggests not pursuing this because any potential contributions to 2024 candidates were minimal and any potential violations were unintentional.

#### Compensation Paid by Maine Democratic Party to Staff is Exempt

Commission staff agrees with the caucus PACs that compensation by the Maine Democratic Party to its employees for a couple of hours of assistance in creating or updating a candidate's mainecandidate.com website is not a contribution to the candidate under this exclusion:

Compensation paid by a state party committee to its employees for the [purpose of] [p]roviding no more than a total of 40 hours of assistance from its employees to a candidate in any election;

21-A M.R.S. § 1012(2)(B)(7)(a).

#### 2022 Payments to Volunteer Technology Consultant are not Relevant to Compliance in 2024

Mr. Clardy asks the Commission to consider whether 2024 candidates received unreported in-kind contributions because the mainecandidate.com websites were paid for by other persons.

On August 17, 2022 and December 19, 2022 (respectively), the SDCC and HDCC each paid a Portland resident \$750 for website services related to mainecandidate.com. In the PACs' letter-response, counsel described these services as "developing the mainecandidate.com"

platform" (PAC letter, at 4) and a cost to "maintain the mainecandidate.com platform." PAC letter, at 3.

These \$750 payments were for services rendered by the consultant in 2022. In the opinion of the Commission staff, the payments were not for the purpose of promoting any 2024 candidate's nomination or election. Therefore, we do not view these payments as an expenditure with respect to 2024 elections, as "expenditure" is defined in 21-A M.R.S. § 1052. The \$750 payments are also not contributions to 2024 candidates.

The caucus PACs argue that the payments of \$750 to the consultant are not expenditures that needed to be included in the mainecandidate.com disclaimer statement because they meet the terms of this exception:

Any communication by a committee that is not made for the purpose of influencing the nomination or election of any person to state or county office ....

§ 1052(4)(B)(6). PAC letter, at 4. The caucus PACs describe these payments as purchases of "ongoing infrastructure that would allow for the development of future websites for the caucuses themselves and for future candidates." *Id.* Commission staff believes it is not necessary to reach this argument. In any case, we have doubts that this exception applies to mainecandidate.com because the purpose of the platform was to expressly advocate for the election of Democratic nominees.

#### Fees Paid for Website Hosting may Qualify as Expenditures, even if Small

The SDCC has paid \$14.50 per month to Linode to host mainecandidate.com, which is disclosed in the PAC's campaign finance reports. PAC letter, at 3. To allocate this cost among the 2024 candidates in Mr. Clardy's complaint, the Commission staff counted 79 different mainecandidate.com websites in Mr. Clardy's second enclosure. Our proposed rough cost per candidate for the entire 2024 election cycle is \$2.02 per candidate. We reached that amount through the following calculation: \$14.50 each month multiplied by 11 months (Jan.-Nov. 2024) divided among 79 candidates equals \$2.02.

As a factual matter, Commission staff agrees with the caucus PACs that the SDCC's spending to host each candidate's website is quite small (roughly \$2.02 per candidate for the entire 2024 election cycle). § 1012(3)(B). Nevertheless, we caution against accepting the caucus

PACs' legal argument that a small hosting or domain registration cost is so minimal that is *not* an expenditure. PAC letter, at 5. It is increasingly feasible for party-based organizations, consultants, or volunteers to use a template to create websites with positive or negative content about a large number of candidates or about a referendum or initiative. Accepting the proposition that small hosting or domain registration costs are not expenditures could open the door to websites that involve *no* expenditures at all, which would mean no required "paid for by" disclaimer statement. We think this would be a risky precedent because members of the public rely on the disclaimers to help them judge the reliability of the websites that promote or attack candidates.

We agree that campaign finance law contains reporting thresholds under which no registration or financial reporting is required. But the "paid for by" disclaimer requirement is particularly important for informing members of the public about the source of election-related communications they receive. The Commission staff recommends against taking any interpretive step that could unintentionally encourage anonymous websites that attack or promote candidates. We note that the Legislature has deliberately created an exception for internet and email activities costing less than \$100 created by individuals that are operating independently of PACs, party committees, and candidates. 21-A M.R.S. § 1014(6)(C). We caution against creating another exception that could cover websites organized by registered PACs, no matter how inexpensive they are.

#### Paying for Website Hosting is Different than Providing Office Equipment

Commission staff disagrees that paying a vendor for cloud hosting is covered by the exception for: "[t]he use of offices, telephones, computers and similar equipment when that use does not result in additional cost to the provider ...." § 1012(2)(B)(9). We suggest that exception covers situations in which a contributor *possesses office equipment* and allows the candidate to use that equipment, for example, for phone banking.

#### Commission has the Discretion to View the SDCC's Payments to Linode as Expenditures

The Commission staff's view is that the SDCC's monthly 2024 payments of \$14.50 to Linode to host the mainecandidate.com website, including roughly 79 individualized pages that

expressly advocated for the election of Democratic nominees, probably should be viewed as expenditures as that term is defined with respect to PACs:

A purchase [or] payment ... of money ... made for the purpose of initiating or influencing a campaign ....

21-A M.R.S. § 1052(4)(A)(1). Campaign includes "any course of activities to influence the nomination or election of a candidate ...." 21-A M.R.S. § 1052(1).

#### Potential Violation of Disclaimer Requirement on mainecandidate.com

It is therefore arguable that the SDCC violated 21-A M.R.S. § 1014(1) because it made expenditures to finance publicly accessible websites on the internet that expressly advocated the election of candidates and the websites did not state the name and address of the person who made the expenditure for the communication, *i.e.*, the SDCC. Rather than identify the SDCC as the person that made expenditures to host the website, the mainecandidate.com websites included the phrase "Paid for and authorized by the candidate" which was largely inaccurate.

The caucus PACs argue that requiring such a disclaimer could cause voter confusion or would be misleading because it would overstate SDCC's involvement. The PACs also assert that requiring candidates to disclose the receipt of small contributions of \$0.35 per month would be extremely burdensome.

Commission staff agrees with the point about burden as far as it relates to financial reporting by candidates. But, regarding the 2024 disclaimer statement on the mainecandidate.com website, our understanding is that the language of the disclaimer statement was within the control of the Maine Democratic Party. We don't understand why it would have been misleading or burdensome for the Maine Democratic Party to adjust the template disclaimer for 2024 to state something accurate along the lines of "Website authorized by the candidate. Hosting fees paid by the Senate Democratic Campaign Committee, PO Box 2227 Augusta, ME." Maybe that option would have presented some hidden difficulties but based on the information received to date such a disclaimer may have been feasible and readily understood by 2024 voters.

Nevertheless, Commission staff suggests there are reasons present for the Commission to exercise its discretion to take no enforcement action against the SDCC for a disclaimer violation:

- It is relevant that the expenditure by the SDCC per 2014 candidate was quite small. Our calculation is that it cost roughly \$2.02 per candidate for the 2014 election cycle.
- Multiple Democratic organizations had oversight of mainecandidate.com in 2022. The monthly Linode charge was put on a SDCC staff credit card in March 2022.
- Campaign organizations such as the SDCC have frequent turnover in staff.
- It is understandable that the purpose of a small monthly credit card fee of \$14.50 that was initiated by SDCC staff in March 2022 could have been overlooked or not understood by SDCC's 2024 staff two years later.
- Any violation of 21-A M.R.S. § 1014(1) by the SDCC was probably unintentional and due to a lack of attention.

If the Commission is inclined to find that the SDCC violated 21-A M.R.S. § 1014(1) and assess a penalty, staff proposes that the maximum penalty would be \$159.50 (\$14.50 per month for January - November 2024).

#### **Staff Analysis - Candidate-Organized Websites**

In his first enclosure, Mr. Clardy identified 54 websites promoting 2024 legislative candidates that he could not find had reported making any expenditures or receiving any in-kind contributions related to website services. Twelve (12) of these websites were not on mainecandidate.com URLs and were apparently organized by the candidates themselves. The Commission staff examined the websites for compliance with the disclaimer requirements and contacted the candidates to verify whether all costs had been reported

The middle column in the following chart summarizes what the Commission staff found concerning whether each candidate had reported their website costs. Two of the candidates had, in fact, disclosed website expenses in their campaign finance reports but they were not easy to detect. One of the candidates reported that she did not have a campaign website in 2014. Nine of the 12 candidates had financed their campaigns with traditional campaign contributions. Several of these candidates had paid for minor website expenses with personal funds, which is allowed, but the candidates must report them. After being contacted by Commission staff, they amended the reports to disclose these expenses.

As discussed in previous meetings, if a candidate amends a campaign finance report to include a minor cost that was omitted when the report was originally filed, the Commission staff generally takes no action unless the omission rendered the originally filed report substantially incomplete. In keeping with this policy, Commission staff recommends taking no action with respect to those candidates that omitted website costs in their reporting.

The Commission staff examined the disclaimers on the 12 websites. The results are summarized in the third column of the following chart. The website disclaimers were compliant except for the website of State Representative Ed Crockett, <a href="www.edcrockettformaine.com/">www.edcrockettformaine.com/</a>. His website contains no statement of who financed the website or that it was authorized by the candidate. In the opinion of the Commission staff, the harm to the public was small because the website looks very much like one that Rep. Crockett sponsored. Commission staff is neutral on whether the Commission should find that the website violated 21-A M.R.S. § 1014(1). I emailed Rep. Crockett to notify him that a finding of violation was possible, but he has not submitted any comments.

#### **Staff Conclusion**

Commission staff would be pleased to engage in any additional investigation desired by the Commission, but we believe the facts gathered to date have been sufficient to decide whether violations occurred. We suggest focusing on encouraging disclosure improvements in the 2026 elections. The caucus PACs acknowledge that costs for mainecandidate.com should have been better identified and expressed openness to restructuring the costs for mainecandidate.com. We don't wish to dictate the solution but perhaps in future elections, each participating candidate could pay a small one-time fee (potentially in the range of \$10 or \$25) to the Democratic party or a caucus PAC to cover hosting, domain registration and any other costs. Depending on the circumstances, a number of alternative disclaimer statements might be compliant such as: "Paid for and authorized by the candidate" or something more descriptive like: "Authorized by the candidate. Fees reimbursed by the candidate."

Mr. Wayne,

I am filing a complaint regarding numerous candidate websites for candidates who ran for legislative offices in 2024.

Most, if not all, of these sites include a disclaimer indicating they were "paid for and authorized by the candidate" (or the candidate's campaign committee), but the candidate has not reported any expenditures or in-kind contributions which can be readily identified as payments for their website. The enclosed spreadsheet titled "No-Pay Candidate-Authorized Websites" identifies 54 such websites and associated candidates.¹ The dollar amounts aren't likely to be large, at least at the level of individual candidates, but there is a cumulative impact on transparency when more than a quarter of one party's legislative candidates have websites which declare they are paid for and authorized by the candidate but there is no visible means of payment – especially.²

In addition, an organization I can only identify as "SDCC" <sup>3</sup> appears to play a key role by hosting templated websites on their mainecandidate.com domain for 77 out of the 122 Democrat candidates with websites "authorized and paid for by the candidate." SDCC's pricing appears to be uneven at best, with the most common candidate-reported total costs being \$0, \$12, and \$24 (in order of reporting frequency). The candidates reporting expenditures for a mainecandidate.com website usually report Squarespace, SDCC's domain registrar, as the payee, but Google and Network Solutions are also listed as payees. This hodgepodge of prices and payments (and non-payments) seems unusual for a vendor who has been providing a standard service for at least three general-election cycles.

Specifically, I am requesting that the Ethics Commission investigate:

- 1. Do the websites I have identified comply with 21-A M.R.S.A. §1014? Were the websites claiming to have been "[p]aid for and authorized by the candidate" actually paid for by the respective candidates? If so, why were the campaign expenditures not reported? If not, then who did pay for the website, and why was that not properly disclosed?
- 2. Additionally, for any websites which were authorized but not paid for by a traditionally financed candidate, why were the costs not reported as coordinated expenditures or in-kind contributions?<sup>4</sup>
- 3. Did any MCEA candidates illegally accept an unauthorized<sup>5</sup> in-kind contribution or otherwise participate in a coordinated expenditure? <sup>6</sup> If so, did they willfully violate the law or were they simply relying on bad advice from a trusted colleague?
- 4. Who is SDCC? Is SDCC exempt from reporting under 21-A M.R.S.A \$1014(6)?<sup>7</sup>
- 5. What services does SDCC offer to candidates, and are any of those services restricted to Democratic Party candidates? For services which

aren't offered to the general public, is SDCC subsidizing any candidates' costs for those services? Is SDCC subsidizing any candidates' costs for campaign websites?

I hope my underlying principle seems self-evident: "[P]aid for and authorized by the candidate" is supposed to mean something. It's not something to be said when someone other than the candidate is footing the bill, and it really gets sticky when clean-election funding is involved (or should be involved but isn't). Attempted end runs around the constraints candidates agree to in exchange for receiving MCEA funding run counter to the intent of "clean election" funding. Most importantly, it's a very unambiguous threshold for Maine candidates to respect.

As always, I urge the Commission to reasonably consider motives in deciding what action, if any, should be taken. Do not discourage "best effort" attempts at compliance with undue punishment, but don't be unduly forgiving of experienced political mentors who should know better and may have been encouraging or abetting minor violations for years.

Dear Mr. Wayne,

We write on behalf of the Senate Democratic Campaign Committee (SDCC) and the House Democratic Campaign Committee (HDCC) in response to your questions regarding a complaint from Mr. William Clardy who alleges potential noncompliance with 21-A M.R.S. § 1014 and questions the activities of the SDCC.

The SDCC and HDCC (the "Caucuses") are designated caucus PACs, entities whose purpose is to "promote the election of nominees of the caucus leader's political party." As part of this function, the caucuses maintained a website hosting platform, which was offered to candidates who wanted to create their own websites at no additional cost to them. Costs related to that hosting were all reported and disclosed in the Caucus's campaign finance reports. These costs, however, which recurred monthly, were not noticed or flagged as potential contributions to candidates. As a result, candidates were not aware that a recurring monthly charge, as minimal as it was, was helping to support their sites.

Specifically, the SDCC haspaid a monthly \$14.50 hosting fee for mainecandiate.com since early 2022. This recurring fee totals \$396.50 since the SDCC began paying it, or \$.35 cents per candidate per month using the websites Mr. Clardy highlighted from the 2024 cycle.

As people who are not particularly tech savvy, it has taken some effort to fully understand mainecandidate.com. For others who may also need some explanation we offer this: mainecandidate.com is like a big online building (the platform), e.g. 45 Memorial Street, with many individual floors (which are available to be individualized websites). Each floor has its own unique number (URL), but they are all located within the same building.

Candidates would not have to purchase their own URL to "occupy" a floor. Instead, the platform generates these URLs automatically based on the candidates' last names using something known as DNS a "Domain Name System." The only URL that needs to be purchased is the root domain name, mainecandidate.com, which serves as the foundation for all the individual candidate websites. For these reasons, mainecandidate.com can be thought of as a "platform" and we use this term in response to your questions. This platform hosts multiple individualized candidate websites, each following the format <a href="https://[name].mainecandidate.com">https://[name].mainecandidate.com</a>. While each candidate appears to have their own website, they are all part of the larger mainecandidate.com platform.

As you will see in the details that follow, expenses for mainecandidate.com on behalf of individual candidates are quite small. As such, while our clients can concede that these small amounts should have been better identified, the expenses and alleged violations did minimal, if any, harm to the public given the amount of reporting and transparency already provided by the SDCC and the HDCC. Moving forward, with Commission and staff input, our clients are open to revising the structure of and reporting for mainecandidate.com so that all costs, even de minimis ones, are reimbursed and reported.

Below please find answers to your specific questions on this matter.

(1) Please identify all registered committees, organizations, and vendors who are responsible for or involved in the mainecandidate.com websites since January 1, 2021, and explain their roles. Please feel free to exclude sub-vendors who have minor involvement in the websites.

The registered committees, organizations, and vendors involved in the mainecandidate.com websites since January 1, 2021, include the SDCC, the HDCC, and the Maine Democratic Party (MDP).

The mainecandidate.com website platform was created for the Maine Democratic Party by a volunteer technology consultant. MDP ended its relationship with the volunteer in 2022. At that time, the SDCC placed the ongoing hosting fee on its credit card. That quick transfer was done for convenience at the time and to ensure that the platform remained active during the transition from the volunteer's involvement. Once transferred, the SDCC essentially forgot about the purpose of the ongoing charge. Since that transfer in 2022, the mainecandidate.com platform has been exclusively managed and updated by employees of the Maine Democratic Party using no more than two hours of staff time per candidate. In some cases, the candidates themselves managed and updated their mainecandidate.com pages.

In summary, the Caucuses, and the Maine Democratic Party are the only parties who have been involved in the mainecandidate.com website since January 1, 2021. There were no vendors or sub-vendors involved in content creation.

(2) In general terms, since January 1, 2021, describe the types of services that the committees, organizations, and vendors identified in (1) have paid for in connection with the mainecandidate.com websites. Please respond based on what you know and what you would

expect. For example, have they paid any costs to reserve domain names? Have they paid vendors for graphic or web design? Have they paid staff or vendors to create and modify the content of the websites? Have they paid for hosting?

The Caucuses paid for three services in connection with the mainecanddiate.com websites since January 1, 2021. These services are 1) operating expenses 2) de minimis in cost and 3) exempt as a contribution.

First, in 2022, the Caucuses each paid \$750.00 to maintain the mainecandidate.com platform. The \$750 expense was an operating expense and was reported by SDCC and HDCC as such. Please see our response to question three for a full discussion of this issue.

Second, since March 2022,<sup>1</sup> SDCC has paid a monthly fee of approximately \$14.50, for a overall total of \$396.50, to a company called Linode for the hosting of mainecandidate.com. The assumption of that fee by the SDCC was done during the volunteer's transition from MDP and was in an effort to simply and quickly ensure continuity of the platform. The recurring fee to Linode was properly reported and disclosed in SDCC filings but it appears that the purpose of the fee was not known to staff after the handoff from MDP in 2022

Hosting fees paid by the SDCC come to a total of \$396.50 or \$. 35 cents per candidate per month using the mainecandidate.com websites questioned by Mr. Clardy.

Third, all work on the individual websites was done by MDP staff as part of their allowed direct candidate support under 21-A M.R.S. § 1012(2)(B)(7)(a). The Maine Democratic Party paid for staff time of no more than two hours per candidate to create websites. The MDP expense for this staff time is not a contribution to the candidates under Maine law due to the state party exception.<sup>2</sup> 21-A M.R.S. § 1012(2)(B)(7)(a). This is discussed in detail in response to questions three and four.

Other than the aforementioned costs, no other vendors were engaged with mainecandidate.com. The mainecandidate.com platform was designed to be low-cost, efficient and simple. As such, state party staff have created and managed website content, including creating and updating individual candidate websites in less than two hours.

In summary, since January 2021, the Caucuses paid to maintain the mainecandidate.com platform. The SDCC paid de minimis costs to host mainecandidate.com in support of the individual websites and state party staff have uploaded content using staff time within the state party forty-hour limit.

(3) Did the HDCC, SDCC, or others make expenditures for the mainecandidate.com websites since January 1, 2021? If so, did the websites correctly state the person(s) "that made or financed the expenditures" for the websites, as required by § 1014(1)?

Yes, in 2022 the Caucuses each paid \$750.00 for the work of developing the mainecandidate.com platform. The SDCC has paid the monthly hosting fee of approximately \$14.50 since 2022, totaling \$396.50, or \$. 35 cents per candidate per month for the 2024 candidates, and state party staff managed individual candidate websites. The hosting fee supports individualized candidate pages of the mainecandidate.com websites.

However, these expenses for the development of the mainecandidate.com platform, monthly hosting fees, and state party staff do not trigger a need to disclose the Caucuses as a person that made or financed an expenditure for a candidate website under § 1014.

When a communication is authorized by a candidate, the communication is required to 1) clearly state that the communication is authorized by the candidate and 2) clearly state the name and address of the person who made or financed the expenditure for the communication. 21-A M.R.S. § 1014(1). All of the mainecandidate.com websites met the first prong and provide important information to the public because they clearly stated that they are authorized by the candidate. At issue here is the second prong, the requirement to state the name and address of the person who made or financed the expenditure. There are three potential costs to consider here:

First, the \$750 payments from the Caucuses to the MDP volunteer. Those \$750 payments should not be disclosed by candidates under § 1014(1) as they were Caucus operating expenses, not expenses to support a candidate communication. Operating expenses are expenditures not made on communications made to initiate or influence any campaign (i.e. rent, phones, paper towels, etc.). 21-A M.R.S. 1052(4)(B)(6), 21-A M.R.S. § 1060(7). Here, the expense to develop the mainecandidate.com platform paid by the Caucuses was not to influence a campaign or support or oppose a candidate. Rather, the platform was built as ongoing infrastructure that would allow for the development of future websites for the caucuses themselves and for future candidates. Supporting that intent, those expenses were reported and disclosed as operating expenses.

Second, the hosting fee paid for by the SDCC was a de minimus contribution of \$.35 cents per candidate per month. Such a nominal cost should not be on required candidate disclosures as it has the potential to overstate the SDCC's involvement – leading to voter confusion and misinformation.

Third, the limited expenses for MDP staff time are expressly carved out of the definitions of contribution and expenditures. As such, it is not accurate under the statute to list the MDP as an entity that "made or financed the expenditure."

While more detail is provided below on the hosting fee and the staff time, we do not believe any of the three costs identified by the Caucuses require candidates to disclosure these activities in their communications to voters.

### De minimis Cost

An expenditure includes a purchase, money, or anything of value made for the purpose of influencing the election of a person to office. 21-A M.R.S. § 1012(3); 1052(4)(A). SDCC's \$396.50 is a purchase of online hosting for candidate websites. The purpose of the candidate websites is to influence the election of those candidates. However, as previously discussed, the cost per candidate per month for the candidates Mr. Clardy highlighted from the 2024 cycle is just \$.35 cents. As such, the hosting fee is so nominal as not to be "anything of value." It is therefore so de minimis that to require additional disclosure by each candidate would be both misleading and extremely burdensome, particularly when the MDP, HDCC, SDCC all disclose their support for and activity on behalf of their candidates repeatedly through the election cycle.

Other areas of Maine campaign finance law recognize the limited utility in itemizing and disclosing de minimis contributions and expenditures that provide little additional information concerning who is spending what to influence elections. For example, candidates identify the name and address of contributors whose contributions aggregate in excess of \$50.00. 21-A M.R.S. § 1017(4). Organizations can spend up to \$2,500 to influence candidate elections without registering and filing PAC reports. 21-A M.R.S. § 1052-A(1)(4). Independent express advocacy to voters is not required to be reported as an Independent Expenditure unless it costs more than \$250. 21-A M.R.S. § 1019-(B(4). While the Maine Clean Election Act does not allow candidates latitude to accept *any* contributions, we ask that the Commission take these other areas of law into account and weigh the benefit of these websites disclosing SDCC's nominal contribution in addition to the candidates authorization.

Whether the disclaimers were compliant as presented is analogous to the recent CapeVoters matter that seemed to hinge on the purpose of a disclaimer - letting the public know who is responsible for a communication. There, staff recommended, and the Commission found that naming CapeVoters in the disclaimer, even though an individual had paid \$2192.92 for the mailing, was compliant because "naming CapeVoters in the disclaimer . . . had greater informational value for the public than naming Sandi Dunham who merely picked up the tab." Staff Memo to Maine Commission on Governmental Ethics and Election Practices Re: Supporter Pays for Mailing on Behalf of Political Group (Dec. 6, 2024). The crucial reasoning seems to be that CapeVoters was responsible for the mail in the same way candidates are responsible for their websites.

Here, a 2024 candidate's website would be supported by an expense of \$.35 cents per month. As such, the amount of support for any of the individualized mainecandidate.com websites is quite a bit less than an itemizable contribution and well under other reporting thresholds. While the § 1014(1) disclaimer requirement does not include a \$50.00 threshold, our clients ask that the Commission consider that thresholds exist to share relevant information with the public, the de minimis nature of the expense, the information provided to the public through meeting the first prong of § 1014(1) and all of the caucus's other disclosures of support, and the limited benefit of additional information to the voting public.

### State Party Employee Exemption

Additionally, an expenditure does not include "compensation paid by a state party committee to its employees for . . . providing no more than a total of 40 hours of assistance from its employees to a candidate in any election." 21-A M.R.S. § 1012(3)(B)(10)(a). Maine

Democratic Party staff were solely responsible for the individualized candidate website and report spending no more than two-hours per website. As such, the state part expense for staff effort on mainecandidate.com websites is not a contribution.

In summary, the individualized candidate websites are not expenditures because the hosting costs associated with them were so nominal as not to be "anything of value," and disclosing SDCC's support has the potential to overstating SDCC's involvement. Moreover, the expense for limited state party staff time is outside of the statutory definition of expenditure or contribution to a candidate. As such, under 21-A M.R.S. § 1014(1), the logical disclaimer is of that who made, or is responsible for, the communication, and the websites in question included this information.

(4) The mainecandidate.com websites might be viewed as a contribution to each candidate, because it was a service given to the candidate ( $\S$  1012(2)) or a financial activity that was coordinated with the candidate to promote them ( $\S$  1015(5)). Recognizing that the definitions of contribution and expenditure contain several exclusions, is there is a reason that the mainecandidate.com websites do not constitute contributions to the candidates under 21-A M.R.S.  $\S\S$  1012(2) & 1015(5) and 94-270 C.M.R. ch. 1,  $\S$  6(4)&(5).

Because the payments of \$750 were operating costs under § 1052(4)(B)(6) and the state party staff time was within the exemptions under §§ 1012(3)(B(10)a) and 1012(2)(B)(7)(a), the issue is whether the SDCC-paid hosting fees of \$ 396.50, \$.35 cents per candidate per month may constitute contributions to the candidates under M.R.S. § 1012(2).

A contribution is "[a] gift, subscription, loan, advance or deposit of money or anything of value made for the purpose of influencing [a candidate nomination or election.]." 21-A M.R.S. § 1012(2)(A).

### Hosting Fees

As discussed above, the hosting fee that SDCC has been paying is a de minimis expense for infrastructure that totals \$396.50 since 2022 and comes to \$.35 cents per candidate per month in 2024. Because it is plausible that it is not "anything of value" under § 1012(2), the hosting fee is not a contribution.

Additionally, under Maine law candidates are not required to report certain contributions, including, for example: "the use of offices, telephones, computers, and similar equipment when that use does not result in additional cost to the provider," "wood or other materials used for political signs," and the sale of food or beverage to a candidate at a charge less than the normal charge so long as the candidate at least pays the vendor's cost and the cumulative value does not exceed \$100 per election. 21-A M.R.S. § 1012(2)(B)(9), (8-B), (3).

As so much of the world moves online and website and technology infrastructure becomes far more commonplace and very inexpensive, it is entirely plausible that such de minimis hosting costs should be considered "similar equipment" under the definition in § 1012(2)(B)(9).

Here, the hosting fee supports an online platform with "floors" that individual candidates may or may not choose to use. Whether a candidate choses to use the platform does not change

the cost of the platform, so no additional costs are incurred. This is similar to a supporter or organization providing offices or phones to a candidate so long as doing so does not create additional cost for the provider.

Because the hosting cost is nominal and because it is analogous to "the use of offices, telephones, computers, and similar equipment when that use does not result in additional cost to the provider," which candidates are not required to report under Maine law, the hosting fee should not be considered a contribution in this instance.

Turning to the administrative burden, the reporting burden of a \$.35 per candidate per month hosting fee to be additionally reported by candidates is considerable and overly burdensome when weighed against the benefit to the public.

### Expense for Staff Time

The term "contribution" does not include compensation paid by a state party to its employee provided that no more than a total of 40 hours of assistance is provided from the employees to a single candidate. § 1012(2)(B)(7)(a).

Other than the aforementioned fees paid by the SDCC and the HDCC, the expense that produced the websites was less than two hours total of state party staff time per candidate website. As such, the building and limited maintenance of the mainecanddiate.com websites – which were simple, template-based websites – are not contributions because compensation paid by a state party to its employee for less than 40 hours of work is not a contribution.

Likewise, this state party staff exemption allows state party staff to support candidates in coordinated ways that would, in other scenarios, qualify as a contribution under 1015(5). While an expenditure made by any person in cooperation, consultation or concert with, or at the request or suggestion of a candidate or their agents is considered is a contribution to that candidate and financing campaign materials prepared by the candidate, their committee or their agents is considered to be a contribution to that candidate under § 1015(5), the term "contribution" does not include compensation paid by a state party to its employee provided that no more than a total of 40 hours of assistance is provided from the employees to a single candidate. § 1012(2(B)(7)(a).

Commission rules also make clear that discounted goods or services or free labor would count as a contribution. 94-270 C.M.R. ch. 1, § 6(4)&(5). For example, a talented designer creating a free website for a candidate would be an in-kind contribution. Here, however, the situation is different. The Maine Democratic Party paid for and reported the construction of a platform. Paid Maine Democratic Party staff then used platform to create template websites for candidates. SDCC paid for hosting all of those websites and reported the expenditure as an operating cost.

### **CONCLUSION**

We have appreciated this opportunity to dig into the structure and functioning of the "mainecandidate.com" platform – an examination which was clearly due. In that digging, we identified three costs related to the platform. As articulated above, we do not believe that any of these costs met the threshold for either candidate communication disclosure or candidate campaign finance reporting disclosure. The SDCC is open to revamping how it manages the platform and

changing how such costs are reported. The Caucuses are open to working with Commission staff to ensure fair and appropriate disclosure to the public. That said, we do not believe these instances justify further investigation by Commission staff and ask that Mr. Clardy's complaint be dismissed.

The Ethics Commission received the attached complaint from Mr. William Clardy about the campaign websites of 54 candidates, including a website that promoted your election to the Maine Legislature. After reviewing campaign finance reports, Mr. Clardy concluded the candidates did not report paying for any services related to the websites. He is asking the Commission to consider a few issues, including:

- Did the candidates pay any costs for the websites that were not included in 2024 campaign finance reports?
- If any other person paid for the websites (*e.g.*, the campaign committee of a legislative caucus), do those payments represent in-kind contributions to the candidates that are inconsistent with the restrictions on Maine Clean Election Act and traditionally financed candidates?
- Do the websites accurately state who paid for them?

Mr. Clardy's complaint is scheduled for discussion at the Commission's meeting on December 18, 2024. If you paid anyone in connection with your 2024 campaign website, please email me at Julie.Aube@maine.gov with the dates, amounts, and payees for the payments and amend your campaign finance reports if necessary. Otherwise, at present the Commission staff is not requesting any comments or information from you. If we require anything else, you will be contacted by your assigned Candidate Registrar or the Commission's Executive Director.

### Title 21-A M.R.S.

### **Chapter 13: Campaign Finance Reports and Finances**

### Subchapter I General Provisions

### § 1012. Definitions

As used in this subchapter, unless the context otherwise indicates, the following terms have the following meanings.

. . .

### **2.** Contribution. The term "contribution:"

### A. Includes:

- (1) A gift, subscription, loan, advance or deposit of money or anything of value made for the purpose of influencing the nomination or election of any person to state, county or municipal office or for the purpose of liquidating any campaign deficit of a candidate, except that a loan of money to a candidate by a financial institution in this State made in accordance with applicable banking laws and regulations and in the ordinary course of business is not included;
- (2) A contract, promise or agreement, express or implied, whether or not legally enforceable, to make a contribution for such purposes;
- (3) Funds received by a candidate or a political committee that are transferred to the candidate or committee from another political committee or other source; and
- (4) The payment, by any person other than a candidate or a political committee, of compensation for the personal services of other persons that are provided to the candidate or political committee without charge for any such purpose; and

### **B.** Does not include:

- (1) The value of services provided without compensation by individuals who volunteer a portion or all of their time on behalf of a candidate or political committee;
- (2) The use of real or personal property and the cost of invitations, food and beverages, voluntarily provided by an individual to a candidate in rendering voluntary personal services for candidate-related activities, if the cumulative value of these activities by the individual on behalf of any candidate does not exceed \$250 with respect to any election;

- (3) The sale of any food or beverage by a vendor for use in a candidate's campaign at a charge less than the normal comparable charge, if the charge to the candidate is at least equal to the cost of the food or beverages to the vendor and if the cumulative value of the food or beverages does not exceed \$100 with respect to any election;
- (4) Any unreimbursed travel expenses incurred by an individual in the course of providing voluntary personal services to a candidate and paid for by that individual, if the cumulative amount of these expenses does not exceed \$350 with respect to any election;
- **(4-A)** Any unreimbursed campaign-related travel expenses incurred and paid for by the candidate or the candidate's spouse or domestic partner;
- (5) The payment by a party's state, district, county or municipal committee of the costs of preparation, display or mailing or other distribution of a party candidate listing;
- (6) Documents, in printed or electronic form, including party platforms, single copies of issue papers, information pertaining to the requirements of this Title, lists of registered voters and voter identification information, created, obtained or maintained by a political party for the general purpose of party building and provided to a candidate who is a member of that party;
- (7) Compensation paid by a state party committee to its employees for the following purposes:
  - (a) Providing no more than a total of 40 hours of assistance from its employees to a candidate in any election;
  - **(b)** Recruiting and overseeing volunteers for campaign activities involving 3 or more candidates; or
  - (c) Coordinating campaign events involving 3 or more candidates;
- (8) Campaign training sessions provided to 3 or more candidates;
- **(8-A)** Costs paid for by a party committee in connection with a campaign event at which 3 or more candidates are present;
- **(8-B)** Wood or other materials used for political signs that are found or contributed if not originally obtained by the candidate or contributor for campaign purposes;
- (8-C) The use or distribution of any communication, as described in section 1014, obtained by the candidate for a previous election and fully paid for during that election;

- (9) The use of offices, telephones, computers and similar equipment when that use does not result in additional cost to the provider;
- (10) Activity or communication designed to encourage individuals to register to vote or to vote if that activity or communication does not mention a clearly identified candidate; or
- (11) A purchase of apparel from a commercial vendor with a total cost of \$25 or less by an individual when the vendor has received a graphic or design from the candidate or the candidate's authorized committee.

### **3. Expenditure.** The term "expenditure:"

### **A.** Includes:

- (1) A purchase, payment, distribution, loan, advance, deposit or gift of money or anything of value made for the purpose of influencing the nomination or election of any person to state, county or municipal office, except that a loan of money to a candidate by a financial institution in this State made in accordance with applicable banking laws and regulations and in the ordinary course of business is not included;
- (2) A contract, promise or agreement, expressed or implied, whether or not legally enforceable, to make any expenditure;
- (3) The transfer of funds by a candidate or a political committee to another candidate or political committee; and
- (4) A payment or promise of payment to a person contracted with for the purpose of influencing any campaign as defined in section 1052, subsection 1; and

### **B.** Does not include:

- (1) Any news story, commentary or editorial distributed through the facilities of any broadcasting station, cable television system, newspaper, magazine or other periodical publication, unless the facilities are owned or controlled by any political party, political committee, candidate or spouse or domestic partner of a candidate;
- (1-A) Any communication distributed through a public access television channel on a cable television system if the communication complies with the laws and rules governing the channel and all candidates in the race have an equal opportunity to promote their candidacies through the channel;
- (2) Activity or communication designed to encourage individuals to register to vote or to vote if that activity or communication does not mention a clearly identified candidate;

- (3) Any communication by any membership organization or corporation to its members or stockholders, if that membership organization or corporation is not organized primarily for the purpose of influencing the nomination or election of any person to state or county office;
- (4) The use of real or personal property and the cost of invitations, food and beverages, voluntarily provided by an individual to a candidate in rendering voluntary personal services for candidate-related activities, if the cumulative value of these activities does not exceed \$250 with respect to any election;
- (5) Any unreimbursed travel expenses incurred by an individual in the course of providing voluntary personal services to a candidate and paid for by that individual, if the cumulative amount of these expenses does not exceed \$350 with respect to any election;
- (5-A) Any unreimbursed campaign-related travel expenses incurred and paid for by the candidate or the candidate's spouse or domestic partner;
- (6) Any communication by any person that is not made for the purpose of influencing the nomination for election, or election, of any person to state, county or municipal office;
- (7) The payment by a party's state, district, county or municipal committee of the costs of preparation, display or mailing or other distribution of a party candidate listing;
- (8) The use or distribution of any communication, as described in section 1014, obtained by the candidate for a previous election and fully paid for during that election campaign;
- (9) Documents, in printed or electronic form, including party platforms, single copies of issue papers, information pertaining to the requirements of this Title, lists of registered voters and voter identification information, created or maintained by a political party for the general purpose of party building and provided to a candidate who is a member of that party;
- (10) Compensation paid by a state party committee to its employees or the following purposes:
  - (a) Providing no more than a total of 40 hours of assistance from its employees to a candidate in any election;
  - **(b)** Recruiting and overseeing volunteers for campaign activities involving 3 or more candidates; or
  - (c) Coordinating campaign events involving 3 or more candidates;

- (10-A) Costs paid for by a party committee in connection with a campaign event at which 3 or more candidates are present;
- (11) Campaign training sessions provided to 3 or more candidates;
- (11-A) Wood or other materials used for political signs that are found or contributed if not originally obtained by the candidate or contributor for campaign purposes;
- (12) The use of offices, telephones, computers and similar equipment when that use does not result in additional cost to the provider; or
- (13) A purchase of apparel from a commercial vendor with a total cost of \$25 or less by an individual when the vendor has received a graphic or design from the candidate or the candidate's authorized committee.

### § 1014. Publication or distribution of political communications

- 1. Authorized by candidate. Whenever a person makes an expenditure to finance a communication expressly advocating the election or defeat of a clearly identified candidate through broadcasting stations, cable television systems, newspapers, magazines, campaign signs or other outdoor advertising facilities, publicly accessible sites on the Internet, direct mails or other similar types of general public political advertising or through flyers, handbills, bumper stickers and other nonperiodical publications, the communication, if authorized by a candidate, a candidate's authorized political committee or their agents, must clearly and conspicuously state that the communication has been so authorized and must clearly state the name and address of the person who made or financed the expenditure for the communication. A communication financed by a candidate or the candidate's committee is not required to state the address of the candidate or committee that financed the communication. If a communication that is financed by someone other than the candidate or the candidate's authorized committee is broadcast by radio, only the city and state of the address of the person who financed the communication must be stated.
- 2. Not authorized by candidate. If the communication described in subsection 1 is not authorized by a candidate, a candidate's authorized political committee or their agents, the communication must clearly and conspicuously state that the communication is not authorized by any candidate and state the name and address of the person who made or financed the expenditure for the communication, except that a communication broadcast by radio is only required to state the city and state of the address of the person that financed the communication. If the communication is in written form, the communication must contain at the bottom of the communication in

print that is no smaller in size than 12-point bold print, Times New Roman font, the words "NOT PAID FOR OR AUTHORIZED BY ANY CANDIDATE."

- **2-A. Other communications.** Whenever a person makes an expenditure to finance a communication that names or depicts a clearly identified candidate and that is disseminated during the 28 days, including election day, before a primary election, during the 35 days, including election day, before a special election or during the period of time from Labor Day to the election day for a general election through the media described in subsection 1, the communication must state the name and address of the person who made or financed the communication and a statement that the communication was or was not authorized by the candidate, except that a communication broadcast by radio is only required to state the city and state of the address of the person that financed the communication. The disclosure is not required if the communication was not made for the purpose of influencing the candidate's nomination for election or election.
- **2–B. Top 3 funders; independent expenditures.** A communication that is funded by an entity making an independent expenditure as defined in section 1019-B, subsection 1 must conspicuously include the following statement:

"The top 3 funders of (name of entity that made the independent expenditure) are (names of top 3 funders)."

The information required by this subsection may appear simultaneously with any statement required by subsection 2 or 2-A. A communication that contains a visual aspect must include the statement in written text. A communication that does not contain a visual aspect must include an audible statement. This statement is required only for communications made through broadcast or cable television, broadcast radio, Internet audio and video programming, direct mail or newspaper or other periodical publications.

A cable television, broadcast television or Internet video communication must include both an audible and a written statement. For a cable television, broadcast television or Internet video communication 30 seconds or less in duration, the audible statement may be modified to include only the single top funder.

The top funders named in the required statement consist of the funders providing the highest dollar amount of funding to the entity making the independent expenditure since the day following the most recent general election day.

- **A.** For purposes of this subsection, "funder" includes:
  - (1). Any entity that has made a contribution as defined in section 1052, subsection 3 to the entity making the independent expenditure since the day following the most recent general election day; and

- (2) Any entity that has given a gift, subscription, loan, advance or deposit of money or anything of value, including a promise or agreement to provide money or anything of value whether or not legally enforceable, except for transactions in which a fair value is given in return, since the day following the most recent general election day.
- **B.** If funders have given equal amounts, creating a tie in the ranking of the top 3 funders, the tie must be broken by naming the tying funders in chronological order of the receipt of funding until 3 funders are included in the statement. If the chronological order cannot be discerned, the entity making the independent expenditure may choose which of the tying funders to include in the statement. In no case may a communication be required to include the names of more than 3 funders.
- C. The statement required under this subsection is not required to include the name of any funder who has provided less than \$1,000 to the entity making the independent expenditure since the day following the most recent general election day.
- **D.** If only one or 2 funders must be included pursuant to this subsection, the communication must identify the number of funders as "top funder" or "top 2 funders" as appropriate. If there are no funders required to be included under this subsection, no statement is required.
- **E.** When compiling the list of top funders, an entity making an independent expenditure may disregard any funds that the entity can show were used for purposes unrelated to the candidate mentioned in the communication on the basis that funds were either spent in the order received or were strictly segregated in other accounts.
- **F.** In any communication consisting of an audio broadcast of 30 seconds or less or a print communication of 20 square inches or less, the requirements of this subsection are satisfied by including the name of the single highest funder only.
- **G.** If the list of funders changes during the period in which a recurring communication is aired or published, the statement appearing in the communication must be updated at the time that any additional payments are made for that communication.
- **H.** The commission may establish by routine technical rule, adopted in accordance with Title 5, chapter 375, subchapter 2-A, forms and procedures for ensuring compliance with this subsection. Rules adopted pursuant to this paragraph must ensure that the information required by this subsection is effectively conveyed for a sufficient duration and in a sufficient font size or screen size where applicable without undue burden on the ability of the entity to make the communication. The rules must also provide an exemption for types of communications for which the

- required statement would be impossible or impose an unusual hardship due to the unique format or medium of the communication.
- **3. Broadcasting prohibited without disclosure.** No person operating a broadcasting station or cable television system within this State may broadcast any communication, as described in subsections 1 to 2-A, without an oral or written visual announcement of the disclosure required by this section.
- **3-A.** In-kind contributions of printed materials. A candidate, political committee or political action committee shall report on the campaign finance report as a contribution to the candidate, political committee or political action committee any contributions of in-kind printed materials to be used in the support of a candidate or in the support or defeat of a ballot question. Any in-kind contributions of printed materials used or distributed by a candidate, political committee or political action committee must include the name or title of that candidate, political committee or political action committee as the authorizing agent for the printing and distribution of the in-kind contribution.
- **3-B.** Newspapers. A newspaper may not publish a communication described in subsections 1 to 2-A without including the disclosure required by this section. For purposes of this subsection, "newspaper" includes any printed material intended for general circulation or to be read by the general public, including a version of the newspaper displayed on a website owned or operated by the newspaper. When necessary, a newspaper may seek the advice of the commission regarding whether or not the communication requires the disclosure.
- 4. Enforcement. A violation of this section may result in a civil penalty of no more than 100% of the amount of the expenditure in violation, except that an expenditure for yard signs lacking the required information may result in a maximum civil penalty of \$200. In assessing a civil penalty, the commission shall consider, among other things, how widely the communication was disseminated, whether the violation was intentional, whether the violation occurred as the result of an error by a printer or other paid vendor and whether the communication conceals or misrepresents the identity of the person who financed it. If the person who financed the communication or who committed the violation corrects the violation within 10 days after receiving notification of the violation from the commission by adding the missing information to the communication, the commission may decide to assess no civil penalty.
- 5. Telephone calls. Prerecorded automated telephone calls and scripted live telephone communications that name a clearly identified candidate during the 28 days, including election day, before a primary election, during the 35 days, including election day, before a special election or during the period of time from Labor Day to the general election day for a general election must clearly state the name of the person who made or financed the expenditure for the communication and whether the communication was authorized by a candidate, except for prerecorded automated telephone calls paid

for by the candidate that use the candidate's voice in the telephone call and that are made in support of that candidate. Telephone surveys that meet generally accepted standards for polling research and that are not conducted for the purpose of influencing the voting position of call recipients are not required to include the disclosure.

- **5-A.** Text messages. Text messages sent with the assistance of mass distribution technology that is paid for by a person must clearly and conspicuously state the name of the person who made or financed the expenditure if:
  - A. The text message expressly advocates the election or defeat of a candidate; or
  - **B.** The text message contains a link to a website that expressly advocates the election or defeat of a candidate.
- **6. Exclusions.** The requirements of this section do not apply to:
  - **A.** Handbills or other literature produced and distributed at a cost not exceeding \$100 and prepared by one or more individuals who are not required to register or file campaign finance reports with the commission and who are acting independently of and without authorization by a candidate, candidate's authorized campaign committee, party committee, political action committee or ballot question committee, party committee, political action committee or ballot question committee;
  - **B.** Campaign signs produced and distributed at a cost not exceeding \$100, paid for by one or more individuals who are not required to register or file campaign finance reports with the commission and who are acting independently of and without authorization by a candidate, candidate's authorized campaign committee, party committee, political action committee or ballot question committee, political action committee or ballot question committee, political action committee or ballot question committee;
  - C. Internet and e-mail activities costing less than \$100, as excluded by rule of the commission, paid for by one or more individuals who are not required to register or file campaign finance reports with the commission and who are acting independently of and without authorization by a candidate, candidate's authorized campaign committee, party committee, political action committee or ballot question committee, party committee, political action committee or ballot question committee;
  - **D.** Communications in which the name or address of the person who made or authorized the expenditure for the communication would be so small as to be illegible or infeasible, including communications on items such as ashtrays, badges and badge holders, balloons, campaign buttons, clothing, coasters, combs, emery

boards, envelopes, erasers, glasses, key rings, letter openers, matchbooks, nail files, noisemakers, paper and plastic cups, pencils, pens, plastic tableware, 12-inch or shorter rulers, swizzle sticks, tickets to fund-raisers and similar items determined by the commission to be too small and unnecessary for the disclosures required by this section and in electronic media advertisements where compliance with this section would be impractical due to size or character limitations; and

**E.** Campaign signs that are financed by the candidate or candidate's authorized committee and that clearly identify the name of the candidate and are lettered or printed individually by hand.

### § 1015. Limitations on contributions and expenditures

1. Contributions by individuals. An individual may not make contributions to a candidate in support of the candidacy of one person aggregating more than \$1,950 in any election for a gubernatorial candidate, more than \$475 for a legislative candidate, more than \$575 for a candidate for municipal office and more than \$975 in any election for any other candidate. This limitation does not apply to contributions in support of a candidate by that candidate or that candidate's spouse or domestic partner. Beginning December 1, 2024, contribution limits in accordance with this subsection are adjusted every 2 years based on the Consumer Price Index as reported by the United States Department of Labor, Bureau of Labor Statistics and rounded to the nearest amount divisible by \$25. The commission shall post the current contribution limit and the amount of the next adjustment and the date that it will become effective on its publicly accessible website and include this information with any publication to be used as a guide for candidates.

### **2.** [Repealed]

### **2-A.** [Repealed]

**2-B. Committees; corporations; associations.** A political committee, political action committee, ballot question committee or other committee, firm, partnership, corporation, association or organization may not make contributions to a candidate in support of the candidacy of one person aggregating more than \$1,950 in any election for a gubernatorial candidate, more than \$475 for a legislative candidate, more than \$575 for a candidate for municipal office and more than \$975 in any election for any other candidate. Beginning December 1, 2024, contribution limits in accordance with this subsection are adjusted every 2 years based on the Consumer Price Index as reported by the United States Department of Labor, Bureau of Labor Statistics and rounded to the nearest amount divisible by \$25. The commission shall post the current contribution limit and the amount of the next adjustment and the date that it will become

effective on its publicly accessible website and include this information with any publication to be used as a guide for candidates.

### **3.** [Repealed]

4. Political committees; intermediaries. For the purpose of the limitations imposed by this section, contributions made to any political committee authorized by a candidate to accept contributions on the candidate's behalf are considered to be contributions made to that candidate. If the campaign activities of a political action committee within a calendar year primarily promote or support the nomination or election of a single candidate, contributions to the committee that were solicited by the candidate are considered to be contributions made to the candidate for purposes of the limitations in this section. For purposes of this subsection, solicitation of contributions includes but is not limited to the candidate's appearing at a fundraising event organized by or on behalf of the political action committee or suggesting that a donor make a contribution to that committee.

For the purposes of the limitations imposed by this section, all contributions made by a person, either directly or indirectly, on behalf of a particular candidate, that are in any way earmarked or otherwise directed through an intermediary or conduit to the candidate are considered to be contributions from that person to the candidate. The intermediary or conduit shall report the original source and the intended recipient of the contribution to the commission and to the intended recipient.

**5. Other contributions and expenditures.** Any expenditure made by any person in cooperation, consultation or concert with, or at the request or suggestion of, a candidate, a candidate's political committee or their agents is considered to be a contribution to that candidate.

The financing by any person of the dissemination, distribution or republication, in whole or in part, of any broadcast or any written or other campaign materials prepared by the candidate, the candidate's political committee or committees or their authorized agents is considered to be a contribution to that candidate.

- **6. Prohibited expenditures.** A candidate, a treasurer, a political committee, a party or party committee, a person required to file a report under this subchapter or their authorized agents may not make any expenditures for liquor to be distributed to or consumed by voters while the polls are open on election day.
- 7. Voluntary limitations on political expenditures. A candidate may voluntarily agree to limit the total expenditures made on behalf of that candidate's campaign as specified in section 1013-A, subsection 1, paragraph C and subsections 8 and 9.
- **8. Political expenditure limitation amounts.** Total expenditures in any election for legislative office by a candidate who voluntarily agrees to limit campaign expenditures as provided in subsection 7 are as follows:

- A. For State Senator, \$25,000; and
- **B.** For State Representative, \$5,000.
- C. [Repealed]

Expenditure limits are per election and may not be carried forward from one election to another. For calculation and reporting purposes, the reporting periods established in section 1017 apply.

**9. Publication of list.** The commission shall publish a list of the candidates for State Representative and State Senator who have agreed to voluntarily limit total expenditures for their campaigns as provided in section 1013-A, subsection 1, paragraph C.

For the purposes of subsections 7 and 8 and this subsection, "total expenditures" means the sum of all expenditures made to influence a single election that are made by a candidate or made on the candidate's behalf by the candidate's political committee or committees, the candidate's party or the candidate's immediate family.

### **Subchapter IV**

### **Reports by Political Action Committees and Ballot Question Committees**

### § 1052. Definitions

As used in this subchapter, unless the context otherwise indicates, the following terms have the following meanings.

- 1. Campaign. "Campaign" means any course of activities to influence the nomination or election of a candidate or to initiate or influence any of the following ballot measures:
  - **A.** A people's veto referendum under the Constitution of Maine, Article IV, Part Third, Section 17;
  - **B.** A direct initiative of legislation under the Constitution of Maine, Article IV, Part Third, Section 18;
  - C. An amendment to the Constitution of Maine under Article X, Section 4;
  - **D.** A referendum vote on a measure enacted by the Legislature and expressly conditioned upon ratification by a referendum vote under the Constitution of Maine, Article IV, Part Third, Section 19;
  - E. The ratification of the issue of bonds by the State or any agency thereof; and
  - **F.** Any county or municipal referendum.
- **2. Committee.** "Committee" means any political action committee or ballot question committee and includes any agent of a political action committee or ballot question committee.
- **2-A.** Ballot question committee. "Ballot question committee" means a person that receives contributions or makes expenditures aggregating in excess of \$5,000 for the purpose of initiating or influencing a campaign, other than a campaign for the nomination or election of a candidate. The term "ballot question committee" does not include a political action committee or an exempt donor.
- **3. Contribution.** "Contribution" includes:
  - **A.** A gift, subscription, loan, advance or deposit of money or anything of value made to or received by a committee for the purpose of initiating or influencing a campaign, including but not limited to:

- (1) Funds that the contributor specified were given, in whole or in part, in connection with a campaign;
- (2) Funds provided in response to a solicitation that would lead the contributor to believe that the funds would be used specifically, in whole or in part, for the purpose of initiating or influencing a campaign; and
- (3) Funds that can reasonably be determined to have been provided by the contributor for the purpose of initiating or influencing a campaign when viewed in the context of the contribution and the recipient committee's activities regarding a campaign;
- **A-1.** Any funds deposited or transferred into the campaign account described in section 1054;
- **B.** A contract, promise or agreement, expressed or implied whether or not legally enforceable, to make a contribution to a committee;
- C. Any funds received by a committee that are to be transferred to any candidate, committee, campaign or organization for the purpose of initiating or influencing a campaign; or
- **D.** The payment, by any person or organization, of compensation for the personal services of other persons provided to a committee that is used by the committee to initiate or influence a campaign.

"Contribution" does not include a loan of money by a financial institution made in accordance with applicable banking laws and regulations and in the ordinary course of business.

- **3-A.** Exempt donor. "Exempt donor" means a person that has not received contributions for the purpose of influencing a campaign in the prior 2 years and whose only payments of money to influence a campaign in the prior 2 years are:
  - **A.** Contributions of money to candidates, party committees, political action committees or ballot question committees registered with the commission or a municipality; or
  - **B.** Payments for goods or services with an aggregate value of no more than \$100,000 contributed to candidates, party committees, political action committees or ballot question committees registered with the commission or a municipality.

### **4. Expenditure.** The term "expenditure":

### A. Includes:

(1) A purchase, payment, distribution, loan, advance, deposit or gift of money or anything of value, made for the purpose of initiating or influencing a campaign;

- (1-A) Any purchase, payment, distribution, loan, advance, deposit or gift of money made from the campaign account described in section 1054;
- (2) A contract, promise or agreement, expressed or implied, whether or not legally enforceable, to make any expenditure for the purposes set forth in this paragraph; and
- (3) The transfer of funds by a political action committee to another candidate or political committee; and

### **B.** Does not include:

- (1) Any news story, commentary or editorial distributed through the facilities of any broadcasting station, cable television system, newspaper, magazine or other periodical publication, unless these facilities are owned or controlled by any political party, political committee, candidate or the spouse or domestic partner of a candidate;
- (2) Activity designed to encourage individuals to register to vote or to vote, if that activity or communication does not mention a clearly identified candidate;
- (3) Any communication by any membership organization or corporation to its members or stockholders, if that membership organization or corporation is not organized primarily for the purpose of influencing the nomination or election of any person to state or county office;
- (4) The use of real or personal property and the cost of invitations, food and beverages, voluntarily provided by a political action committee in rendering voluntary personal services for candidate-related activities, if the cumulative value of these activities by the political action committee on behalf of any candidate does not exceed \$250 with respect to any election;
- (5) Any unreimbursed travel expenses incurred and paid for by a political action committee that volunteers personal services to a candidate, if the cumulative amount of these expenses does not exceed \$100 with respect to any election;
- (6) Any communication by a committee that is not made for the purpose of influencing the nomination or election of any person to state or county office; and
- (7) Any payments to initiate a people's veto referendum or the direct initiative of legislation made prior to the submission of an application to the Department of the Secretary of State as provided in section 901.

# Title 21-A M.R.S. Chapter 14: Maine Clean Election Act

### § 1125. Terms of participation

. . .

6. Restrictions on contributions and expenditures for certified candidates. After certification, a candidate must limit the candidate's campaign expenditures and obligations, including outstanding obligations, to the revenues distributed to the candidate from the fund and may not accept any contributions unless specifically authorized by the commission. Candidates may also accept and spend interest earned on fund revenues in campaign bank accounts. All revenues distributed to a certified candidate from the fund must be used for campaign-related purposes. The candidate, the treasurer, the candidate's committee authorized pursuant to section 1013-A, subsection 1 or any agent of the candidate and committee may not use these revenues for any but campaign-related purposes. The candidate, the treasurer, the candidate's committee authorized pursuant to section 1013-A, subsection 1 or any agent of the candidate and committee may not use these revenues for post-election parties. This section does not prohibit a candidate from using personal funds for post-election parties as governed by rules of the commission. The commission shall publish guidelines outlining permissible campaign-related expenditures.

### 94-270 COMMISSION ON GOVERNMENTAL ETHICS AND ELECTION PRACTICES

**Chapter 1: PROCEDURES** 

### SECTION 6. CONTRIBUTIONS AND OTHER RECEIPTS

. . .

- 4. Unless specifically exempted under Title 21-A M.R.S.A. §§ 1012 and 1052 or this section, the provision of any goods or services without charge or at a charge that is less than the usual and customary charge for such goods or services is an in-kind contribution. Examples of such goods and services include, but are not limited to: equipment, facilities, supplies, personnel, advertising, and campaign literature. If goods or services are provided at less than the usual and customary charge, the amount of the in-kind contribution is the difference between the usual and customary charge and the amount charged the candidate or political committee.
  - A. A commercial vendor that has provided a discount to a candidate or political committee because of a defect in performance or other business reason has not made a contribution if the vendor grants substantially similar discounts to other customers in the ordinary course of the vendor's business.
  - B. If a candidate is a public official who is provided a vehicle for transportation by a public entity for the purpose of conducting official duties, the use of such vehicle for campaign purposes is considered to be an in-kind contribution to the candidate from the public entity unless the candidate reimburses the public entity for the use of the vehicle.
