STATEMENT DUE BY JANUARY 17, 2025

1. GO TO WWW.MAINECAMPAIGNFINANCE.COM AND CLICK ON THE  BUTTON IN THE UPPER RIGHT-HAND CORNER OF THE SCREEN AND SIGN IN WITH YOUR SOSOI USERNAME AND PASSWORD. ONCE LOGGED IN ENSURE YOU ARE ON THE CORRECT SITE BY CONFIRMING THE PURPLE ETHICS DISCLOSURE BANNER IS DIRECTLY BENEATH THE URL. IF THIS IS NOT PRESENT, YOU HAVE LOGGED IN WITH YOUR CAMPAIGN FINANCE CREDENTIALS, AND WILL NEED TO LOGIN WITH YOUR SOSOI INFORMATION TO ACCESS THIS SITE.
