Any <u>single</u> contribution of \$5,000 or more or any <u>single</u> expenditure of \$1,000 or more must be reported as set forth below.		
Reporting Period	Filing Deadline (11:59 p.m.)	
February 11- February 24, 2025 (5 p.m.)	Within 24 hours of receiving contribution or making expenditure	
<b>Independent Expenditure (IE) Reports</b>		
An expenditure in excess of \$250 for a communication that expressly advocates the election or defeat of a clearly identified candidate and is made independent of the candidate, the candidate's authorized committee, or the candidate's or committee's agents must be reported as set forth below.		
Name of Report	Reporting Timeframe	Filing Deadline (11:59 p.m.)
2-Day Pre-Election IE Report	December 27, 2024 – February 11, 2025	Within 2 calendar days of expenditure
1-Day Pre-Election IE Report	February 12 - 25, 2025	Within 1 calendar day of expenditure

<b>Any <u>single</u> contribution of \$5,000 or more or any <u>single</u> expenditure of \$1,000 or more must be reported as set forth below.</b>	
Reporting Timeframe	Filing Deadline (11:59 p.m.)
February 11 - February 24, 2025 (5 p.m.)	Within 24 hours of receiving contribution or making expenditure

<b>Independent Expenditure (IE) Reports</b>		
<b>An expenditure in excess of \$250 for a communication that expressly advocates the election or defeat of a clearly identified candidate and is made independent of the candidate, the candidate’s authorized committee, or the candidate’s or committee’s agents must be reported as set forth below.</b>		
Name of Report	Reporting Timeframe	Filing Deadline (11:59 p.m.)
2-Day Pre-Election IE Report	December 27, 2024 – February 11, 2025	Within 2 calendar days of expenditure
1-Day Pre-Election IE Report	February 12 - 25, 2025	Within 1 calendar day of expenditure
