Any single contribution of \$5,000 or more received or single expenditure of \$1,000 or more made by a committee during the Reporting Period must be reported no later than 11:59 p.m. on the following calendar day.

February 11 - February 23, 2026		
Independent Expenditure (IE) Reports*		
A public communication costing more than \$250 that clearly identifies a candidate, advocates for their election or defeat, was made independently of them and their political committee, and agents of either, must be reported.

2-Day Pre-Election IE	December 26, 2025 – February 10, 2026	Within 2 calendar days of expenditure
1-Day Pre-Election IE	February 11 - 23, 2026	Within 1 calendar day of expenditure

Any single contribution of \$5,000 or more received or single expenditure of \$1,000 or more made by a committee during the Reporting Period must be reported no later than 11:59 p.m. on the following calendar day.

A public communication costing more than \$250 that clearly identifies a candidate, advocates for their election or defeat, was made independently of them and their political committee, and agents of either, must be reported.
