Initial Campaign Finance Reports		
All new committees must file an Initial Report within 7 days of registration or within 14 days of when they exceeded \$2,500 (for PACs) or \$5,000 (for BQCs) in financial activity. For PACs, the Initial Report covers all activity from the beginning of the year through the date of registration. For BQCs, the Initial Report covers all activity from the beginning of the campaign through the date of registration.

For expenditures, orders placed with or obligations made to vendors are considered expenditures at the time the orders or obligations are made. Overhead expenditures, such as rent, taxes, utilities, and some salary payments are not required to be reported.
