Re: Ballot Initiatives on Disclosure Website

Please accept this informational memorandum as an explanation for how the Maine Ethics Commission's campaign finance website handles ballot initiatives relative to Clean Energy Matters' waiver request. Specifically, in the PAC's waiver request, the PAC indicates that "the Commission itself has not separated the first NECEC initiative from the second in terms of the information that is made available to the public." The Commission staff disagrees.

When a PAC discloses an expenditure to support or oppose a ballot question, the PAC must select the specific question from a drop-down list on the data entry screen. The campaign finance website treats each ballot initiative as a separate and distinct entity in the system. Once the Commission staff received the language for the second NECEC initiative from the Secretary of State, we created a distinct initiative in the system. The snippets below show the total spending to support and oppose the two NECEC-related initiatives:

No expenditures to support or oppose the second NECEC initiative have been reported yet. Those are expected for the reports due April 12, 2021. As you can see, the two resolves are treated separately, have their own information, and tallies of information. The Committees can now select NECEC II instead of NECEC I for reporting their expenditures. The Committees have also amended their registrations to reflect their work on NECEC II.

Regarding reports filed by the Committees, the reports would be side by side, but each expenditure would list which initiative the expenditure was made for:
