# Listening Session Summary: Stonington

## Prior adaptation efforts:

- January 2024 storms exceeded sea level rise projections Stonington had prepared for

## Working waterfront infrastructure damage:

- Only two days between storms to assess damage, prevent further loss
- Private wharves at risk of selling due to insurmountable damage, loss of critical working waterfront


# Listening Session Summary: York County

## During storms:

- Rescue teams encountered fast rising storm surge, electrical fires, lack of personnel
- Flooded roads & pump stations

## Post storm damage:

- Severe loss of Old Orchard Beach sand dunes, 5 feet of beach sand
- Camp Ellis has lost approximately 38 homes over the past 60 years

# Commission Topics

**1. *Avoiding the unmanageable* – recommendations to mitigate disaster risks and avoid future damages through:**

- a. flood plain management,
- b. building codes,
- c. infrastructure design standards, and
- d. insurance

**2. *Managing the unavoidable* – recommendations for resilient disaster recovery and rebuilding in the future through:**

- a. Hazard mitigation and communication
- b. planning,
- c. permitting,
- d. capacity, and
- e. funding

**3. *Keeping the lights on* – recommendations for:**

- a. reducing electric grid outages and delivered fuel interruptions,
- b. mitigating the impact of outages for people and businesses during and after disasters

**4. *Sustaining community infrastructure* – recommendations for long-term protection of vital community and economic infrastructure including working waterfronts from natural disasters, redevelopment, and disrepair**

**5. *Leveraging strategic partnerships* – recommendations for expanding the role of capital markets and philanthropy in disaster recovery**

**6. *Maximizing use of existing funding* – recommendations for addressing gaps in disaster recovery support and funding for infrastructure adaptation**
