- 4. Executive Director Report Joe Young
 - a. Membership Update
 - i. Bill Hanson has been appointed, but needs to be sworn in
 - ii. Brian Guerrette has been appointed to represent the CIO
 - iii. Betsy Fitzgerald's paperwork is still in process
 - iv. Jon Giles has been appointed and sworn in
 - b. Data Acquisition Projects
 - i. NHD Survey going on that Dan is coordinating.
 - ii. NSGIC Winter Meeting (National States Geospatial Information Council)
 - Arkansas has moved all their geospatial data into a cloud distribution system and claiming thousands of dollars per year in savings. Something we may want to look into.
 - Several states are moving toward a coordinated road centerlines.
 - Senator Orin Hatch of Utah will be introducing a Geospatial Data Act to formalize the coordination and acquisition of Geospatial data acquisition. Currently the only oversight has been done through presidential executive orders lacking any congressional requirements.
 - iii. USGS LiDAR Acquisition
 - CFRU and Joe are working with USGS and other agencies to put develop a plan to present to the CFRU membership at their meeting in April. The discussion has focused on leaf off vs. leaf on collect. For USGS the result must be data acquisition meeting QL2 standards.
 - A Joint Funding Agreement with USGS for the collection of LiDAR data in 2015 year has been signed with acquisition planned for this spring.
 - iv. 2015 Orthoimagery
 - The work orders have been developed for this years acquisition and will begin as soon as snow is gone this spring
 - The 2016 project will include Franklin and Somerset counties
 - Fairfield and Wilton have inquired about participating in 2016 already.
 - v. GIS Manager posting has closed, reviewing applications, will set up interviews shortly.
- 5. Annual Report to Legislative Committees
 - a. Corrections recommended
 - i. Section 2, Executive Summary, line 5 should it be 1 m or 2 m? 1 m is standard.
 - ii. Next page, 2nd paragraph, last two lines include 22 new communities and 28 updated communities.
 - iii. Bottom of the page about Land Use Code emphasize that use of STATE land use codes is voluntary.

- iv. Section 5, Financial Expenditures parcel mapping contributions should be \$0. Add footnote: Parcel mapping may also have come from data volunteered by municipalities.
- v. Executive Summary include a table of data that's been maintained or acquired, near the expenditures table in the chart. Perhaps add a table below the Data Acquisition table to show square miles of area covered and square miles of areas maintained. It was decided to add this to next year's report and not include this time since the narrative of information included on the next page covers it for this year.
- vi. Small typo on page 7 Electronic Gateway; change and to an
- vii. Instead of just a definition, it would be good to include an explanation of what LiDAR is. A suggestion was made to create a 1-page document about LiDAR to provide more detail to the committee. It was noted there is an existing document that has orthoimagery and LiDAR on it that might be used. Alina had a copy of some additional materials and shared it with Patrick
- viii. Include the 3 maps in the Data Development section as full pages in the Appendix.
