  - a. <u>Coordination & Communication</u> Joe Young
    - i. Annual report one pager, need new one
    - Still looking for a chair Jon and Joe should talk about a charter of what each committee should be doing, to help determine time needed for each committee. Betsy and Joe to discuss later.
  - b. <u>Education & Training</u> Cathleen McAnneny, PhD/Vinton Valentine, PhD
    - i. Will get update at next meeting as Vinton was unable to attend today.
  - c. <u>Geospatial Data</u> Dan Walters/Joe Young
    - i. Parcel Data Standards
      - Jon, Aaron and Joe met with Anji to review existing PDS, began discussing other items such as level of accuracy when looking at parcel mapping, adding deliberate attribute value. Send suggestions or comments to Joe, Jon or Aaron. Hoping to have a draft in the near future for people to comment on – hopefully by the end of summer. They will also compare it to other state standards.
      - 2. People will look at a tax map and initially expect that it's survey accurate.
      - 3. Any way to beef up the disclaimer (from a hosting level)? Joe has one from Vinton a few months ago and will look at that as well as the last one recommended by the GeoParcel workgroup.
      - Community Guided Planning and Zoning in Aroostook County, Washington County, and Western Mountains is likely to make changes to zoning. Organized town data does not include zoning data, but the unorganized territory viewer does include it
    - ii. <u>1970's Aerial Imagery Nate</u>
      - MDOT has some high resolution imagery from areas all over the state. Looking to see who might have some interest in the information. Some have 2 copies. Any interest by GeoLibrary to house it? Would like to keep the information together. Dave Edson stated there are currently models to digitally image info and to make it available to others. It's important to preserve this old data. Want to keep it, index it and make the index available.
        - a. Has anyone talked to Archives? Not yet. Need to be able to find the index in order to use the collection.
        - b. Contact at archives, from Maria Tammy?

- c. Not offering up MDOT resources to prepare this information.
- d. May be a library type role for the GeoLibrary to keep the index, direct more to archives. Does the GeoLibrary want to step into a long-term role?
- e. Nate: There is interested, need to keep it, need to put together an index and contact Archives.
