- 2. Executive Director Report Joe Young
 - a. Project Reports
 - i. Joe distributed LiDAR and Imagery report.
 - 1. Lidar
 - a. CFRU status is now MOA Signed.
 - b. Joe did presentation to Barbara Wheatland Lab in Orono, where a few large landowners were in attendance. There is a possibility they may join us, which could increase it to a \$2M project and nearly 10K square miles. Both landowners are in their budget planning for 2017 right now.
 - c. FEMA, USGS, NRCS agreements have been signed to collect LiDAR in northern Oxford and Franklin counties filling in the gap left by the GeoLibrary's 2016 acquisition. Acquisition is scheduled to begin as soon as leaves drop and before snow falls.

 - a. Discussion took place about the strategy and target audiences. Joe handed out some drafts of "OneMap for ME" information sheets, which the group reviewed together and suggested edits.

 - iii. University Chancellor Vinton met with Jim Page over summer and Jim is still supportive. He will take forward for us anything for the bond as it relates to System needs.

 - i. Committee hasn't met since June, but worked to put together Orthoimagery RFP. Plan to meet in October to discuss Land cover data partnership with NOAA. Will also begin discussions of 1:4800 scale mapping.
 - Orthos RFP hope to have decision by first week of October, 2nd week at the latest. 4 vendors submitted proposals and they are currently being reviewed.
 York and Cumberland will be the focus of first year of flights.
