 - i. Derek Gorneau shared a high-level overview of current funding
 - 1. 013 funding is federal grant money
 - 2. 014 funding is special revenue, money collected from municipalities and counties
 - a. Derek to share document with group
 - ii. Brian gave presentation on GIS rates
 - 1. Brian to share slides with group

 - i. No report
- c. Policy Committee –Vinton Valentine
 - i. Jon found old copy of RFP for Strategic Plan

3. Executive Director Report – Claire Kiedrowski

- a. Board Members Update
 - i. Brian is waiting to hear back from Dept. of Economic and Community Development Commissioner, has a few potential names for a board appointee
 - ii. Nate and Betsy haven't heard anything on their Governor-appointed seats
 - iii. Brian Lippold wants to step down, so we should get this into the Governor's queue

- iv. Letter of recommendation for Sarah Haggerty has been sent to House Speaker
- v. Ken Murchison and Rosemary Mosher are interested in joining the board.

b. Project Reports

- i. LiDAR
 - 1. Crown of Maine (2018-2019) Update
 - a. All the data was delivered to USGS in the middle of April, and the contract with USGS has been extended to November 15, 2020. USGS has expressed a desire for no more contract extensions if possible.
 - 2. Status on 2' Contours Development
 - a. Quantum Spatial is working on the 2-foot contour work order to address quality issues identified earlier in the year with a lack of hydrographic breaklines. Tentative availability may be by July 1, 2020; Quantum has expressed an intent to have the data delivered by Memorial Day, but Claire has asked to see the data to verify before it's delivered.2020
 - 3. Southern Coast of Maine Project (2020)
 - a. flights have begun to collect coastal southern Maine LiDAR data as part of the USGS award. Once that project area is flown, Claire will push for the 2-foot contour collection being developed by Quantum.

ii. Orthoimagery

- 1. 2020 Spring Program
 - a. Flown April 23 and April 25. All imagery has been processed and passed QA/QC.

iii. Land Cover

- 1. Land cover remains on the back burner, but Claire is meeting with Wheatland Labs to look at survey responses and to discuss developing funding options considering the current budget situation with the state response to COVID-19.
- 2. Funding must be 1:1 match.
- 3. Jon asks if the State's southern two counties (which were scheduled to be developed as a demonstration effort) been completed and publicly released? Claire: no update on this.

 - iv. NRCS and USGS are updating SeaSketch to show what they want to have done, including the coast of Maine and portions inland
 - 1. SeaSketch is community website for government agencies to identify their Areas of Interest, in this case for LiDAR acquisition. Publicly available.
