  - a. Tony reviewed the GeoLibrary's financial report, which is projected through 6/30/2023.

  - a. Brian reviewed the slide deck, which looked at website traffic, email requests, location of request (based on IP address), etc.
  - b. Clarence let everyone know that the OGC services have all be republished.
- 4. Land Cover Projects Jamie Carter (NOAA), Kasey Legaard (UMaine's GeoIntelligent Solutions)
  - a. Informal Question & Answer
    - i. NOAA: 1-meter state-wide Coastal Change Analysis Program (C-CAP)
      - 1. Salt marsh habitat do you go further asea in any of your efforts in terms of biomass being sequestered in what's essentially open water?
      - 2. Submerged aquatic vegetation? Not in Maine, but other states. We've been working with DEP to help them with this.
    - ii. UMaine: 10-meter detailed forestry map; carbon map
      - 1. Fungal biomass in the forest will there be any attempt to included that in any sequestration models?
        - a. Probably best answered by someone else. For mapping project, we only have biomass for live trees.
      - 2. If the state decides that your carbon sequestration model is something that needs to go forward with incentive or regulatory activities attached to it, what kind of temporal redoing of your

database is going to be necessary to accommodate such an activity at the state level?

- a. Not the person to answer this. An annual update process is certainly doable though.

    - ii. 2022 South Central LiDAR all captured as of 4/21/22, QC in progress.

    - ii. Storymap updated
    - iii. Orthophoto Schedule updated with delivery in December.
