 - a) Correction to clarify land cover project for UMaine under Executive Director's report.
 - b) Motion to approve the amended minutes of the December 14, 2022, meeting made by Aaron Weston, seconded by Nate Kane.

- 3. "State Hazard Mitigation Plan 2023 Update" Samuel Roy, Natural Hazards Planner, MEMA
 - a) Plan's goal is to mitigate effects of natural hazards, such as storms, flooding, etc.
 - b) MEMA is required to use "Best Available" data and assessments for creating risk assessments.
 - c) Questions & Comments:
 - i) Is Maine Risk Map public?
 - (1) Yes, it is. <u>https://maine.maps.arcgis.com/apps/mapviewer/index.html?webmap=eb8ec0935ce544dbaa80</u> <u>aec18c8db785</u>
 - ii) Claire can share the presentation slides to anyone who would like them following the meeting.

 - iv) Would MEMA be interested in participating in Orthoimagery acquisition around the state again?(1) We use that information a lot, so we would want to participate.
 - v) How much of a problem is the gap in any data that exists for the communities you're reaching out to, particularly on the organized town side of coverage?
 - (1) I'm not sure how accurate it is, or sometimes there is no data available. Ideally, I would love to have full coverage because we try to analyze on an individual building footprint or parcel basis. Then we can sort of aggregate that up to a level that ensures privacy of homeowners and things like that. If more comprehensive data is available, it will be more beneficial to the state and communities.

- vi) Where is the greatest need in the sense of parcel mapping? Organized or unorganized towns?
 - (1) There would be a priority for areas with greater population density. Because we now have resources that give us FEMA's definition of what a disadvantaged community is, if there's an overlap between lack of parcel data in those areas, then those would probably be a higher priority as well. Also weighing their interest in applying for funding as well.
- vii) Does MEMA approach the relationship with town level civil divisions differently in the organized and unorganized parts of the State? For instance, do they go to the county in the unorganized where they may go directly to the town in the organized?
 - (1) No, we normally follow the same process anywhere, generally working closely with the counties.
- viii) Knox County was attempting to maintain or gather parcel mapping. Leticia, Sam, is there any update on this?
 - (1) Leticia: Still a work in progress, but we should revisit it this year.
- ix) What are you using for building footprints and is that something we need or the address points that E911 uses that serve as a proxy?
 - (1) Microsoft building footprints have been the best I've seen for the locations I've tested. Also looking at tracking development trends and there are multiple ways this can be done.
- x) Are there particular collections programs that maybe the GeoLibrary or other university groups could be thinking about to support these needs?
 - (1) One thing that has been talked about a bit is the need for pre-disaster imagery. Not necessarily just Orthoimagery, but it could be land-based imagery that is geolocated.
- xi) Do you have Jon Rice's 911 address points, updated last year? If you need more information, touch base with Jon Rice.
 - (1) Yes, I accessed that information in Fall 2022.
