- 2. Meeting minutes of January 18, 2023 Leticia vanVuuren
 - a) Motion to approve the minutes of the January 18, 2023, meeting made by Nate Kane, seconded by Greg Copeland.
 - i) Voted: 11 Yea 0 Nay 1 Abstained Katie Bernhardt
- 3. "Messaging Update" Andrew Fox, Senior Project Manager, Timmons Group
 - a) Goal is to develop materials to support the messaging of the plan to pursue sustainable funding.
 - b) Used list of important issues from the Governor's website to help give examples of how this information can be used to help trying to solve those issues.
 - c) Sarah Environmental Issues are another good talking point
 - i) PFAs, Renewable Energy, Solar, On-Shore Wind, Off-Shore Wind
 - d) Katie do we have any concrete examples of how our stakeholders are using the GeoLibrary data?i) Working to bolster metrics and give concrete numbers around usage.
 - e) Brian we know what data sets are being used, but we can't determine who is using them or how.
 - f) Maine Geospatial Institute, Maine GIS User Group, Maine Office of GIS and GeoLibrary Board got together to create some marketing and community outreach information to show why GIS is important, including a Storymap and Tri-fold brochure
 - g) Greg Governor's speech about budget last night do we have any part of the infrastructure funding she talked about?
 - i) Brian there are three line items in the Governor's budget.
 - (1) Funds for State agencies to use for data acquisition; not directly related to the board.
 - (2) Provide funding for an Executive Director and Systems Analyst to support the board.
 - (3) Funding for the board to use for data acquisition.
 - h) Joe emphasize that "the GIS data is the infrastructure under the infrastructure" in bullet two of messaging. The better the GIS data, the better the infrastructure will be. Also, libraries have checkout procedure, so it doesn't have to impact the personal identity, but there should be a method for the library to keep track of who is using the data that the library is providing.
 - i) Clarence determining who is using the data is a pick list item for the next quarter.
