
"Strategery"

A living process managed yearly.


"The Strategic Plan" (as a noun)

Fixed in Time-5 Year Cycle?




The Program Plan (as a verb)


Orthophotography

1 -Provide recent (< 5 years old), high resolution (</= 12-inch resolution), 4 band orthographic aerial imagery for the full area of the State of Maine

Budget Amount -\$100K annual +/- 25%

2 -Provide a flexible path to State, County, or Local jurisdictions that allows for the purchase of higher resolution imagery (</= 6-inches), Historical Imagery, Obliques, On-line access.

Budget Amount = +\$100K annual +/- 25%



LiDAR (Elevation)

3 -Provide LiDAR for the Western Mountains as per our JFA and SOW with USGS.\$250K against a total of \$466,981.13 (2-year deliverable)

4 - "Sew" the existing Digital Elevation Models (DEMs) to provide a seamless statewide DEM. \$25,000 +/- 100%.

5 -Bathymetry data for the full coast will be collected from public sources and developed as budgets allow.

Parcels and Land Mapping

6 -Kick-off a Parcel Project in conjunction with the MRS and LUPC for a feasibility study of building a parcel data set for the Unorganized Territories.

\$25,000.00 for contractual services




Land Cover (Environmental)

7 - Continue to partner with NOAA on the development and release of high-resolution landcover data. Focus on wetland data development.

\$25,000.00 +/- 10%

No specifics yet, requires discussion with NOAA



Web Site

8 -Upgrade the GeoLibrary web site to reflect current standards for web development and geospatial portals. Update content and improve functionality across several classes of service. Build in a "conference room" and collaborative environment for Board usage as part of the web site.

\$50K +/- 25% Covers additional developer and social media contract.

What's NOT in the plan?


Administrative Overhead – things like Marketing communications expenses to facilitate the Buy-Up Process and a Road Show to take it to the Counties.
