As of November 1, 2017, all guide applicants must complete a background check. To start the fingerprint process, visit https://me.ibtfingerprint.com or call 1-855-667-7422 and select "Schedule a New Appointment." The applicant then must select "Maine Inland Fisheries and Wildlife Guide License" and follow the instructions. After having fingerprints taken, the applicant will need to wait 30 days before submitting a completed application to the Department.

Non-Residents (only) will need to print blank fingerprint cards from the following link https://www.fbi.gov/file-repository/standard-fingerprint-form-fd-258-1.pdf/view. Nonresidents will then need to make an appointment with their local police department or state police agency to have their fingerprints taken. Once their fingerprints are taken they must mail the fingerprint cards to the address provided on the IdentoGO website (this is shown at the time of registration. After having fingerprints taken, the applicant will need to wait 30 days before submitting a completed application to the Department.

Note: Applicants that have underlying issues with their background check will receive a letter from the Bureau of Warden Service.
