PURPOSE

Recent data indicates that the abundance of togue under 23 inches is increasing. It is suspected that this increase has placed additional pressure on the smelt population and in turn affected growth and condition of landlocked salmon. PURPOSE

This request was precipitated from three consecutive years of fall drought conditions, resulting in lower flows and warmer water in the fall. Thus, salmon have migrated into the stream later in October than usual, resulting in a shorter fall fishing season. REGULATION CHANGE DESCRIPTION

Change the 150' General Law fishway restriction to only restrict fishing in or from the fishway. Add/remove additional text for law book consistency.

PURPOSE

Churchill Dam was reconstructed in 1997 to better manage water levels in the lakes above and flows in the river below for recreation and habitat improvements. Churchill Dam is a major access point for the Allagash Wilderness Waterway with a significant amount of angling; several campsites are available for overnight stays. This proposal would remove the General Law restriction prohibiting fishing within 150 feet of the fishway. Since the dam was rebuilt, the outlet pool has seen physical changes and the current general law unnecessarily limits fishing opportunity.

Proposed deletion in second bullet: Round Pond is already listed in the law book and referencing it in this regulation is redundant.

Delete: S-26

Add: Daily bag limit on togue: 6 fish; no minimum length limit; only 1 may exceed 23 inches.

Note: This water is also proposed to retain the use of live fish as bait under a previous regulations packet, the results of which have not yet been determined.

PURPOSE

Eagle Lake supports a highly important sport fishery. It has excellent habitat for coldwater fishes with abundant deep, well-oxygenated water that is best known for producing large togue. Togue 10 lbs or larger are caught each year with fish over 20 lbs caught every few years. Eagle Lake also supports popular wild landlocked salmon and brook trout fisheries. For at least 30 years, balancing the lake's fisheries for togue and salmon with the principal forage, rainbow smelt, has been problematic. Both predators are wild and become over-abundant when harvest in the fishery declines. Salmon remain very abundant in the lake and there is currently an experimental salmon regulation in place to encourage harvest. Recent sampling suggests that the togue population has also increased. In an effort to achieve a balance between predators and prey, a liberalized togue regulation is proposed.

Add: S-19, only 1 brook trout may exceed 14 inches.

PURPOSE

Ferguson Pond is a known producer of size quality brook trout. However, recent sampling indicates average length of age 3 brook trout has decreased, catch rates have increased, and no trout surpass the 18 inch minimum length (no trout captured in department sampling have exceeded 18 inches and [according to voluntary booklet data] only 5.5% of trout caught since 1996 have been 18 inches or larger.) Fortunately, condition factor (fatness) of brook trout at Ferguson Pond has remained better than average. This proposal would allow the opportunity for limited harvest of brook trout while maintaining the goal of producing size quality brook trout.

REGULATION CHANGE DESCRIPTION

Add fall/winter open water season and clarify period allowing harvest of landlocked salmon and specify catch and release of brook trout at that time. Create bullets for season language.

PURPOSE

This proposal would create year-round open water fishing opportunities in the two thoroughfares connected to Eagle Lake. The goals of this proposal are to increase harvest of the over-abundant landlocked salmon population within Eagle Lake and to create additional opportunity for year-round open water fishing. A recent radio telemetry study of Eagle Lake brook trout indicated that spawning is primarily occurring in the outlet and not in the thoroughfares included in this proposal. Even so, artificial lures only and a catch and release regulation on brook trout is proposed. This proposal would assist in reaching objectives aimed at reducing salmon numbers in Eagle and St. Froid Lakes.
