RENEWAL APPLICANT - Read carefully and complete the entire front of this application, signing where indicated. Submit completed application, and license fee to address on front. Current first aid is not required to renew a guide license.

Effective 7-1-98 a renewal applicant whose guiding authority has been expired for 3 years must apply as a new guide and be reexamined.

NEW APPLICANTS - (Testing process for new applicants normally takes from 6 months to a year.) All new applicants must be currently certified by the American Red Cross in standard first-aid or completion of any standard first-aid course that meets the criteria established by rule of the commissioner. **Please note that we do NOT accept online courses.** Complete entire form, front and back. Each new guide applicant must pay a \$100.00 fee in each classification to be examined to become a guide. In the event the applicant fails the test, one re-examination is allowed before another application fee is assessed. The \$100.00 fee is non-refundable and will not be credited toward the license fee. Please send the completed application, copies of both sides of current First Aid card, a copy of your successful background check letter and the \$100.00 fee to Inland Fisheries and Wildlife, 284 State Street, Augusta, ME 04333. **If, due to a disability, you need any accommodation in the exam process, you need to notify us 10 business days prior to the exam date.**

NON RESIDENT/ALIEN - applicant may take the exam on the morning of the day he/she is scheduled for the appointment before the Board.

FEES - All regular guides licenses are issued for a three year period for a \$81.00 fee.
