# Investing in the right solutions for Maine's long-term growth

Maine was highlighted by the non-partisan Center on Budget and Policy Priorities as a national leader in deploying American Rescue Plan recovery funds towards talent, jobs, and innovation. The report ranked Maine in the top three states for share of funds allocated towards workforce development, higher education, and business assistance.

The White House has also cited three of Maine's initiatives in describing American Rescue Plan workforce best practices and the US Department of Treasury, the federal agency charged with overseeing the American Rescue Plan Act, recognized Maine as the lead example of a state investing in job training with federal recovery funds.

I absolutely love my job and the environment I am in." The Governor's Jobs Plan was approved by the Legislature on July 19, 2021, and went into effect on Oct. 18, 2021. This made Maine one of the first four states in the nation and the first in New England to commit 100% of its State Fiscal Recovery Funds from the American Rescue Plan Act.

## **JOBS PLAN UPDATES**

#### WORKFORCE DEVELOPMENT

The Jobs Plan is helping individuals become employed and improve their careers through job training, credential attainment, education programs, and experiential learning. Workforce investments are focusing on sectors hardest hit by the pandemic and critical to Maine's longterm growth, such as construction, education and child care, health care, heritage industries (agriculture, fishing, forestry), technology, energy, and manufacturing.

To date, the Jobs Plan has enabled Maine's community colleges to enroll 1,000+ students into free and low-cost training programs, with 206 courses planned or underway. State agencies have engaged more than 25 community-based outreach workers to help populations overcome barriers to enter the workforce.

### INFRASTRUCTURE

The Jobs Plan is providing grant funds to help communities address critical infrastructure needs quickly by leveraging other funding without assuming additional debt.

More than \$54 million in debt-free infrastructure funding across 75 communities for 111 drinking water, sewer, septic system, and infrastructure climate adaptation grants has been awarded to date.

#### HOUSING

The Jobs Plan is investing \$50 million to support development of approximately 550 homes and rental units across the state through MaineHousing, which is currently reviewing applications and entering into financing agreements for projects.

## SMALL BUSINESS SUPPORT

The Jobs Plan is deploying economic recovery grants and forgivable loans to help Maine businesses cover added costs and lost revenues from the pandemic.

These supports provided more than \$169 million in recovery support for Maine's small businesses, including: grants to heritage industries such as fishing, farming, and forestry; investing \$80 million into the Unemployment Insurance Trust Fund to mitigate increases to business taxes and offering \$20 million in health insurance premium relief to help 5,700 small businesses provide health insurance to 44,500 employees and family members.

#### **ENERGY EFFICIENCY**

The Jobs Plan is investing \$50 million to expand energy efficiency programs for Maine homeowners and renters, businesses, and public buildings through Efficiency Maine.

To date, Efficiency Maine has accelerated weatherization projects, and opened programs with incentives for hospitality businesses, schools, and municipal buildings to convert to high-efficiency heat pumps for heating and cooling, as well as improve energy efficiency through lighting and refrigeration upgrades.

#### EARLY CHILDHOOD

The Jobs Plan is investing \$25 million to expand pre-kindergarten (\$10m) and provide grants to child care centers (\$15m). To date, \$2 million has been utilized by 10 districts to offer new or expanded Pre-K programs to 300 students with further Pre-K and child care grants to be awarded later this year.

## JOBS PLAN SPOTLIGHT Health Care Workforce

#### HEALTH CARE TRAINING FOR ME

Campaign launched in April 2022 to provide health care career navigation and tuition assistance for health care employees, individuals interested in careers in health care, and employers seeking to upskill their workforce.

#### MCCS TRAINING PROGRAMS

To date, 1,163 slots have been approved for no-cost health care training courses through the Maine Community College System, with a total of 678 enrollees.

#### **TUITION REMISSION**

To date, 160 healthcare workers are enrolled in free or low-cost training to advance in their careers, across sectors including behavioral health, dental, long-term care, and EMS.

#### CARING FOR ME

Campaign launched in April 2022 to recruit workers for direct care and behavioral health career opportunities through combination of digital outreach, website with current jobs and events including job fairs throughout the state.

#### APPRENTICESHIP PROGRAMS

- Expanded the apprenticeship program at MaineHealth which will fund an estimated 45 apprenticeships and over 500 preapprenticeships.
- Partnered with local schools including Foster CTE, Somerset CTE, Gorham School District to expand existing and establish new EMT and CNA preapprenticeship programs for young adults.
- Established new pre-apprenticeship programs at Lewiston and Portland Adult Education, including a partnership with Northern Light to train up to 120 preapprentices in medical office staff and medical assisting.

#### HEALTH CARE RECRUITMENT

Campaign to market health care as a meaningful, rewarding career that provides opportunity for advancement and good pay and benefits, leading to more than 650 applications submitted for healthcare jobs to date.

## JOBS PLAN SPOTLIGHT Heritage Industries

The Maine Jobs & Recovery Plan includes three initiatives to support the economic recovery of Maine's heritage industries – forestry, fishing and farming – from impacts due to the COVID-19 pandemic. In the last year, the Governor's Jobs Plan has awarded approximately \$41 million in economic recovery funds to 391 businesses in these heritage sectors across all 16 counties in Maine.
