Approval of January 8, 2013 Commission Meeting Minutes	Copy of minutes received by all Commissioners.	Commissioner Glazier moved for the approval of the minutes. Commissioner Roy seconded. All present voted in favor. Approved.
Operations Reports Review	<p>Director Pelletier presented the <u>February 2013 Operations Reports</u> to the Commissioners and highlighted the following information: the average voucher cost rose slightly, with felony cases and appeals having the highest average; collections were slightly higher as well, but this increase was predicted due to state tax returns being garnished through the tax offset program; the balance at the end of February in the All Other account was \$839,000, which was better than the first two quarters and will allow us to pay on schedule for Q3 with only a day or day and a half behind schedule; this limited shortfall in Q3 will advance the date for when we will need emergency funds from the Governor's Office, previously anticipated to be around May 1; the Q4 allotment is quite low so the Commission will face a shortfall; the conference account will carry over to Q4 from the Q3 allotment and the Commission will not need permission to carry it over from year to year.</p> <p>Chair Mitchell requested that Director Pelletier keep the Commissioners apprised of what is happening with the Q4 shortfall so it can keep the attorneys informed.</p>	
Budget Discussion	The discussion then turned to the status of the budget process. Director Pelletier informed the Commissioners that the Commission is looking for \$4.6 million in new funding from Appropriations in order to implement the rate increase to \$70/hr in FY14, and \$4.8 million in additional funding in FY15 for a rate increase to \$75/hr. Director Pelletier then provided an overview of the Conference and Personal Services accounts. He noted that this will be the first time the Conference account will be in the biennial budget. While

	<p>there is a spending limit on this account, it is budget neutral since attorneys pay for the cost of the trainings. For the Personal Services account, there will be changes to the deputy director, accounting associate and administrative staff positions, which will reduce Personal Services by \$1,500. Director Pelletier indicated that once these changes have been made he will fill the vacant administrative staff position.</p> <p>Director Pelletier then reviewed the following pending legislative proposals:</p> <p>LD 396 seeks to fund the Commission at \$70/hr and \$75/hr in FY'14 and FY'15. Director Pelletier discovered that the amounts in the bill are incorrect and will work with the bill's sponsor and the committee analyst to make the necessary changes. A hearing on this bill is set for March 20. The Commissioners voted in favor of this bill and Chair Mitchell indicated that he would submit written testimony for the March 20<sup>th</sup> hearing.</p> <p>LD 686 seeks to increase funding for indigent legal aid provided to Wabanaki Tribal Members. Director Pelletier was unsure if this bill referenced state court or tribal court. Chair Mitchell agreed that the intent is unclear and that tribal court is outside the scope of the Commission. Commissioner Glazier recommended that Director Pelletier call the bill's sponsor to get some additional information. A hearing had not yet been scheduled for this bill.</p> <p>LD 852 seeks to amend 4 MRSA § 1804 and 15 MRSA § 2115-A in order to shift the cost of paying defense counsel fees in State appeals from the Judicial Branch to the Commission, regardless of whether the defendant is indigent. Director Pelletier located a 1983 unpublished, single justice Law Court opinion that found that the Judicial Branch must pay the cost of defense counsel fees in State appeals. Director Pelletier explained that the issue of payment of counsel fees in State appeals has only come up once since the Commission's creation and in that case the defendant was not indigent and the Judicial Branch paid the attorney's bill. Chair Mitchell indicated that the Commissioners oppose this bill. A hearing date has not yet been set for this bill.</p> <p>Section NNN of biennial budget tasks the Office of Policy and Management, an Executive Branch office, with reviewing the various methods of providing indigent legal services and to report back to the Governor and the Joint Standing Committees of the</p>

	<p>Judiciary and Appropriations and Financial Affairs by November 1, 2013, with its findings. Director Pelletier indicated that the Office of Policy and Management (OPM) has already begun its review and that both he and Chair Mitchell have met with people from OPM concerning this review. Chair Mitchell told OPM that the Commission would help out in any way and related that he had already sent OPM a law review article about a public defender system in Maine written back in the 1970's. Commissioner Carey, by way of written comments, expressed some concern about the language in Section NNN since it focuses solely on the "most efficient delivery of service" and makes no mention of the quality of services which our enabling statute mandates. Director Pelletier explained that he will be sure to note in his remarks to Judiciary and Appropriations that quality of representation as well as efficiency should be the focus of the review.</p>	
Screener update	<p>Director Pelletier gave an update on several screener issues. He explained that Michelle Weirich was hired as the new screener in Bangor and that she starts on Monday, March 18. Director Pelletier also updated the Commissioners on an inquiry that was made during the Judiciary Committee work session regarding the possibility of hiring contract or part-time screeners in areas not currently covered. Director Pelletier told the Commissioners that, while he is willing to explore the idea, in his view it would not be economically practical to hire a screener in Washington or Aroostook Counties or attempt to have someone cover both areas. Chair Mitchell confirmed that the caseload for Lawyer of the Day was quite light in Washington County, that only a handful of people fill out the paperwork. He thought that Aroostook County might be a bit busier but not by much. Director Pelletier thought that polling the clerks in the rural counties to get an estimate of the numbers would be useful. Director Pelletier indicated that hiring a new screener is a time intensive process and that the central office staff is quite busy. He thought a better use of our limited resources would be to fine tune the schedules of our current screeners. Commissioner Glazier commented that the Ellsworth courts are fairly busy and that the Bangor screener should fit that into her schedule.</p> <p>Director Pelletier confirmed that the Commission's financial guidelines have been sent to all the judges. Based on Attorney Ruffner's comments about the potential change in the risk of jail determination, Chair Mitchell thought it would be wise to let the courts know that this is a big issue. Director Pelletier indicated that he would address the issue at the next UCD meeting.</p>

Counsel Fees for Appearances at Collateral Matters	<p>Director Pelletier informed the Commissioners of his decision to allow attorneys to include time entries on their vouchers for appearances at PFA and BMV hearings for the purpose of examining witnesses who are also witnesses in criminal and child protective cases. He emphasized that the Commission would not pay for filing pleadings or negotiations or for submitting memorandum, but strictly for examining witnesses. Commission Glazier thought that it should be limited to just OUI cases for the time being and to give more thought about whether PFA should be included. Director Pelletier indicated that he would email the attorneys to let them know about this change.</p>

Attached you will find the March, 2013 Operations Reports for your review and our discussion at the upcoming Commission meeting on April 9, 2013. A summary of the operations reports follows:

- 2,129 new cases were opened in the DefenderData system in March. This was a 35 case increase from February.
- The number of vouchers submitted electronically in March was 2,553, an increase of 236 vouchers over February, totaling \$1,143,148.17, an increase of \$180,000 over February. In March, we paid 2,318 electronic vouchers totaling \$936,024.
- There were no paper vouchers submitted and paid in March.
- The average price per voucher in March was \$403.81, down slightly from February, but still above the average cost per voucher that we have seen this fiscal year to date. For Fiscal Year 2013 the average price per voucher rose \$0.28 to \$401.36.
- Appeals and post conviction review cases were the highest average vouchers in March.

In our All Other Account, the total expenses for the month of March were \$860,059.77. Of that amount, only \$7,769.54 was devoted to the Commission's operating expenses.

In the Personal Services Account, we had \$37,012 in expenses for the month of March.

In the Revenue Account, our monthly transfer from the Judicial Branch for counsel fees for the month of March, which reflects February's collections, totaled \$61,081.83, an improvement over our average monthly collections so far this year. We spent our entire revenue allotment for the third quarter on electronic voucher's in March, but because collections for the quarter exceeded the allotment, we have a cash balance of \$13,104.59 to carry into the fourth quarter. During April, we will use the financial order process to increase our revenue allotment for the fourth quarter to allow us to spend this balance, as well as any collections that exceed the current fourth quarter allotment.

In March, we had no activity in our conference account, leaving our Conference Account total balance to \$10,629.16.
