Attached please find the September 2010 MCILS Operation Reports and FY11, Quarter 1 Expense Report for your review and our discussion at the upcoming Commission meeting on October 12, 2010.

In the month of September:

- The number of rostered attorney dropped from 414 to 412 attorneys. Several new attorneys were added to the rosters, but a number of attorneys were placed in inactive status due to changes in employment, moves and retirement. The number of firms represented rose from 345 to 350.
- 2,917 new cases were opened in the DefenderData system, a 40% decrease from the number of cases opened in July and an 11% decrease from August. We suspect that a large majority of pre-July 1 “transition” cases have now been loaded into the system and anticipate that the number of new cases will stabilize in the second quarter.
- 2,050 vouchers were submitted electronically, a 1% increase from August and a 27% increase from July. The vouchers paid electronically this month totaled \$606,799.94.
- The biggest change in September was the dramatic decrease in the number of paper vouchers processed by the MCILS staff. Only 83 paper vouchers, totaling \$57,958.05, were paid this month, a 92% decrease from July and an 81% decrease from August. All of the backlogged AOC “transition” paper vouchers have been paid. However, we do expect that we will continue to receive and process a minimal amount of paper vouchers from those attorneys who were appointed to cases by the courts prior to July 1 but did not apply to be rostered with MCILS.
- Combined, there were 1,751 electronic and paper vouchers paid totaling \$810,577.11. The average amount per voucher in September was \$379.64.

In addition to the regular monthly reports, I have included a first quarter expense report breaking down the MCILS expenses by Personnel, Operating Expenses and Indigent Legal Services for our review and discussion.
