Approval of July 10, 2012 Commission Meeting Minutes	Copy of minutes received by all Commissioners.	Commissioner Mitchell made a motion to accept the minutes. Commissioner Spirer seconded. All present voted in favor.
Operations Report Review	Director Pelletier presented the <u>July 2012 Operations Reports</u> to the Commissioners.	
Supplemental Budget Request	Director Pelletier explained that the Commission projects its shortfall for FY'13 to total \$1,643,787 and requested a Commission vote to authorize submission of a FY'13 supplemental budget request in that amount.	Commissioner Mitchell made a motion authorize submission of a supplemental budget request for FY'13 in the amount proposed by the Executive Director. Commissioner Spirer seconded. All present voted in favor.
Rate Increase Discussion	Director Pelletier presented staff budget projections based on various models for a rate increase. These included: 1) projected budget needs for a flat hourly rate increase, with examples showing the rate set at \$65/hr., \$75/hr., and \$85/hr.; 2) projected budget needs based on an increase to \$70.00/hr. for specialized panel cases and to \$60.00/hr. for all other cases as suggested by Chair Schneider; and 3) projected budget needs for hourly rates ranging from \$100/hr. to \$60/hr. based on a combination of criminal charge and case type as suggested by Commissioner Glazier.	
	Discussion ensued with consensus forming that the most appropriate date to implement

	any rate increase would be July 1, 2013, the beginning of FY'14.	
	The discussion then turned to the size of any rate increase and whether the hourly rate should remain uniform or should vary depending on the type of case. A variety of opinions were expressed, and no consensus was reached.	
	Among the proposals discussed were flat hourly rate increases that included both \$70/hr. and \$80/hr., neither of which had been modeled by staff. In addition, it was pointed out that the total budget amounts needed for the flat hourly rate increases supported by the various Commissioners would exceed the total budget needs for the models that proposed varying rates. Chair Schneider suggested that the Commission could vote to authorize staff to submit a budget request based on the hourly rate model which, if granted, would allow sufficient funds for either of the varying rate models. This would allow the ultimate decision on the structure of the rates to be left for rule-making because sufficient funds would be available for either option. Consensus formed around this point, but not around the level of flat rates on which to base the budget submission.	
	The Commissioners agreed to meet again later in the month to vote on the level of hourly rate increase on which to base the budget submission. They requested that for the next meeting, staff model the total budget needs for flat hourly rate increases to \$70/hr. and \$80/hr.

Rate Increase Discussion	Director Pelletier presented staff budget projections based on flat hourly rate increases to \$60/hr. and \$70/hr., which had been requested at the August 14 th meeting. Commissioner Spirer reviewed the understanding that had been reached at the August14th meeting; to wit: the final decision on the structure for future rates, whether uniform for all cases or varied based on the type of case, would be deferred until rule-making subject to the total budget needs for whatever structure emerged being less than or equal to the total budget needs based on a flat rate increase to be determined at the instant meeting. There was no objection to this understanding. A discussion then ensued about what level of hourly rate should form the basis of the Commission's FY'14 and FY'15 budget submission, culminating in a motion by Commission Glazier to base the budget submission upon rates calculated at \$70/hr. in FY'14 and \$75/hr. in FY'15	Commissioner Glazier moved that the Commission's biennial budget request be based on a flat hourly rate of \$70/hr. for FY'14 and \$75/hr. for FY'15. Commissioner Roy seconded. All present voted in favor.
Supplemental Budget Request	Director Pelletier explained that the Commission is working on a computer interface with the Judicial Branch, with the goal of completing this project in FY'13. The Commission has received a proposal from Justiceworks for the Commission's share of costs of this interface that totals approximately \$65,000. Director Pelletier requested that the amount of the Justiceworks proposal for this project be included in the Commission's FY'13 supplemental budget request.	Commissioner Glazier moved that the cost of the Justiceworks proposal for the interface project be included in the Commission's supplemental budget request for FY'13. Commissioner Roy seconded. All present voted in favor.

Attached you will find the August 2012 Operations Reports for your review and our discussion at the upcoming Commission meeting on September 11, 2012. A summary of the operations reports follows:

- 2,128 new cases were opened in the DefenderData system in August.
- The number of vouchers submitted electronically in August was 2,320, totaling \$941,279.51. We paid 2412 electronic vouchers totaling \$971,162.55.
- There were 5 paper vouchers submitted in August totaling \$27,401.81.
- The average price per voucher in August, which included vouchers in several murder cases, was \$413.14. For Fiscal Year 2013 the average price per voucher is \$407.26
- Appeals and Post Conviction Review cases were the highest average vouchers in August.

In our All Other Account, the total expenses for the month of August were \$1,091,744.87. Of that amount, only \$7,957.03 was devoted to the Commission's operating expenses.

In the Personal Services Account, we had \$29,487.98 in expenses for the month of August.

In the Revenue Account, our monthly transfer from the Judicial Branch for counsel fees for the month of July, which reflects June's collections, was not received in time to be posted to July's budget. In August, we received revenue collections for both June and July, totaling \$77,964.58. Collections continue to run below estimates.

In August, we had no activity in the Conference Account. Our Conference Account balance now totals \$7,538.93
