## **Developmental Considerations in Juvenile Forensic Evaluations**

In the aftermath of recent Supreme Court cases, adolescent developmental research has gained further prominence. An understanding of the role of adolescent development on cognition, clinical conditions, risk, and treatment amenability is critical to informed juvenile dispositional evaluations for the Courts. This 3-hour workshop will address those intersections as well as the utility/limitations of the research on adolescent development. Gender, culture, and ethnicity issues also will be covered.

At the conclusion of the workshop, participants will:

- 1. Identify recent Supreme Court cases and their implications regarding juvenile forensic evaluations.
- 2. Identify how development affects adolescent cognition, clinical conditions, risk, and treatment amenability.
- 3. Identify how research in adolescent development can be used most appropriately in Court and with respect to social policy.
- 4. Identify how age, gender, culture, and ethnicity intersect with development and describe their importance in forming opinions in juvenile forensic evaluations.

**Debra Baeder, PhD, ABPP** is board certified in forensic psychology by the American Board of Professional Psychology. Dr. Baeder has served the State of Maine for 22 years in many capacities including the Chief Forensic Psychologist for the State Forensic Service. She has served on the Domestic Homicide Review Panel, Police Use of Deadly Force Task Force, and the Justice for Children Task Force. During and after her transition to Director of Clinical Services, she helped to establish and staff 5 regional Mental Health Court dockets and a first of its kind Close Supervision Community Program to divert pre-trial defendants from more restrictive settings. She helped establish the OBH Justice and Health Team to enhance intensive case management in jails and communities statewide and was appointed by Governor Mills to the Juvenile Justice Advisory Group. Dr. Baeder has provided workshops on juvenile forensic topics in Maine and nationally.
