This legislation, and the board, does not intend to combine these into one profession. The purpose of this legislation is to protect the people of Maine by efficiently setting licensing standards for the three separate professions with one licensing board.

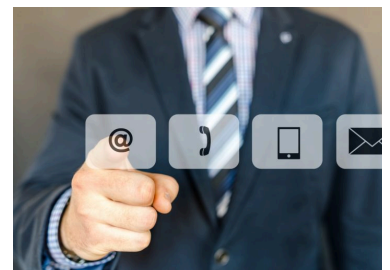
