**I. Call to Order**

Ms. Weinstein called the meeting to order at 8:14 a.m.

**II. Adjudicatory Hearing**

**A. Ian G. Reight, M.D. (CR21-71)**

Hearing Officer Rebekah J. Smith, Esq. convened the hearing at 8:16 a.m.

Dr. Reight was present and represented by Kathleen Healy, Esq. and Seth Orkand, Esq.

AAG Lisa Wilson represented Board Staff.

Hearing Officer Smith confirmed that Board members received and reviewed the Licensee's Motion for Directed Verdict and Board Staff Objection with all members responding in the affirmative. The Hearing Officer provided instructions to the Board regarding deliberation.

Following deliberation, the Board made the following motions:

**Count VII.** Whether Dr. Reight engaged in unprofessional conduct in violation of 32 M.R.S. § 3282-A(2)(F) by violating a standard of professional behavior established in the practice of medicine by failing to evaluate a patient in-person when he was on call on or about May 9, 2020, and/or by failing to document when he saw or evaluated the patient or of the patient's transfer of care.

Dr. Waddell moved to find no violation based on the evidence presented. Dr. Ng seconded the motion, which passed unanimously.

**Count VIII.** Whether Dr. Reight engaged in unprofessional conduct in violation of 32 M.R.S. § 3282-A(2)(F) by violating a standard of professional behavior established in the practice of medicine by failing to evaluate a patient on or about February 6, 2020 as represented to emergency department staff and/or by failing to document an evaluation if provided or transfer of care to another surgeon.

Dr. Waddell moved to find no violation based on the evidence presented. Dr. Ng seconded the motion, which passed unanimously.

**Count IX.** Whether Dr. Reight engaged in unprofessional conduct in violation of 32 M.R.S. § 3282-A(2)(F) by violating a standard of professional behavior established in the practice of medicine by not signing the operative note relating to an October 8, 2020 operation until November 18, 2020, after the patient was readmitted to the hospital on October 27, 2020 following a significant complication of the initial surgery resulting in a 49-day hospitalization and/or by not seeing the patient upon readmission the patient and leaving her care to other surgeons.

Dr. Waddell moved to find no violation based on the evidence presented. Dr. Fay-LeBlanc seconded the motion, which passed unanimously.

**Count X.** Whether Dr. Reight engaged in unprofessional conduct in violation of 32 M.R.S. § 3282-A(2)(F) by violating a standard of professional behavior established in the practice of medicine by failing to conduct an initial consultation regarding a patient on or about December 17, 2020, and/or failing to document his consult in the patient medical record.

Dr. Ng moved to find no violation based on the evidence presented. Dr. Nesin seconded the motion, which passed unanimously.

**Count XI.** Whether Dr. Reight engaged in unprofessional conduct in violation of 32 M.R.S. § 3282-A(2)(F) by violating a standard of professional behavior established in the practice of medicine by placing his interests above the interests of a patient or patients in violation of the AMA Code of Medical Ethics Principles and AMA Code of Medical Ethics opinion 1.1.1.

Dr. Nesin moved to find no violation based on the evidence presented. Dr. Ng seconded the motion.

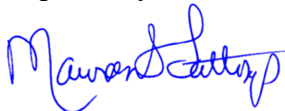
Following further discussion regarding Count XI, Hearing Officer Smith requested that the Board withhold a decision on Count XI.
