**MOTION:** The Board initiated the complaint following its review of information regarding a telephonic medical consultation (“consultation”) the physician provided to an emergency department physician who was evaluating a patient for a puncture wound to the hand resulting from a high-pressure washer line exploding in his hand and which did not clearly indicate that concerns for compartment syndrome had been addressed. The physician responded to the complaint and explained his medical decision-making during the consultation. The Board investigated the matter further by requesting an outside expert review of the medical records and consultation recording.

The guidance is as follows: consultations provided to emergency department physicians should include clear communication about all potential concerns, including the possibility of compartment syndrome if indicated. If compartment syndrome is a concern, it is important that the patient receive explicit instructions that the plan includes prompt patient follow-up with a specialist to occur withing hours – not days – in order to determine whether admission or observation was needed.

**MOTION:** The adult son of a patient alleges that the patient's primary care physician (PCP) failed to follow-up with the patient regarding a procedure that was done by a specialist. Review of the records indicates that the PCP was aware of the procedure, but the specialist was responsible for communicating the results.

**MOTION:** The divorced father of a pediatric patient alleges the physician is biased in treating his son and is discriminating due to his race. The mother of the patient

lives locally and is the custodial parent while the father lives out of state. The complainant also feels his attempts to seek alternative treatment and second opinions have been ignored. The physician and his staff have utilized the MyChart system and have attempted to contact the complainant for facetime appointments which he has not always been available to participate in. The complainant is requesting ample notice to participate in meetings which is not always possible. Review of the record reveals appropriate care. In a situation such as this, with parents not agreeing on coordinating and scheduling appointments plus medical decision making, this complaint would be better suited in a parental rights and responsibilities agreement per their divorce decree.

**MOTION:** The complainant alleges that the licensee was abrupt, rude, sarcastic and dismissive during a one-time consultation for treatment of chronic pain. The licensee saw the patient in conjunction with a nurse practitioner and denies any inappropriate or unprofessional communication. The licensee states that the interaction was

challenging throughout, that the complainant was resistant to the suggested treatment plan, and that an effort to shift the focus of the discussion was unsuccessful. Review of record reveals a thorough examination and a reasonable treatment plan, with concurrent documentation of the complainant's dismissal of the suggested treatment.

**MOTION:** The complaint was initiated by a patient's relative who alleged that the physician assistant provided inappropriate care to the patient who presented with flu like symptoms and who expressed concern that he may have a recurrence of Lyme disease, and that she ordered a test for Lyme disease upon the patient's insistence but did not timely communicate the results of the laboratory test. The physician assistant responded to the complaint, explained the patient visit and her medical decision-making, and provided a copy of the patient's records for review. Following initial review of the complaint materials, the Board investigated further and asked the physician assistant additional questions regarding the process for reporting laboratory results. She responded to the questions and indicated that written laboratory results were not provided to the patient.

The guidance is as follows: As a physician assistant it is your responsibility to ensure that a patient's medical record includes documentation of medical decision-making and that you timely communicate to patients the results of laboratory tests. In addition, you are responsible for ensuring you comply with Maine law, including 22 M.R.S. § 1646, which requires that "[e]very health care provider that orders a laboratory test for the presence of Lyme disease shall provide the patient with a copy of the results of the test."

**MOTION:** An emergency room (ER) physician placed staples to repair a scalp laceration of a teenager. The complainant, the patient's parent, felt that staple placement and technique did not meet the standard of care and as a result, attempts at their removal ten days later resulted in undue trauma and pain as many care providers

attempted unsuccessful extraction. Ultimately, the two staples were removed successfully by the patient's primary care provider.

Review of all records surrounding this case do not support the claim that the standard of care was not met by the ER physician who initially placed the staples. The initial wound assessment, cleansing, repair, at home instructions and follow-up guidelines were appropriate and commonplace. The unfortunate events that occurred during the second visit ten days later did not involve the named physician and could not have been foreseen by that doctor.

**MOTION:** The patient complains she was unable to get her medications in a timely manner. Review of the records reveals that the office was trying to refill the medications, but a combination of poor communication, insurance coverage issues, and temporary staffing lead to a delay in refills. Medication reconciliation and refills done at each office visit is standard of care and may have prevented some of the confusion.

**MOTION:** The complainant states the licensee refused to prescribe a certain medication because “it did not work.” This was the first visit the patient/complainant had with the licensee and lasted, according to the information provided, only two to three minutes before the complainant left the exam room. The licensee in attempting to assess the complainant’s condition prior to prescribing the medication suggested a diagnostic test to the complainant. This same test had been suggested before by different practitioners and routinely rejected by the complainant. Since the complainant felt she wasn’t getting what she had come for (a medication refill) she abruptly left the exam room before further assessment and conversation could take place. The record suggests care and interaction with the complainant was appropriate.

**MOTION:** A patient who presented to an urgent care with upper respiratory infectious (URI) symptoms alleges that the licensee was dismissive of his symptoms,

misdiagnosed him and failed to treat him appropriately with antibiotics. The medical records document that the patient had two days of multiple URI symptoms and his presentation was consistent with a viral process. The patient felt that he had a bacterial infection based on his history of improvement with antibiotics for similar symptoms. The licensee performed an appropriate assessment of the patient, provided a diagnosis of viral sinusitis, and recommended alternative supportive treatments. The patient felt that the licensee was dismissive and not listening to him because she would not prescribe antibiotics, and the patient did not agree with the licensee's recommendations. The care of the licensee was felt to be appropriate and within the standard of care and evidence-based medicine.

The matter was reviewed out of order at 9:00 a.m. as the case reporter anticipated needing to leave the meeting for a period of time.

**MOTION:** The Board initiated this complaint based on information that the physician assistant did not report termination of her employment. The termination was related to poor operating room skills, poor communication with patients, lack of follow up with labs and issues with rounding on patients. The physician assistant responded that she left on maternity leave and when she returned, she was put on a different service. This service was in the process of expanding its providers and her role was less defined compared to the prior service. She believes most of the issues stemmed from this and was not aware that she was under investigation when she left. She has not contested the citation and administrative fine. She is currently employed in primary care and her supervisor has not seen any issues.

At 9:50 a.m. Ms. Lunner requested to revisit this matter to review the language for the motion. No additional action was taken.

The complainant further argued that the physician assistant was diagnosing outside the scope of their practice and attempting to practice in areas without the proper oversight of a physician. The complainant further stated that the physician assistant was misrepresenting themselves as a “doctor.”

Review of the complaint, licensee response and all medical records provided show medical care was challenged by a terminally ill hospice patient in a remote area of Maine where common conveniences of lab, radiology, specialists, etc. was very limited. The care provided by the physician assistant in question does appear to have met the standard of care, shows no prescribing of controlled substances to the patient in question, does not demonstrate that the physician assistant attempted to diagnose or practice outside their scope of practice, and there is no indication that they misrepresented themselves as a physician.

Dear Mr. Smith,

In accordance with the “Board Member Remote Participation Policy” adopted by the Board on August 10, 2021, I am directing that the December 13, 2022 meeting of the Board be conducted virtually through exclusively remote participation pursuant to Section 2(A) of that policy. In support of this directive, I have determined that, based on the following circumstances, there exists an emergency or urgent issue which, pursuant to the policy, requires the Board to meet by entirely remote methods on December 13, 2022:

1. The Secretary of the U.S. Department of Health and Human Services first proclaimed on January 31, 2020, and most recently renewed on October 13, 2022, the nationwide public health emergency (PHE) due to the continued consequences of the Coronavirus Disease 2019 (COVID-19) pandemic. (<https://aspr.hhs.gov/legal/PHE/Pages/default.aspx>)
2. The Commissioner of the Maine Department of Health and Human Services declared on July 1, 2021 a health emergency due to the continued consequences of the COVID-19 pandemic, which shall remain in effect through the duration of the PHE declared by the Secretary of the U.S. Department of Health and Human Services. (<https://www.maine.gov/dhhs/sites/maine.gov.dhhs/files/inline-files/Public%20Health%20Emergency%20Declaration%206-30-21.pdf>)
3. The acting Secretary of the U.S. Department of Health and Human Services wrote a letter to all Governors on January 22, 2021 stating, “To assure you of our commitment to the ongoing response, we have determined that the PHE will likely remain in place for the entirety of 2021, and when a decision is made to terminate the declaration or let it expire, HHS will provide states with 60 days' notice prior to its termination.” (<https://ccf.georgetown.edu/wp-content/uploads/2021/01/Public-Health-Emergency-Message-to-Governors.pdf>)
4. Efforts to combat the pandemic continue in Maine where, as of December 6, 2022, 302,399 residents have been infected (216,933 confirmed and 85,466 probable), 6,363 residents have been hospitalized with the virus, and 2,740 people have died from the virus since January 2020. (<https://www.maine.gov/dhhs/mecdc/infectious-disease/epi/airborne/coronavirus/data.shtml>)
5. As of December 6, 2022, the number of new COVID-19 infections in the State of Maine as confirmed by testing brings the seven-day average of new cases in the State to 150; the number of new cases (confirmed and probable) statewide is 1,054; the number of current hospitalizations is 118 (with 19 in critical care); the number of validated vaccine breakthrough cases is 121,999; the total number of deaths is 2,740. (<https://www.maine.gov/dhhs/mecdc/infectious-disease/epi/airborne/coronavirus/data.shtml>)
6. Viruses like SARS-CoV-2 continuously evolve. The Omicron variant of SARS-CoV-2 (including B.1.1.529, BA.1, BA.1.1, BA.2, BA.3, BA.4 and BA.5 lineages) is currently

classified as a Variant of Concern. As of December 6, 2022, the Omicron variant represents 100 percent of all sequenced samples collected in Maine.

7. As of December 6, 2022, 12 of Maine's counties are in the “low”, 4 counties are in the “medium,” and 0 county is in the “high” transmission category as defined by the U.S. Centers for Disease Control and Prevention.  
([https://covid.cdc.gov/covid-data-tracker/#county-view?list\\_select\\_state=Maine&data-type=CommunityLevels](https://covid.cdc.gov/covid-data-tracker/#county-view?list_select_state=Maine&data-type=CommunityLevels))
8. Eight of the Boards’ members (6 physicians and 2 physician assistants) are actively practicing medicine or rendering medical services and are potentially exposed to the COVID-19 virus while seeing and treating patients at medical facilities, including hospitals, despite taking precautionary measures.
9. An in-person meeting of the Board is foreseeably likely to result in an increased risk of exposure to the COVID-19 virus, which has an incubation period of 2-14 days before the onset of symptoms, for members of the Board, its staff, licensees, and members of the public.
10. Conducting an in-person Board meeting on December 13, 2022 is not practicable due to the widespread rise in COVID-19 infections and the potential exposure to the COVID-19 virus to Board members and to members of the public. Therefore, I have determined that there is an emergency such that the December 13, 2022 Board meeting shall be held entirely remotely as the best way to protect the safety and wellbeing of the members of the Board, its staff, licensees, and members of the public.

There will be no physical location where members of the public may attend this meeting. The Board will continue to provide members of the public a meaningful opportunity to attend the meeting remotely via Zoom as it has successfully done since April of 2020. Please post this determination to the Board website and update the agenda to include the Zoom information as soon as possible.
