**MOTION:** The complaint was first reviewed in November of 2023 and the Board voted to obtain an expert review. The patient complains that the licensee mismanaged her post-delivery care, pulling on the umbilical cord and causing a postpartum hemorrhage. The patient also reports the licensee forgot the patient had no pain medication and examined her without any explanation. The licensee is an OB/GYN physician who was working with residents at the time of this delivery. The licensee did not participate in the patient’s prenatal care, and only met the patient during the delivery. The licensee reports that she was the supervising attending supporting a resident who did the delivery. The licensee reports that the placenta was delivered spontaneously (which is also recorded in the medical records), that the postpartum bleeding occurred two to three hours after delivery, and that the bleeding was appropriately managed as an emergency. The expert reviewer did not find any deviations from the standard of care. No evidence of incompetence. The reviewer also cited literature which supports the licensee’s handling of the case.

**MOTION:** The complainant has a ventriculo-peritoneal (VP) shunt and presented to the emergency department (ED) with complaints of symptoms suggestive of shunt failure, as well as concern re: new abdominal wall masses. Standard imaging for evaluation for shunt failure was normal and the patient was discharged. The next day the patient re-presented with the same concerns, imaging was repeated and was again reassuring. The complainant requested additional testing but the licensee did not feel that it was indicated. The complainant was discharged. The complainant later underwent evaluation at another facility, where they were diagnosed with shunt failure and underwent surgeries for revision of the shunt, ultimately with apparent resolution of symptoms.

The complainant specifically alleges that the licensee:

- Misdiagnosed the complainant with ocular migraine
- Was dismissive of the complainant’s concerns re: shunt failure and the abdominal masses
- Refused to do additional evaluations, even though the complainant’s family member asked specifically for that

The licensee responds that he carried out an appropriate repeat evaluation for shunt failure and explains his thinking in deciding not to do a shunt tap. The licensee only saw the complainant on the second ED visit and did not diagnose the complainant with ocular migraine.

An outside expert review found no concerns with care.

**MOTION:** A biologic mother of an infant with congenital urologic issues complains about the care her son received by a pediatric urologist. Review of the records reveals reasonable evaluation, imaging, medical consultation, examination and treatment plan.

**MOTION:** The patient alleges that the licensee was unprofessional in his communication and was dismissive of her medical issue when she was seen for a perineal infection and concern for a fistula. The medical record supports the treatment at the time she was seen by the licensee in the emergency department. The patient was appropriately referred for further evaluation and treatment that resulted in multiple surgeries to treat a complicated perineal abscess and fistula. The licensee’s response indicates that he was appropriate with the patient, and he denied making unprofessional comments or dismissive treatment. The diagnosis of a fistula is often difficult to ascertain. The exam and workup at the time did not identify the presence of a fistula nor would the diagnosis of a fistula have resulted in a change of acute treatment by the licensee. Care rendered by the licensee is felt to be appropriate.

**MOTION:** The complainant states that:

- The licensee waited twelve hours after an appointment to call the police to have the complainant submit to an involuntary crisis evaluation
- He had a 10:00 AM appointment to discuss potential treatment
- After a short discussion, the licensee stated “this doesn’t seem like something medication will help with” then ended the appointment
- He left the appointment thinking all was well
- At 9:25 PM that same night, police were knocking on his door for an involuntary crisis evaluation
- The licensee took at least two quotes out of context
- The licensee’s report was an exaggeration, but if he had been in crisis, her timeliness was inappropriate
- He explains that he has lost faith in his ability to seek medical attention

The licensee is a physician specializing in Addiction Medicine and Psychiatry. She indicated that the complainant was seen and she noted the complainant to have violent ideations toward individuals that he felt had harmed him even though he did not express any direct threat at the time of the evaluation. However, the complainant did make inference to thoughts of using a gun in a past event. The licensee did not feel the complainant was at imminent risk at that time and she informed the complainant that she needed to speak with his referring providers. The licensee was not able to speak with the complainant’s primary care provider until lunch as well as consult with a colleague that there was concern to evoke the “yellow flag law” due to concern for patient’s risk behavior toward self and others. The licensee consulted legal counsel who was also in agreement with evoking the weapon restriction yellow flag law. The police

were then contacted to execute the order. This notification process appeared to have taken some time. The licensee recognized in her response how distressful the experience was for the complainant, but that she also had an obligation to act and she did so in a rapid but thoughtful manner.

The review of the records and accompanying documentation shows that the licensee has evaluated and assessed the complainant’s psychiatric issues comprehensively and there was concern for the complainant’s risk behaviors. The licensee acted appropriately to request a weapon restriction/yellow flag order from law enforcement which unfortunately added to the time gap between initial evaluation to time of law enforcement contact. The licensee acted within the standard of care in such risk situations.

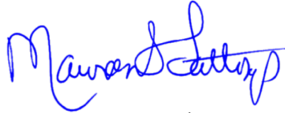

## NOTICE REGARDING POTENTIAL FOR A FULLY REMOTE BOARD MEETING ON DECEMBER 10, 2024

If the Governor does not close or delay the opening of State government, individual members of the Board are permitted by Section 2(E) of the Board Member Remote Participation Policy to make their own determination regarding whether the weather affects their ability to safely attend the Board meeting, and the Board meeting will be held in a hybrid format both in-person and remotely. In this case, members of the public may attend this meeting in-person at the Board’s Offices at 161 Capitol St, Augusta, Maine. The Board will also continue to provide members of the public a meaningful opportunity to attend the meeting remotely via Zoom.

In addition, in accordance with the “Board Member Remote Participation Policy” adopted by the Board on November 14, 2023, I have approved several Board members to participate remotely for the initial portion of the meeting to conduct regular business **(8:00 a.m. – 9:50 a.m.)** at the December 10, 2024, meeting of the Board pursuant to Section 2(F) of that policy.

If the meeting is not held fully remotely, members of the public may attend this meeting in-person at the Board’s Offices at 161 Capitol St, Augusta, Maine.
