MOTION: The patient alleges that the licensee conducted himself in an unprofessional manner allegedly taking pleasure in the patient's involuntary commitment for delusional ideation, falsely accusing the patient of misuse of prescribed Adderall, inappropriately prescribing Haloperidol and neglecting the patient's chronic suicidality.

Review of the clinical and other material suggests that the patient was felt to have delusional thoughts by several independent clinicians, but that involuntary hold was based upon the concern of associated suicidal risk. Adderall was discontinued not because of any documented misuse but of a general concern that concurrent use of Adderall would cause or contribute to delusional thoughts. The patient was prescribed Haldol with their informed consent after it was determined that a previously prescribed antipsychotic by their outpatient psychiatrist was not effective. Haldol was not tolerated well by the patient and was discontinued after a brief trial in conventional dosage.

The purpose of the hospitalization was to assess acute suicidality which was resolved at the time of discharge. The patient was referred to their usual outpatient psychiatrist for management of chronic mood disorder and for further evaluation of ADHD and sleep apnea and the need for psychostimulants or other treatments for these conditions if confirmed to be present.

Review suggests that care of the patient was appropriate and met professional standards of care.

MOTION: The complainant is a patient who alleges that the licensee failed to provide appropriate care and pain management and falsely accused him of drug diversion.

The patient had a history of chronic pain on high doses of opioid medication and was admitted to the hospital for a small bowel obstruction. The medical record does not support that the patient experienced opioid withdrawal or inappropriate treatment. There was concern for potential diversion based on the patient appearing overmedicated with much lower doses of opioids than what he routinely takes. The licensee had a professional and ethical responsibility to address her concerns of potential misuse. The licensee appropriately communicated these concerns with the patient's primary care provider.

The medical care rendered by the licensee was felt to be appropriate and within the standard of care.

The licensee explained the rationale for the use of Gabapentin and the consideration for the potential adverse effects and how the patient was being monitored by the ACT team.

The team felt that the patient's psychosis was more affected by the patient's lack of willingness to accept antipsychotic medication or any other psychiatric medication other than Gabapentin.

Care was deemed appropriate and professional with proper attention to the risks and benefits of medication prescribed to the patient.

MOTION: The complaint was initiated by the Board following notification of the suspension of the physician's clinical privileges based upon an incident during a surgical procedure on an elderly patient with significant cognitive and behavioral issues. The physician responded to the complaint and described his care and treatment and explained his actions during the incident. The Board conducted further investigation, including that the physician complete a course in communications. He completed the course, which included feedback regarding his participation and insight.

The guidance is as follows: communication among surgical team members is crucial and can impact the course of the procedure and the outcome. Good communication increases your approachability and builds trust among team members. You should consider conducting pre-procedure huddles with team members and post-procedure debriefs with team members as a way to increase communication in your office and the operatory. You should also consider additional reading regarding communication such as "Crucial Conversations" (<https://training.vitalsmarts.com/courses/dialogue>); "The 8 Pillars of Trust" (<https://davidhorsager.com/the-8-pillars-of-trust-the-leading-indicator/>); and "The Five Dysfunctions of a Team" (Lencioni).



Dear Mr. Smith,

In accordance with the “Board Member Remote Participation Policy” adopted by the Board on August 10, 2021, I am directing that the July 12, 2022 meeting of the Board be conducted virtually through exclusively remote participation pursuant to Section 2(A) of that policy. In support of this directive, I have determined that, based on the following circumstances, there exists an emergency or urgent issue which, pursuant to the policy, requires the Board to meet by entirely remote methods on July 12, 2022:

1. The Secretary of the U.S. Department of Health and Human Services first proclaimed on January 31, 2020, and most recently renewed on April 16, 2022, the nationwide public health emergency (PHE) due to the continued consequences of the Coronavirus Disease 2019 (COVID-19) pandemic. (<https://aspr.hhs.gov/legal/PHE/Pages/COVID19-12Apr2022.aspx>)
2. The Commissioner of the Maine Department of Health and Human Services declared on July 1, 2021 a health emergency due to the continued consequences of the COVID-19 pandemic, which shall remain in effect through the duration of the PHE declared by the Secretary of the U.S. Department of Health and Human Services. (<https://www.maine.gov/dhhs/sites/maine.gov.dhhs/files/inline-files/Public%20Health%20Emergency%20Declaration%206-30-21.pdf>)
3. The acting Secretary of the U.S. Department of Health and Human Services wrote a letter to all Governors on January 22, 2021 stating, “To assure you of our commitment to the ongoing response, we have determined that the PHE will likely remain in place for the entirety of 2021, and when a decision is made to terminate the declaration or let it expire, HHS will provide states with 60 days' notice prior to its termination.” (<https://ccf.georgetown.edu/wp-content/uploads/2021/01/Public-Health-Emergency-Message-to-Governors.pdf>)
4. Efforts to combat the pandemic continue in Maine where, as of June 28, 2022, 269,308 residents have been infected (194,140 confirmed and 75,168 probable), 5,135 residents have been hospitalized with the virus, and 2,413 people have died from the virus since January 2020. (<https://www.maine.gov/dhhs/mecdc/infectious-disease/epi/airborne/coronavirus/data.shtml>)
5. As of June 28, 2022, the number of new COVID-19 infections in the State of Maine as confirmed by testing brings the seven-day average of new cases in the State to 236; the number of new cases (confirmed and probable) statewide is 1,652; the number of current hospitalizations is 112 (with 12 in critical care); the number of validated vaccine breakthrough cases is 99,810; the total number of deaths is 2,413. (<https://www.maine.gov/dhhs/mecdc/infectious-disease/epi/airborne/coronavirus/data.shtml>)

6. Viruses like SARS-CoV-2 continuously evolve. The Omicron variant of SARS-CoV-2 (including B.1.1.529, BA.1, BA.1.1, BA.2, BA.3, BA.4 and BA.5 lineages) is currently classified as a Variant of Concern . As of June 28, 2022, the Omicron variant represents 100 percent of all sequenced samples collected in Maine.
7. As of June 28, 2022, 8 of Maine's counties (Cumberland, Kennebec, Knox, Lincoln, Sagadahoc, Somerset, Waldo & York) is in the “low”, 8 counties (Androscoggin, Aroostook, Franklin, Hancock, Oxford, Penobscot, Piscataquis & Washington) are in the “medium” and 0 counties are in the “high” transmission category as defined by the U.S. Centers for Disease Control and Prevention.
8. An in-person meeting of the Board is foreseeably likely to result in an increased risk of exposure to the COVID-19 virus, which has an incubation period of 2-14 days before the onset of symptoms, for members of the Board, its staff, licensees, and members of the public.
9. Conducting an in-person Board meeting on July 12, 2022 is not practicable due to the widespread rise in COVID-19 infections and the potential exposure to the COVID-19 virus to Board members and to members of the public. Therefore, I have determined that there is an emergency such that the July 12, 2022 Board meeting shall be held entirely remotely as the best way to protect the safety and wellbeing of the members of the Board, its staff, licensees, and members of the public.

There will be no physical location where members of the public may attend this meeting. The Board will continue to provide members of the public a meaningful opportunity to attend the meeting remotely via Zoom as it has successfully done since April of 2020. Please post this determination to the Board website and update the agenda to include the Zoom information as soon as possible.
