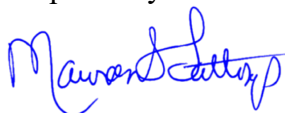
At 10:12 a.m. Mr. Jamison moved to come out of executive session. Dr. Fay-LeBlanc seconded the motion, which passed unanimously.
