**MOTION:** The Board initiated the complaint following receipt of a report from a health care facility that the physician assistant deviated from the standard of care which caused direct harm to a patient. The report indicated that a patient presented to the facility with numerous risk factors for self-harm but was discharged without appropriate consultations. The physician assistant responded to the complaint, explained her medical decision-making, and admitted that she did not sufficiently document her interactions with other health care providers regarding the patient. Additional investigation revealed that protocols at the facility have been changed to avoid a similar situation in the future.

The guidance is as follows: Complete and accurate medical record documentation is essential to good patient care, especially continuity of care. Failure to ensure timely and adequate medical record documentation regarding medical decision making poses a risk to patient safety. In addition, patients who present with multiple risk factors for self-harm should be appropriately assessed through consultation with a mental health specialist or use of validated tools, and not released until risks of self-harm have been addressed and a safety plan established, if needed.

**MOTION:** The complaints were filed by patients who expressed frustration about appointment cancellations and the physician's failure to participate in post-operative appointments with his staff. The physician responded to the complaints and explained the care provided.

The guidance is as follows: Ideally, patients should receive timely post-operative care and follow-up by their operating surgeon or arrangement with coverage by others with expertise to deliver care. If you as a surgeon delegate this care and/or know that you will have to delegate post-operative care, you should provide patients with full disclosure of this arrangement pre-operatively as part of the patients' informed consent to treatment. Additionally, as the physician-owner of the medical practice you should ensure timely responses to record requests by patients and quickly and personally address and resolve patient medical issues and concerns.

**MOTION:** The complaint was filed by the relative of a patient regarding the physician's care and treatment of the patient during an initial appointment to follow-up after the patient's

discharge from the hospital. The physician responded to the complaint, explained his medical decision-making, described his examination of the patient and his interactions with the patient and the patient's relative.

The guidance is as follows: Be mindful of the purpose for an evaluation and its potential effects on patients, especially patients who are in acute pain. Prior to the examination, it is important to impart empathy and develop trust by using eye contact and explaining the type of examination to be performed, answering any questions about the examination and the sensations it might cause, and then obtaining the patient's consent to proceed. In addition, be aware of and sensitive to both verbal and nonverbal cues from patients and caregivers during the conduct of an examination that indicate a need for additional communication.

**MOTION:** The complaint was filed by the mother of a teenage female patient regarding the physician assistant's care and treatment during an office appointment for a well child exam. After describing that the appointment began with confusion regarding the need for a vaccination booster, the patient's mother expressed concern regarding the physician assistant's failure to discuss issues regarding pregnancy, sexual activity, or drug and alcohol use. The physician assistant responded to the complaint, explained her medical decision-making, described her examination of the patient and her interactions with the patient and the patient's parents.

The guidance is as follows: Discussions with adolescent patients regarding pregnancy, reproductive care, and alcohol and drug use are considered standard and are an important part of a well child office visit involving teenage patients. Such discussions should be documented in the patient's medical record.

**12. CR22-46 Kelli M. Nicole Huth, P.A.**

Dr. Fay-Leblanc moved to dismiss the matter with a letter of guidance. Ms. Weinstein seconded the motion.

**MOTION:** The complaint was filed by the father of a young patient regarding the physician assistant's care and treatment during an urgent care visit. The physician assistant responded to the complaint, explained her medical decision-making, described her examination of the patient and her interactions with the patient and parent.

The guidance is as follows: You should avoid utilizing exam templates as they may cause your notes from the office visit to be an inaccurate reflection of the actual examination that you performed. You should not assume that patients or their family members who may be in a health care profession will know certain health care information and should provide them with the same advice and education that you provide to any patient.

**MOTION:** The Board initiated the complaint following receipt of a report that the physician provided a professional medical opinion regarding mental status of a patient who was related to her by marriage. The physician responded to the complaint and explained her medical decision-making.

The guidance is as follows: The co-mingling of professional and personal boundaries may affect objectivity on the physician's part and could ultimately be helpful or harmful to the patient. A physician must be thoughtful, vigilant, and mindful when making professional decisions involving patients with whom they have personal and/or familial relationships. A copy of the *AMA Code of Medical Ethics, Opinion 1.2.1 "Treating Self or Family"* is enclosed with this letter of guidance for your review.

**MOTION:** A patient in a state facility alleges he received inadequate care for an injured right shoulder. He was referred to a specialist after being seen by this physician and then requested a second opinion. Pain treatment was difficult for this patient with a history of opioid use disorder. Additionally, he was provided with two mattresses, extra pillows, and a wedge pillow for sleeping. Personal items belonging to the patient were found in other residents' spaces in the facility opening a conversation regarding diversion. Appropriate care and treatment provided.

#### 15. CR22-75

The patient had an appropriate evaluation and urine sent for culture which was negative for infection. An explanation for the abnormal urine dip test was provided to the mother. The patient’s evaluation did not warrant immediate additional testing for hematuria or antibiotics while being seen by the licensee. The patient received follow-up and reevaluation in the office. Care of the patient was appropriate.

**MOTION:** The complainant is a patient who has been on Xanax and Ambien for many years. The provider discussed the use of these medications and recommended consideration to wean off them. The patient was upset that the provider reportedly told them they were “addicted” to the medications. The patient reports that the provider was upset and acted unprofessionally. The PMP and medical records were reviewed, and the standard of care was followed. The interaction may have been better if the licensee used different language (dependence versus addiction) and a shared decision-making approach with this patient.

**MOTION:** The complainant is dissatisfied with a decision to taper a controlled substance (benzodiazepine) and understood it to be due to the absence of that substance in repeated urine drug screens and that the licensee refused to follow up point of care tests with confirmatory tests. The licensee counters that the decision to taper was based on patient safety considerations (combination of benzodiazepine, opioid at high dose, plus marijuana) and not on the drug screens, and that confirmatory tests were in fact ordered.

Care was appropriate and well documented, and taper was discussed at two visits prior to its initiation. In a supplemental response the licensee also demonstrated insight into what could be done better and has initiated some practice improvement.



Dear Mr. Smith,

In accordance with the “Board Member Remote Participation Policy” adopted by the Board on August 10, 2021, I am directing that the June 14, 2022 meeting of the Board be conducted virtually through exclusively remote participation pursuant to Section 2(A) of that policy. In support of this directive, I have determined that, based on the following circumstances, there exists an emergency or urgent issue which, pursuant to the policy, requires the Board to meet by entirely remote methods on June 14, 2022:

1. The Secretary of the U.S. Department of Health and Human Services first proclaimed on January 31, 2020, and most recently renewed on April 16, 2022, the nationwide public health emergency (PHE) due to the continued consequences of the Coronavirus Disease 2019 (COVID-19) pandemic. (<https://aspr.hhs.gov/legal/PHE/Pages/COVID19-12Apr2022.aspx>)
2. The Commissioner of the Maine Department of Health and Human Services declared on July 1, 2021 a health emergency due to the continued consequences of the COVID-19 pandemic, which shall remain in effect through the duration of the PHE declared by the Secretary of the U.S. Department of Health and Human Services. (<https://www.maine.gov/dhhs/sites/maine.gov.dhhs/files/inline-files/Public%20Health%20Emergency%20Declaration%206-30-21.pdf>)
3. The acting Secretary of the U.S. Department of Health and Human Services wrote a letter to all Governors on January 22, 2021 stating, “To assure you of our commitment to the ongoing response, we have determined that the PHE will likely remain in place for the entirety of 2021, and when a decision is made to terminate the declaration or let it expire, HHS will provide states with 60 days' notice prior to its termination.” (<https://ccf.georgetown.edu/wp-content/uploads/2021/01/Public-Health-Emergency-Message-to-Governors.pdf>)
4. Efforts to combat the pandemic continue in Maine where, as of May 31, 2022, 262,572 residents have been infected (189,301 confirmed and 73,271 probable), 4,951 residents have been hospitalized with the virus, and 2,346 people have died from the virus since January 2020. (<https://www.maine.gov/dhhs/mecdc/infectious-disease/epi/airborne/coronavirus/data.shtml>)
5. As of May 31, 2022, the number of new COVID-19 infections in the State of Maine as confirmed by testing brings the seven-day average of new cases in the State to 439; the number of new cases (confirmed and probable) statewide is 2,634; the number of current hospitalizations is 167 (with 21 in critical care); the number of validated vaccine breakthrough cases is 95,056; the total number of deaths is 2,346. (<https://www.maine.gov/dhhs/mecdc/infectious-disease/epi/airborne/coronavirus/data.shtml> )



6. Viruses like SARS-CoV-2 continuously evolve. The Omicron variant of SARS-CoV-2 (including B.1.1.529, BA.1, BA.1.1, BA.2, BA.3, BA.4 and BA.5 lineages) is currently classified as a Variant of Concern . As of May 31, 2022, the Omicron variant represents 100 percent of all sequenced samples collected in Maine.
7. As of May 31, 2022, 1 of Maine's counties (Sagadahoc) is in the “low”, 9 counties (Cumberland, Kennebec, Knox, Lincoln, Piscataquis, Somerset, Waldo, Washington & York) are in the “medium” and 6 counties (Androscoggin, Aroostook, Franklin, Hancock, Oxford, & Penobscot) are in the “high” transmission category as defined by the U.S. Centers for Disease Control and Prevention.
8. An in-person meeting of the Board is foreseeably likely to result in an increased risk of exposure to the COVID-19 virus, which has an incubation period of 2-14 days before the onset of symptoms, for members of the Board, its staff, licensees, and members of the public.
9. Conducting an in-person Board meeting on June 14, 2022 is not practicable due to the widespread rise in COVID-19 infections and the potential exposure to the COVID-19 virus to Board members and to members of the public. Therefore, I have determined that there is an emergency such that the June 14, 2022 Board meeting shall be held entirely remotely as the best way to protect the safety and wellbeing of the members of the Board, its staff, licensees, and members of the public.

There will be no physical location where members of the public may attend this meeting. The Board will continue to provide members of the public a meaningful opportunity to attend the meeting remotely via Zoom as it has successfully done since April of 2020. Please post this determination to the Board website and update the agenda to include the Zoom information as soon as possible.
