MOTION: The Board issued a complaint following receipt of a report made by a health care entity that the physician resigned following an administrative suspension regarding issues associated with professionalism, clinical skills, and clinical judgment. The physician responded to the complaint and explained the circumstances surrounding her resignation. The Board further investigated and obtained an outside expert review of the care provided to patients.

The guidance is as follows: when there is a discrepancy in the sponge count at the end of an operative procedure, it is the standard of care for the surgeon to manually check the abdominal cavity and document this in the operative summary as well as obtain an intraoperative x-ray. Keep a high index of suspicion about retained foreign bodies on imaging and undertake immediate remedial operative action.

Continue to learn and gain experience as a surgeon by carefully planning preoperatively, discussing potential surgical cases with other experts, seeking consultation on medically complex patients, and obtaining assistance surgically when deemed necessary to take the best care of your patients.

For any physician dealing with patients, especially medically complex patients, it is important to have strong professional relationships and good communication with all colleagues and staff.

MOTION: The patient complains that the provider refused to see her due to a positive COVID test and refused to prescribe antibiotics. The patient was upset about not being able to get a mask waiver and a COVID vaccine waiver and the patient felt pushed to receive the COVID vaccination.

Records reveal that the provider did address the patient's desire for a mask and vaccine waiver and was planning to discuss it in person with the patient. The provider's response indicates that it was the organizational policy that outpatients testing positive for COVID be referred to the emergency department. The policy reveals the licensee did follow the organization's policy regarding COVID positive patients.

MOTION: This complaint revolves around care that was provided in 2015 by the on-call OB/GYN who evaluated the patient, who was 25 weeks 4 days pregnant, in the emergency department for bloody vaginal discharge. The provider examined the patient, monitored her for contractions for two hours, tested for infections and sent the patient home. The provider felt the bloody discharge was light, and per the patient's records there was a possible alternative diagnosis. The patient developed severe bleeding the following day and unfortunately ended up having a placental abruption and the baby died. The Board requested an expert review of the matter. The reviewer opined that the standard of care was followed.

MOTION: A patient complains that the physician was dismissive when she presented to him three days in a row. The patient complains that this resulted in her being admitted to the intensive care unit for days. There was a second issue when the physician did not have a medical assistant that day and she needed to have packing removed. The patient also states that the physician was rude when he told her they no longer had a therapeutic relationship, due to the fact that she was looking for an attorney to sue him for his short comings. The physician responded that he had taken care of the patient since 2010 and she had many exacerbations of her breathing issues. As part of that treatment, she has had pulmonary function tests and was being followed by a pulmonologist. Prior to this incident her oxygen levels were dropping down far enough that she was started on supplemental oxygen. He also investigated other treatment options, but the patient was not interested or did not qualify. Around the time of the hospitalization, the physician states he did not have any interaction with her. The second issue was her being seen without a chaperone and the physician states that he told her he did not have anyone that could come in, but she insisted to be seen. He states at their final meeting he tried to explain to her that he does not feel comfortable being her provider if she is searching for an attorney to sue him. Review of the records revealed that the patient received reasonable care.

MOTION: The complaint was filed by a mother of a pediatric patient alleging that the physician was dismissive of the child's symptoms, neglected to examine the child and provided inappropriate care. The physician responded to the complaint and explained his medical decision making.

The guidance is as follows: when interacting with patient relatives/guardians be mindful of the importance of communication and active listening in situations where there may be disagreements regarding diagnoses and the plan of care. As outlined in the enclosed guidelines for "Communicating with Patients," these aspects of

communication, combined with active listening, will enhance your practice and may preclude similar future complaints.

As a physician it is your responsibility to ensure that a patient's medical record accurately reflects all aspects of patient care and communications, including any physical examination that is performed.

MOTION: The complaint was filed by a patient alleging that her surgery should have been determined to be medically necessary, that the surgery was not performed properly, and that her medical records were inaccurate. The physician responded to the complaint and explained the care provided and his interactions with the patient.

The guidance is as follows: as a physician it is your responsibility to ensure that a patient's medical record includes documentation that accurately reflects the

information available, and services provided. As indicated in the Board's Copy and Paste Guidelines (enclosed), "Clinicians using CPF or pre-populating data should do so carefully and judiciously to create efficient and complete clinical notes that will enhance communication, while avoiding duplication of notes and the propagation of outdated information that does not reflect the current condition of the patient."

12. CR22-159 Emily A. Vayda, M.D.

MOTION: The complaint was filed by a patient alleging misdiagnosis, which exacerbated anxiety, and that the prescribing of benzodiazepines for that anxiety and subsequent attempts to taper those medications worsened the complainant's condition. The physician responded to the complaint and explained the care provided. The guidance is as follows: the decision to start a short course of a benzodiazepine for situational anxiety may be reasonable, but clinicians need to be aware of safety considerations and patient history which could result in difficulty in managing and tapering this class of medication. In addition, clinicians must have knowledge regarding proper tapering of any medication they prescribe.

The complainant suffers with chronic pain and may have a significant psychiatric diagnosis. The complainant has repeatedly expressed dissatisfaction with his treatment plan, both with this and other providers.

The licensee responded that she worked to address both the complainant's medical concerns and to approach his care with clear boundary setting and direct, clear communication, which is the appropriate approach to a patient with this psychiatric diagnosis.

Dear Mr. Smith,

In accordance with the "Board Member Remote Participation Policy" adopted by the Board on January 10, 2023, I am directing that the March 14, 2023, meeting of the Board be conducted virtually through exclusively remote participation pursuant to Section 2(A) of that policy. In support of this directive, I have determined that, based on the following circumstances, there exists an emergency or urgent situation which, pursuant to the policy, requires the Board to meet by entirely remote methods on March 14, 2023:

- The Secretary of the U.S. Department of Health and Human Services first proclaimed on January 31, 2020, and most recently renewed on February 28, 2022, the nationwide public health emergency (PHE) due to the continued consequences of the Coronavirus Disease 2019 (COVID-19) pandemic. (https://aspr.hhs.gov/legal/PHE/Pages/default.aspx)
- 2. The Commissioner of the Maine Department of Health and Human Services declared on July 1, 2021, a health emergency due to the continued consequences of the COVID-19 pandemic, which shall remain in effect through the duration of the PHE declared by the Secretary of the U.S. Department of Health and Human Services.

- 3. The acting Secretary of the U.S. Department of Health and Human Services wrote a letter to all Governors on January 22, 2021 stating, "To assure you of our commitment to the ongoing response, we have determined that the PHE will likely remain in place for the entirety of 2021, and when a decision is made to terminate the declaration or let it expire, HHS will provide states with 60 days' notice prior to its termination." (https://ccf.georgetown.edu/wp-content/uploads/2021/01/Public-Health-Emergency-Message-to-Governors.pdf)
- 4. Efforts to combat the pandemic continue in Maine where, as of February 28, 2023, 316,760 residents have been infected (225,980 confirmed and 90,780 probable), 7,035 residents have been hospitalized with the virus, and 2,921 people have died from the virus since January 2020. (https://www.maine.gov/dhhs/mecdc/infectious-disease/epi/airborne/coronavirus/data.shtml)
- 5. As of February 28, 2023, the number of new COVID-19 infections in the State of Maine as confirmed by testing brings the seven-day average of new cases in the State to 128; the number of new cases (confirmed and probable) statewide is 1,331; the number of current hospitalizations is 168 (with 30 in critical care); the number of validated vaccine breakthrough cases is 190,741; the total number of deaths is 2,921.

- 6. Viruses like SARS-CoV-2 continuously evolve. The Omicron variant of SARS-CoV-2 (including B.1.1.529, BA.1, BA.1.1, BA.2, BA.3, BA.4 and BA.5 lineages) is currently

- classified as a Variant of Concern. As of February 28, 2023, the Omicron variant represents 100 percent of all sequenced samples collected in Maine.
- 7. As of February 28, 2023, 7 of Maine's counties are in the "low", 9 county is in the "medium," and 0 counties are in the "high" transmission category as defined by the U.S. Centers for Disease Control and Prevention.

- 8. Seven of the Boards' members (5 physicians and 2 physician assistants) are actively practicing medicine or rendering medical services and are potentially exposed to the COVID-19 virus while seeing and treating patients at medical facilities, including hospitals, despite taking precautionary measures.
- 9. An in-person meeting of the Board is foreseeably likely to result in an increased risk of exposure to the COVID-19 virus, which has an incubation period of 2-14 days before the onset of symptoms, for members of the Board, its staff, licensees, and members of the public.
- 10. Conducting an in-person Board meeting on March 14, 2023, is not practicable due to the widespread persistence in COVID-19 infections and the continued threat of exposure of the COVID-19 virus to Board members and to members of the public. Therefore, I have determined that there is an emergency such that the March 14, 2023, Board meeting shall be held entirely remotely as the best way to protect the safety and wellbeing of the members of the Board, its staff, licensees, and members of the public.

There will be no physical location where members of the public may attend this meeting. The Board will continue to provide members of the public a meaningful opportunity to attend the meeting remotely via Zoom as it has successfully done since April of 2020. Please post this determination to the Board website and update the agenda to include the Zoom information as soon as possible.
