- The licensee ignored the complainant's concerns about her son's mental health
- The complainant emphasized that her son has depression, anxiety and autism
- The complainant indicated that when she tried to address issues with the licensee, the licensee said "so you would be to discontinue services"
- The complainant indicated that the licensee kept repeating the above phrase when she tried to make her concerns known
- The complaintant alleged that the licensee misdiagnosed her son, ignored or misread lab results and failed to perform proper aftercare or follow-up with the patient and his mother
- The complainant explained the license did not take an appropriate patient history and disregarded the patient's health history

The patient was referred back to the licensee through his case manager as the licensee had seen the patient in 2021-2022. In review of the records, the licensee did a comprehensive history and review and made recommendations to start Abilify to address symptoms of anxiety and mood instability. This seemed to work for a bit with some reported improvements by both the patient and mother. However, the improvement was not sustained. The complainant was noted to be "dismissive" of Abilify due to her own personal past experience. Documentation noted the complainant had become upset on several occasions due to lack of significant improvement with the patient and the licensee not responsive to her concerns. The licensee suggested referral to a specialty clinic and even hospitalization. The patient was eventually evaluated in the emergency department and then admitted. The patient was started on a regimen that the mother wanted and there was some improvement but then he deteriorated again. The documentation demonstrated attempts by both the licensee and her program to connect with the complainant to address her concerns at times without success but in the end not to her satisfaction.

The review of the records shows the licensee did meet the standard of care in the care of a very challenging clinical situation. There was evidence in the documentation that the license identified her rationale for treatment as well as working with the family. It is unfortunate that the regimen initiated by the licensee did not yield sustained improvement with the patient, which led to the complainant's frustration with treatment. No evidence of deviation of care was found.
