The following questions have been received:

Question: ****NOTE this question is directed to ALL LCP's**** Could the department clarify if the paving widths for this year's contracts will consist of zeroing out on the fog line or if the paving will be full width main line with the shoulders if present?

Response: LCP contracts will be full width with shoulders if present. Similar to past years, it may be decided in the field to zero out at the fog line in some areas.

Question: That State of Maine wage determination lists one of the project locations as Smithfield. Should be Springfield.

Response: See new State Wage Rate Determinations above.




