Please make the following changes to the Bid Documents:

REMOVE pages 13-20, "CONTRACT AGREEMENT OFFER & AWARD", two copies, 4 pages each, and **REPLACE** with the attached, revised "CONTRACT AGREEMENT OFFER & AWARD", two copies, 4 pages each, dated July 24, 2019.

CHANGE on page 46, "SPECIAL PROVISION, SECTION 107 (TIME)", in the second paragraph which begins with "The specified Contract completion Date..." to read:

"The specified Contract Completion Date is <u>October 21, 2019</u>." Make this change in pen and ink.

The following questions have been received:

Question: Please help to clarify the scope of work. The project is advertised as "Concrete building slabs". Is the project "slab ready", or is it the intent to include earthwork activities, foundation and slabs?

Response: Includes earthwork activities, footings, underdrain, frost wall and slab. See pages 28-37 in contract book.

Question: Is work indicated in section B/5 removal of existing concrete curb and wood framed wall included?

Response: The wood frame wall will be taken care of by DOT. The Contractor will be responsible for removing the existing concrete curb and matching the height of the new concrete floor to the existing concrete floor.

Question: Is an under-slab vapor barrier required?

Response: Yes, under-slab vapor barriers are required.

Question: Is the rigid insulation under the entire slab?

Response: Under the new slab as shown in the plans.

Question: Are the Bollards to be included? Note Detail H/6 for the bollards is not in the plan set. If the bollards are to be included, please clarify the quantity. Are there 4 bollards at the China location and 2 bollards at the Edgecomb location?

Response: No, bollards are not included.

Consider these changes and information prior to submitting your bid on July 31, 2019.
