As some know I have been racing with the club and cycling for over 5 decades including over 2000 races from local to national and world championships in the sports of Cyclocross, Mt Biking, Road Racing, and Track Racing. Bike touring, bike packing, and commuting on my bike, have also been my passion. I have worked for many years as an energy and transportation advocate for 3 national and local nonprofits and have been a technical consultant on the subject, including the Maine State Rail plan. I have studied, researched; and done many public talks and written many published articles on these issues over the years. That included drafting and successfully (passeing by our legislature and signed into law), several pieces of legislation on these issues. Having ridden my bikes all over the world, including many bike trails and former railways, has given me unique insight. Additionally having been a passenger, many times with my bike on many of the world's rail netwo

rks including most of the high-speed networks in Asia, Europe, and other parts of the world. It is with this background that I would like to express another opinion.

Climate catastrophe is upon us. Each passing day that we wait to make dramatic changes to how we "do" energy and transportation is a calamitous step for our children. Transportation is upwards of 40-50% of our state's carbon emissions and fuel use. Although they have been getting trimmed, like the branches on a tree each year. We still have several important rail lines left in our state, connecting our major cities. Several past governors (like John Baldacci) saw the importance of railway preservation by purchasing hundreds of miles of these railways. You, the taxpayer spent tens of millions on these purchases. For reuse as future railways, one of the smartest ideas of our past governors. I personally worked with Governor Baldacci on some of these purchases.

The former railway from Lewiston/Auburn, which continues to downtown Portland via what was called the St Lawrence and Atlantic line, is one of the most important connections in Maine. While there is a freight line owned by Pan AM railways almost parallel to parts of it (that gets a lot of use), this line is not being used at the moment. The Maine Rail Transit Coalition along with several other organizations for which I have worked; wrote and passed legislation to recreate this line into the passenger service between Maines's 2 largest cities. This project has been studied and is in the late phases of planning to potentially bring passenger rail service with up to 22 round trips per day between Maine's largest urban areas. The project could bring either fully electric or electric battery hybrid, self-powered train cars, carrying 40-60 passengers per car (including bikes) from downtown directly along Portlands waterfront into the current ferry terminal. Yes, thi

s plan has been vetted with many state agencies, potential stations could include stops in Falmouth, Cumberland, Yarmouth, New Gloucester, Danville, Auburn, and Lewiston Downtown, behind the second largest hospital in Maine.

This service can be fast, nonpolluting; and alleviate thousands of passenger miles on our crumbling roadways. For it to be successful, it needs to be separated from the current freight line (which it is), and have several siding tracks, so that trains going in opposite directions can pass each other. This requires the full use of most of the

current right of way (land). This requirement along with setbacks and very steep side grades; makes use of this railway incompatible with trails.

I cannot reiterate the importance of this project. It alone; could be the largest reduction in CO2 emissions in our state. It will of course bring orders of magnitude more economic growth and prosperity to Maine's largest urban area than a trail. It could alleviate some of the labor shortages we currently have, by allowing economic growth and cheap transportation to hurting economic classes and a much wider area. Offshore wind and solar could power this entire railway, with clean, almost silent rail cars; bringing you and your bike to work or out to dinner in another city. The funny part is, we had a clean green inter-urban railway that was hydro-powered, and non-polluting, between these 2 urban areas every 30 or so minutes. It made the trip, faster than today's Maine Turnpike, over 100 years ago!

Railways are highly engineered to carry millions of pounds per square yard of roadbed, these railways are graded at only a few feet per mile and go through some of the most valuable lands in the state. They are irreplaceable for clean transportation. Using these railways for bike trails; would be like purchasing a Grand Piano and using it as a coffee table in your living room. Horrible public policy in the least, and locking us into an unsustainable asphalt future with more and more congestion, and pollution, for our highways, and roadways.

The cool hype in the USA now; is to look toward electric and autonomous vehicles. While that sounds really cool, in practicality it lacks a lot (I own an EV). While EV's should be used to get you to railways, from more rural places, we need to use public rail transit to connect our major cities including the integration of local buses. Self-driving cars sound good for Florida, but in Maine, their use in the snow is not even close to practical. Most of the modern world has embraced passenger rail, even other states are farther along. We need to do the same, we need to think big, think fast and be bold.

A practical example of a disastrous policy decision is the â&eSunriseâ& trail in down-east Maine. We spent millions of dollars to protect and restore a railway, a misguided DOT commissioner got pressured by special interest groups to rip up the most vital backbone of transportation in the region and turn it into the world's most expensive snowmobile and ATV trail. One that is now eroded, sandy, dusty, and destroyed, while the population of those 2 counties suffers from hypertension diabetes, morbid obesity; and economic desertification.

While this is not the proposal in Southern Maine, it has direct correlations to our future. Please do not let this happen, we have this opportunity to revolutionize our transportation infrastructure, do not believe "Maine is too rural for railâ€. It's just not true, we had less than half our current population 100 years ago and had fully successful railways connecting all of our state! We need to make huge changes, and a knee-jerk bike path is not the answer. Smart transportation is. As cyclists, we should be thinking of real solutions. Ripping up our best chance at that possibility is a horrible idea. Ask our DOT to stop considering 150 million Turnpike extensions, and put that money towards this project! We need a green future, please consider this.
