On December 16, 2021, the Merrymeeting Trail Board of Supervisors voted to formally request that the Maine Department of Transportation (MDOT) form a Rail Corridor Use Advisory Council to explore using the relevant unused section of the Lower Road railroad corridor as the Merrymeeting Trail, pursuant to Title 23 MRSA §75. 

Jeremy asked Darryl to secure a letter from Richmond stating that the Select Board passed a similar resolution. Tom will contact the Gardiner town manager to arrange for a letter stating they also passed a similar resolution. Early next year we are hoping for a supporting resolution from the Kennebec River Rail Trail Board of Supervisors. After which the board will forward our request and supporting letters from the towns and KRRT Board of Supervisors to the Maine Department of Transportation.

The board discussed setting a tentative monthly meeting schedule. Jeremy will reach out to all members to see if the last Wednesday of the month will work for everyone.
