# PEDIATRIC DISASTER RESPONSE AND EMERGENCY PREPAREDNESS

### MGT-439

A 2010 report by the National Commission on Children and Disasters identified a training gap for emergency responders, first receivers, and emergency management personnel that reduced their effectiveness in responding to pediatric patients and their unique needs/considerations. This course addresses pediatric emergency planning and medical response considerations through a combination of lectures, and small group exercises.

CERA sandwiches, 3-minute walk from Free Street (Congress in Monument Square)


The Works, Sandwiches, 3–4-minute walk from Free Street (Temple Street which is a block from CERA)

Hi Bombay, Indian, 3-4-minute walk from Free Street (Pleasant, Center, York, Fore intersection)


Yosaku, Japanese cuisine, 3-4-minute walk from Free Street (Danforth Street)

Little Tap House, Bar and Grill, 3–4-minute walk from Free Street (Spring/High)




#### **Parking Information**
