## **PRE-DISASTER MITIGATION GRANT (PDM)**

### **WHAT IS THE PRE-DISASTER MITIGATION GRANT?**

The Pre-Disaster Mitigation (PDM) Grant is a nationally competitive annual grant opportunity through the Federal Emergency Management Agency. The goal is to reduce overall risk to the population and structures from future hazard events, while also reducing reliance on Federal funding in future disasters. This program awards planning and project grants and provides opportunities for raising public awareness about reducing future losses before disaster strikes. PDM grants are funded annually by Congressional appropriations and are awarded on a nationally competitive basis. In Fiscal Year 2019, **\$250,000,000** is available to assist State, Tribal Territorial and local governments in reducing overall risk to the population and structures from future hazard events, while also reducing reliance on federal funding from future disasters.

### **WHO IS ELLIGIBLE?**

States, territories, federally-recognized tribes and local governments are eligible to serve as sub-applicants for the Pre-Disaster Mitigation grant. Applicants must be participating in a FEMA approved County Hazard Mitigation Plan.

### **HOW DO I APPLY?**

Eligible applicants who wish to apply should contact the State Hazard Mitigation Officer, Anne Fuchs, to (1) discuss the project, and (2) request an Access ID. Each applicant will need their own Access ID to formally apply within FEMA's eGrants system.

### **WHAT IS THE E-GRANTS SYSTEM?**

The eGrants system is an electronic portal FEMA utilizes to track mitigation applicants. Sub-applicants who wish to use the Mitigation eGrants system to apply for and manage applications for assistance to the PDM and/or FMA grant programs must register on the FEMA Portal: <https://portal.fema.gov> and then request access to the Mitigation eGrants system using the appropriate Access ID provided by the State Hazard Mitigation Officer. States will review and approve local Sub-applicant registrations for

eGrants system access. Once approved, sub-applicant users will receive an email detailing what privileges have been assigned to them in the eGrants External system by their state.

### **WHAT IS THE EGRANTS APPLICATION PROCESS?**

In the application process, sub-applicant users create planning and project sub-grant applications and submit them to their State Hazard Mitigation Officer. Sub-applicants should consult the State Hazard Mitigation Officer (SHMO) in their state for more information regarding the application process.

The State Hazard Mitigation Officer will review and approve the sub-grant applications submitted from their Sub-applicants. The State Hazard Mitigation Officer will then create a grant application on behalf of MEMA for submittal to FEMA ranking each respective sub-grant application received. ### **WHAT IF I AM UNABLE TO SUBMIT MY APPLICATION ELECTRONICALLY?**

If a Sub-applicant cannot use the Mitigation eGrants system to submit their sub-grant application, then The State Hazard Mitigation Officer must enter the paper application(s) into the eGrants system on the Sub-applicant's behalf. Using a *blank application* ensures that all of the necessary information is provided to the Grant Applicant for input into the eGrants External System. ### **WHEN ARE APPLICATIONS DUE?**

Sub-applicant applications are to be submitted via the eGrants system no later than end of business on Friday December 20<sup>th</sup>. Applications will then be reviewed and ranked by the State Hazard Mitigation Officer before formal submission to FEMA on January 31, 2020.
