

Tilmaanta Waydiinta Codsadaha Guri

2. Sidoo kale waa sharci-darro qof kasta dagaya dhismayaal kiro ama hoyga dadwayne in loo diido in laga kirayo ama in lagu khasbo sharciyo kale oo kiro qof kasta kaasoo ah helaha kaalmada fadaraalka, gobal, ama kaalmada heer deegaan, ooy ka mid tahay kaalmada caafimaad iyo caawinta guri, marka hore sababtoo ah shakhsiyaadka loo aqoonsanyahay helayaasha caawin.
3. Waydiimuhu ma ahan sharci-darro haddii ay la xidhiidhaan arrimo ganacsi ooyna ku salaysnayn qaybaha la ilaaliyay.
4. Guryaha badankood ee dadka da'da ah, sida sharcigu sheegayo, waa laga dhaafay sharciga mabnuuca takoorka firka qoys (laga reebo xayisiinta) waxayna wax ka waydiin karaan firka qoys ee codsadaha. Fadlan la soo xidhiidh Golaha haddii aad qabtid wax su'aalo ah oo ku saabsan aqoonsigaaga ah siiyaha guri dadka da'da.
5. Goluhu wuxuu ku taliyaa in xulashada kiraystayaal, guri bixiyayaasha ay diiradda saaraan si gaar ah shuruudaha sharci ee codsadaha ee guri la siiyay.
6. Waydiimaha guri ee lagu sameeyay tilmaamaha raacidda, ama shuruudaha ah, wakaalad ama wakaalado deegaan, gobal, ama dawladda dhexe ee xidhiidhka la leh maamulidda barnaamijyada guri caawinta kuma ahan sharci-darro Hay'adda Dawada & Caafimaadka (MHRA).
7. Hay'adda Dawada & Caafimaadka (MHRA) ma mabnuucdo waydiinta codsadaha in la siiyo xog ka caawinaysa raacidda qorshe sharci ah.
8. Liiska su'aalaha "sharciga ah" iyo "kuwa sharci-darrada ah" ee ka kooban halkaan kuma dhama. Waxaa loola jeedaa in lagu muujiyo noocyo su'aalo ah oo badanaa soo noqnoqda.
