## Maine Labor Relations Board

On October 24, 2022, Robert Bashinsky filed a petition for Decertification Election with the Maine Labor Relations Board (Board) pursuant to 26 M.R.S.A. § 967(2) and Chapter 11 of the Board Rules. Because the requirements set forth in Chapter 11 of the Board Rules were met, the Board scheduled a Decertification Election by mail ballot to be conducted among employees in the collective bargaining unit described below between November 21, 2022, and December 8, 2022. On November 1, 2022, the Board provided the petitioner, AFSCME Council 93, Local 1458-08, and the Brunswick Topsham Water District with sample ballots and a notice of election for both informational and posting purposes in accordance with Board Rule Chap. 11, § 14(2) and § 46. On November 21, 2022, the Board mailed ballots to all members of the unit included in the list of eligible voters prepared by the employer.
