On August 10, 2023, the Knox County Communications Association (KCCA) filed with the Maine Labor Relations Board (Board) a petition for Decertification/Bargaining Agent Election (MLRB Form 2A). Because the requirements set forth in Chapter 11 of the Board Rules were met, the Board scheduled a Decertification/Bargaining Agent Election by mail ballot to be conducted among employees in the collective bargaining unit described below between September 11, 2023, and September 26, 2023. On August 18, 2023, the Board provided KCCA, the Maine Association of Police (MAP), and Knox County with sample ballots and a notice of election for both informational and posting purposes in accordance with Board Rule Chap. 11, § 14(2) and § 46. On September 11, 2023, the Board mailed ballots to all members of the unit included in the list of eligible voters prepared by the employer.


