On July 23, 2024, the Sanford Public Works Association (Petitioner) filed with the Maine Labor Relations Board (Board) a petition for Decertification/Bargaining Agent Election (MLRB Form 2A). Because the requirements set forth in Chapter 11 of the Board Rules were met, the Board scheduled a Decertification/Bargaining Agent Election by mail ballot to be conducted among employees in the collective bargaining unit described below between August 22, 2024, and September 12, 2024. On August 7, 2024, the Board provided the petitioner, AFSCME Council 93, Local 481, and the City of Sanford with sample ballots and a notice of election for both informational and posting purposes in accordance with Board Rule Chap. 11, § 14(2) and § 46. On August 22, 2024, the Board mailed ballots to all members of the unit included in the list of eligible voters prepared by the employer.
