On May 31, 2024, the National Correctional Employees Union (Petitioner) filed with the Maine Labor Relations Board (Board) a petition for Decertification/Bargaining Agent Election (MLRB Form 2A). Because the requirements set forth in Chapter 11 of the Board Rules were met, the Board scheduled a Decertification/Bargaining Agent Election by mail ballot to be conducted among employees in the collective bargaining unit described below between July 1, 2024, and July 23, 2024. On June 11, 2024, the Board provided the petitioner, the Teamsters Local Union No. 340, and Somerset County with sample ballots and a notice of election for both informational and posting purposes in accordance with Board Rule Chap. 11, § 14(2) and § 46. On July 1, 2024, the Board mailed ballots to all members of the unit included in the list of eligible voters prepared by the employer.
