On October 9, 2024, the Winslow ME Police Association-FOP Lodge #2 (Petitioner) filed with the Maine Labor Relations Board (Board) a petition for Decertification/Bargaining Agent Election (MLRB Form 2A). Because the requirements set forth in Chapter 11 of the Board Rules were met, the Board scheduled a Decertification/Bargaining Agent Election by mail ballot to be conducted among employees in the collective bargaining unit described below between November 8, 2024, and November 25, 2024. On October 18, 2024, the Board provided the petitioner, the Maine Association of Police, and the Town of Winslow Police Department with sample ballots and a notice of election for both informational and posting purposes in accordance with Board Rule Chap. 11, § 14(2) and § 46. On November 8, 2024, the Board mailed ballots to all members of the unit included in the list of eligible voters prepared by the employer.
